

1. Compared to 2020, do you expect the available dollar value of projects you compete for in 2021 to be (answer for all market areas in which your business operates): Responses: 82




2. What changes do you expect in your firm's headcount in 2021? Responses: 82




How would you describe your current situation in filling salaried and hourly craft positions?Responses: 82




4. Do you expect any changes in the availability of hourly craft or salaried personnel over the coming 12 months? Responses: 82




5. Did your firm increase or decrease pay or benefits in 2020? (mark all that apply) Responses: 82







7. Did an owner postpone or cancel any projects that were scheduled to start in 2020 or 2021? (mark all that apply) Responses: 81




8. When do you expect your firm's volume of business will return to its normal level relative to one year earlier? Responses: 81







10. What challenges, if any, do you see regarding the safety and health of your firm's workers (mark all that apply)? Responses: 75




11. What best describes your firm? Responses: 82
