# 2018 AGC Diversity & Inclusion Council Steering Committee Guidelines

## D&I Council Structure

The Diversity & Inclusion (D&I) Council functions as a forum in which members can network, and exchange ideas about construction industry diversity and inclusion practices. The D&I Council is open to all interested AGC members without the need of a formal appointment process. The steering committee membership rotates on a regular four-year basis.

## D&I Council Purpose

- To be an open forum to exchange ideas.
- To be an entry vehicle into AGC to promote diversity and inclusion.
- To foster a strong network.
- To create and promote industry best practices.
- To discuss the most important issues and provide feedback to AGC leadership.
- To help structure AGC for the future.

## **D&I Council Steering Committee**

- The 16-person Steering Committee is made up of up to 15 committed AGC members four of which are appointed by the AGC Divisions and one AGC Chapter staff.
- The Steering Committee responsibilities are as follows:
  - Four-year term;
  - One face-to-face meetings per year (at the AGC Annual Convention (spring) with the possibility of a second face-to-face meeting in the fall.
  - Monthly conference calls; and
  - Participate in at least one D&I Council Subcommittees, which drive the initiatives of the D&I Council; and
- The Steering Committee will have a Chair and Vice Chair, who will serve one-year terms.
- The Vice Chair will be chosen at the discretion of the Chair.

#### New D&I Council Steering Committee Members

- Those interested in joining the Steering Committee must submit:
  - 1. The member application form (pages 3 &4 below);
  - 2. A signed commitment form (page 5 below); and
  - 3. A bio (250 words or less) and photo.
- Completed application and all supporting documents are due Thursday, November 30, 2017.

# **D&I Council Steering Committee Selection**

• The D&I Council Steering Committee will review all nominees during its December 2017 conference call. A final decision on which members will be selected will be made during the December 2017 call. During the selection process, the members will take into consideration

the composition of the current Steering Committee and the number of slots available. They will be looking for nominees who:

- 1. Are willing and able to be an active Steering Committee participant;
- 2. Can make a four-year commitment;
- 3. Will attend the in-person meetings held each year at the AGC Annual Convention;
- 4. Help diversify the Steering Committee; and
- 5. Complete all portions of the application.
- Applicants will be notified whether or not they have been selected for the national Steering Committee the week of Dec., 18, 2016. Their three-year term will begin at the in-person Steering Committee meeting to be held at the AGC of America 99th Annual Convention in New Orleans, LA, February 26-28, 2018.
- Any nominees who are not appointed to the Steering Committee will be given more information about AGC committees, forums and divisions, and are strongly encouraged to join those of interest to them.
