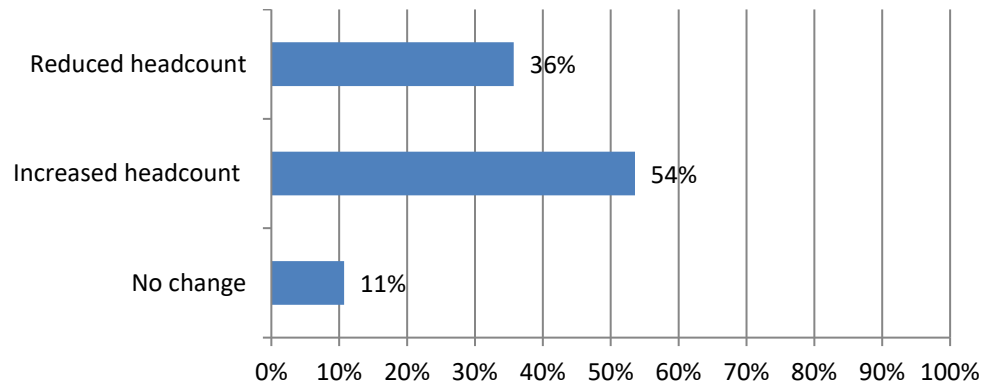

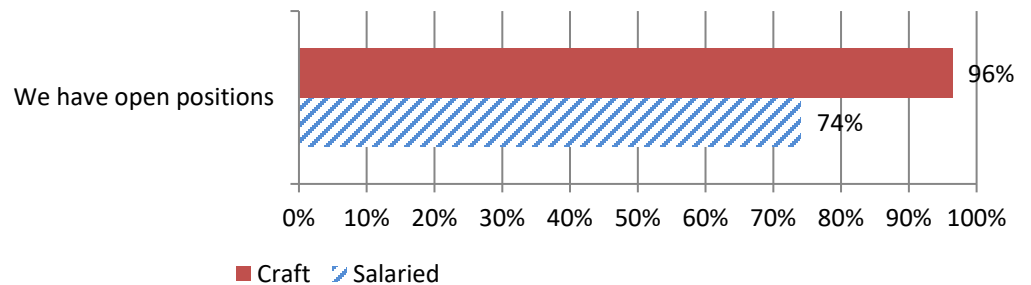

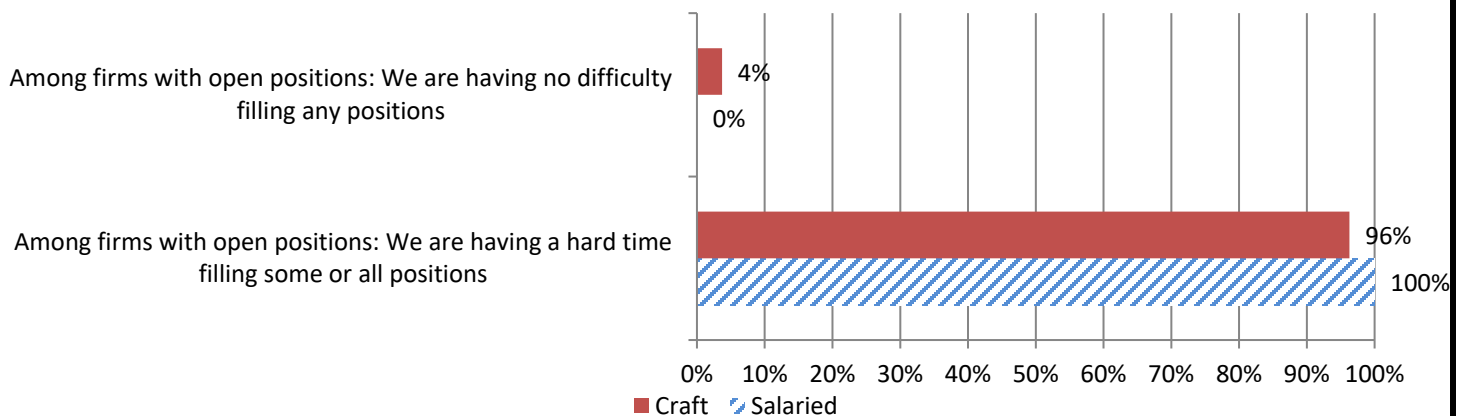
1. By what percentage has your firm's headcount changed in the past 12 months? Responses: 28



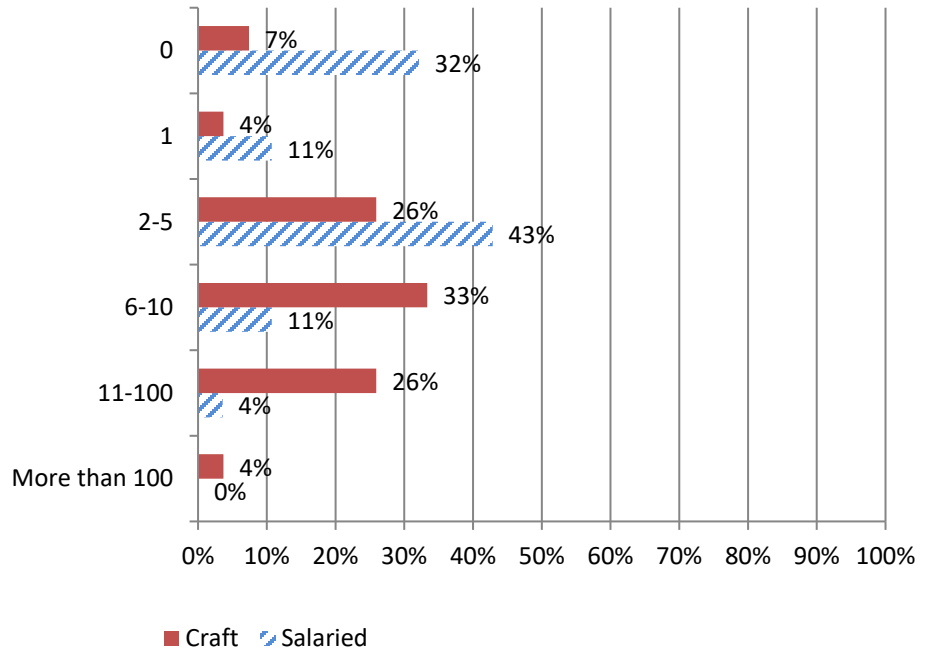
2. How would you describe your current situation in filling hourly craft or salaried positions? Responses: 27 Salaried; 28 Craft



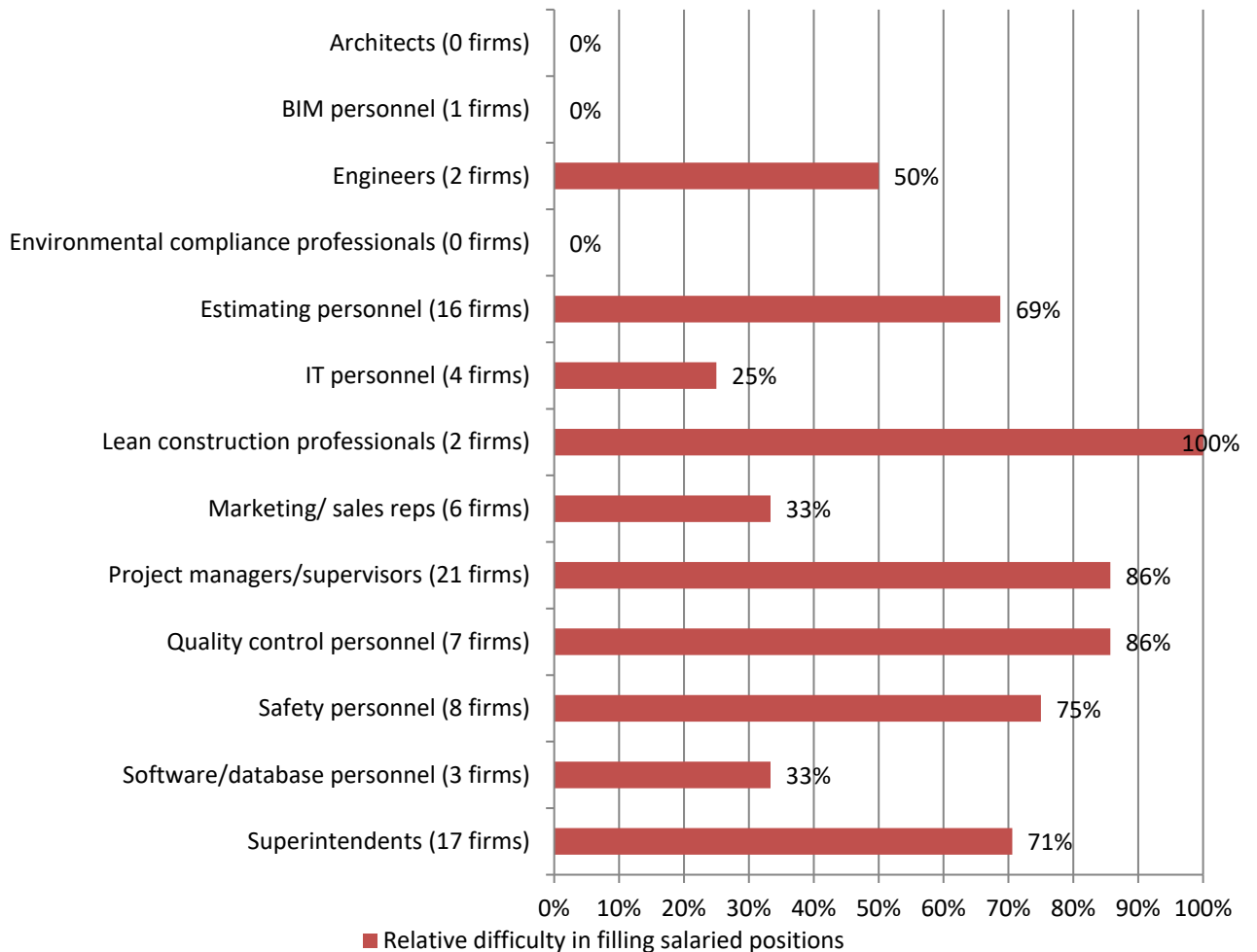
3. Describe your difficulty in filling open positions: Responses: 27 Salaried; 28 Craft



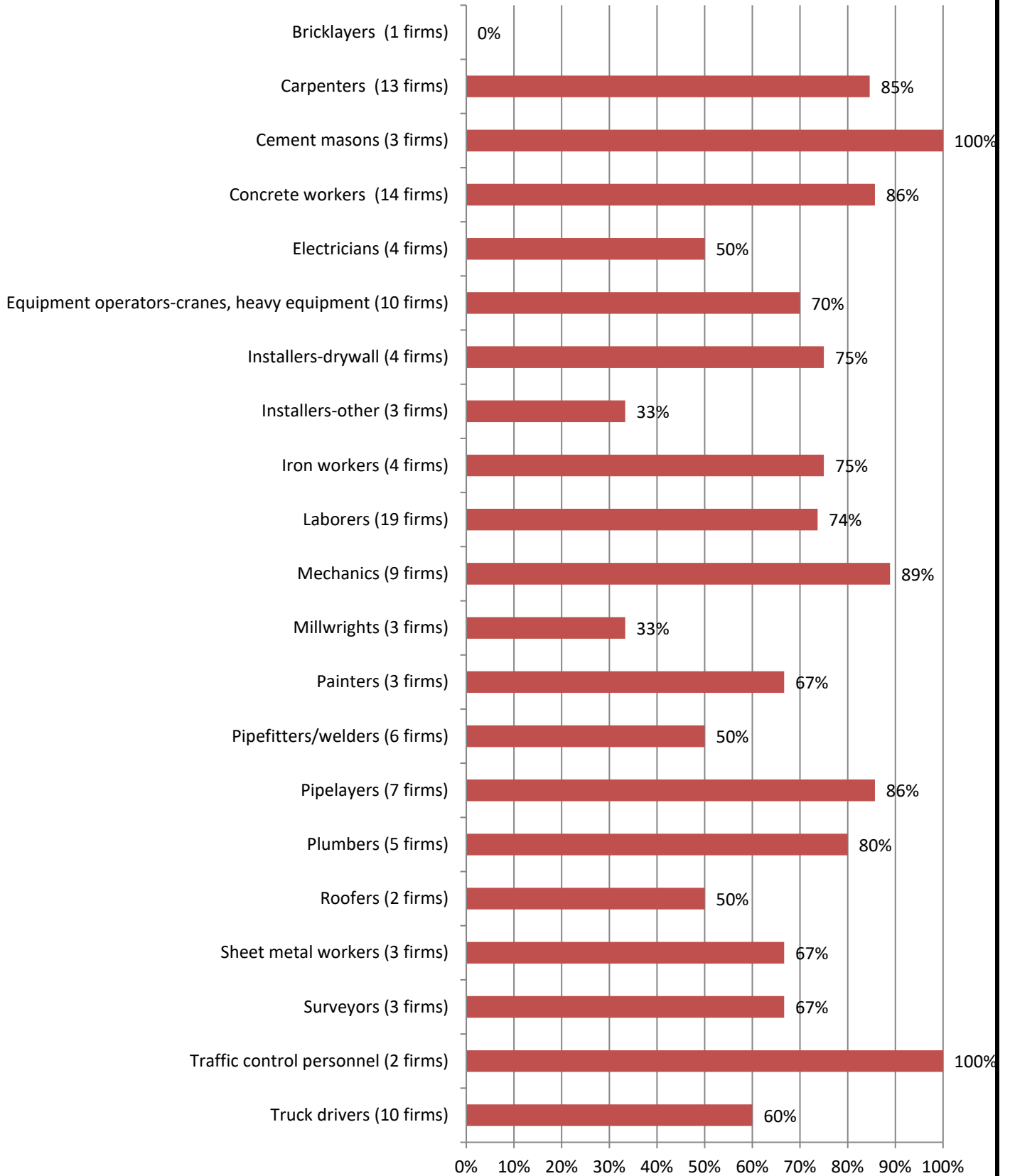
4. How many unfilled hourly craft or salaried positions did you have on June 30, 2023? Responses: 28 Salaried; 27 Craft

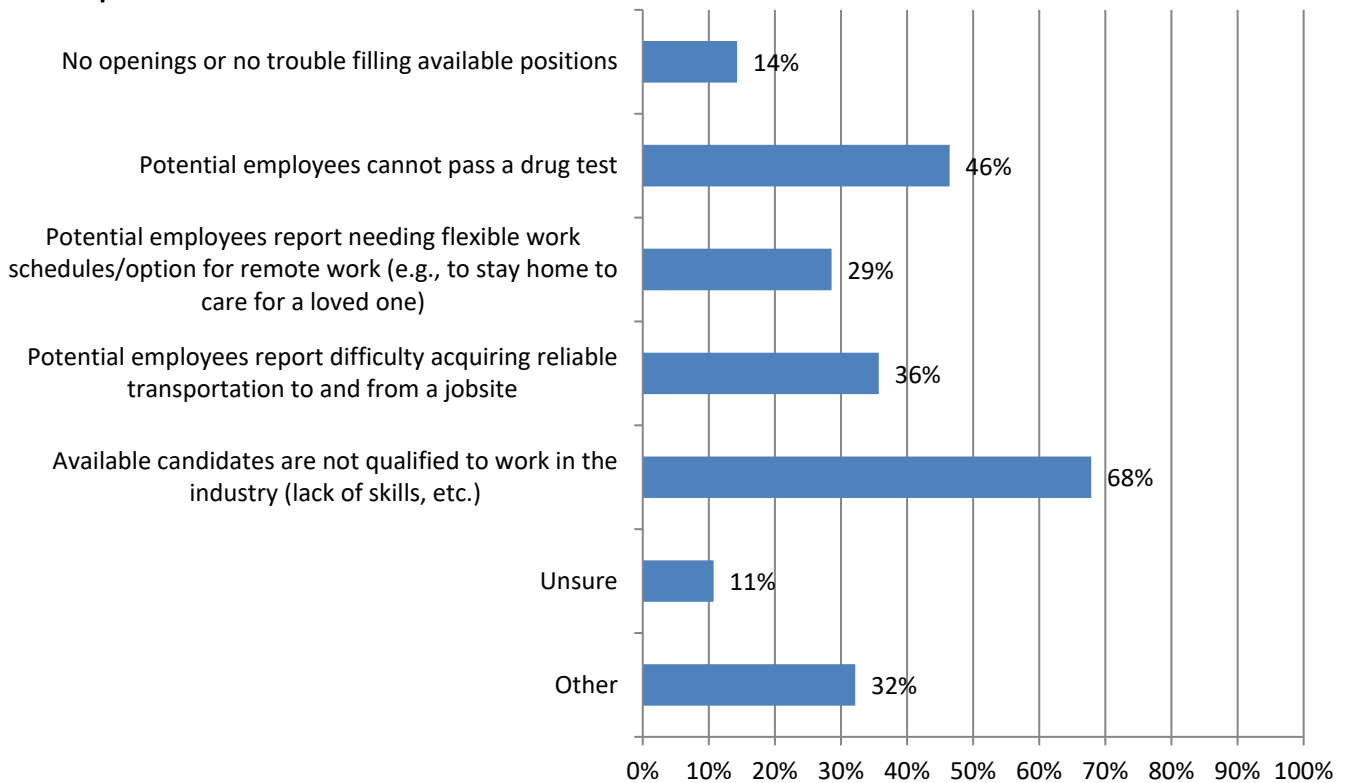

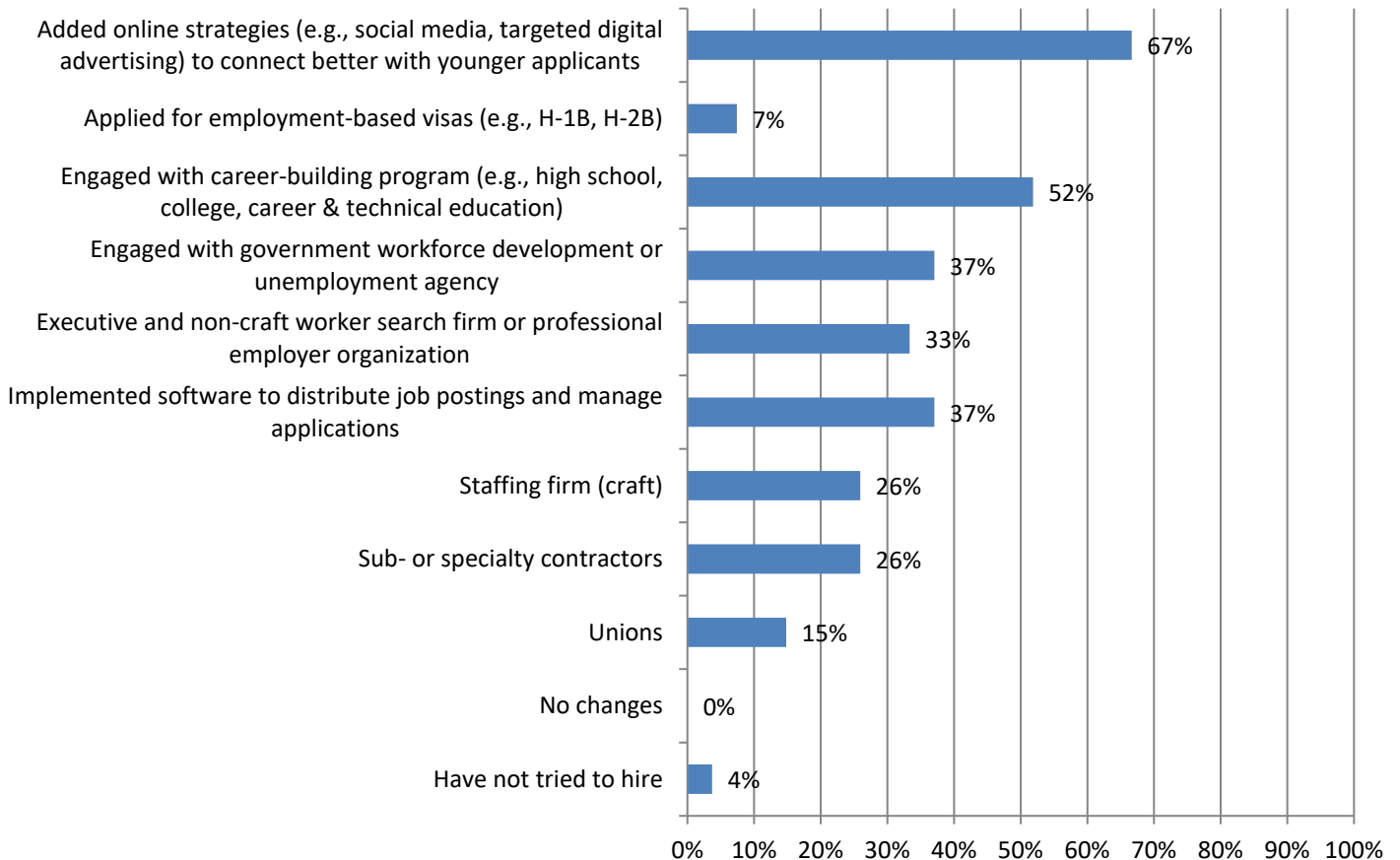
■ Relative difficulty in filling hourly craft positions

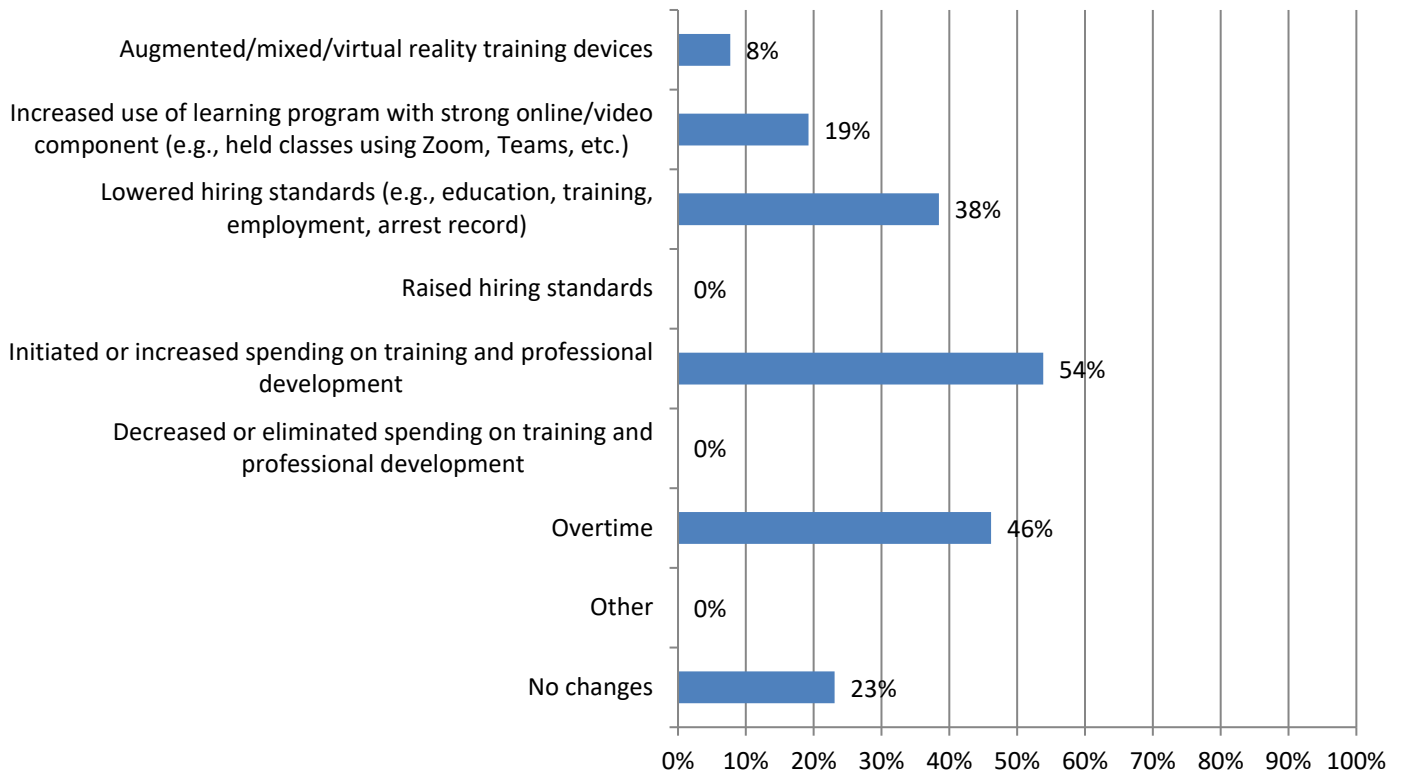

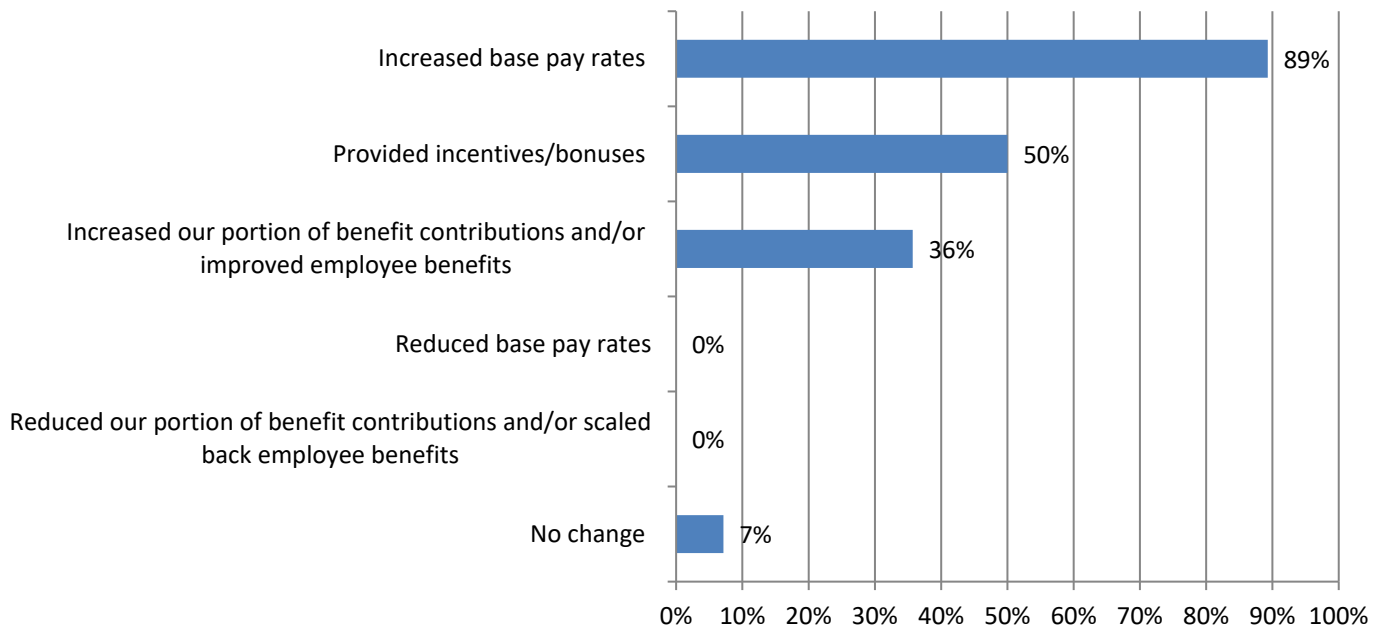

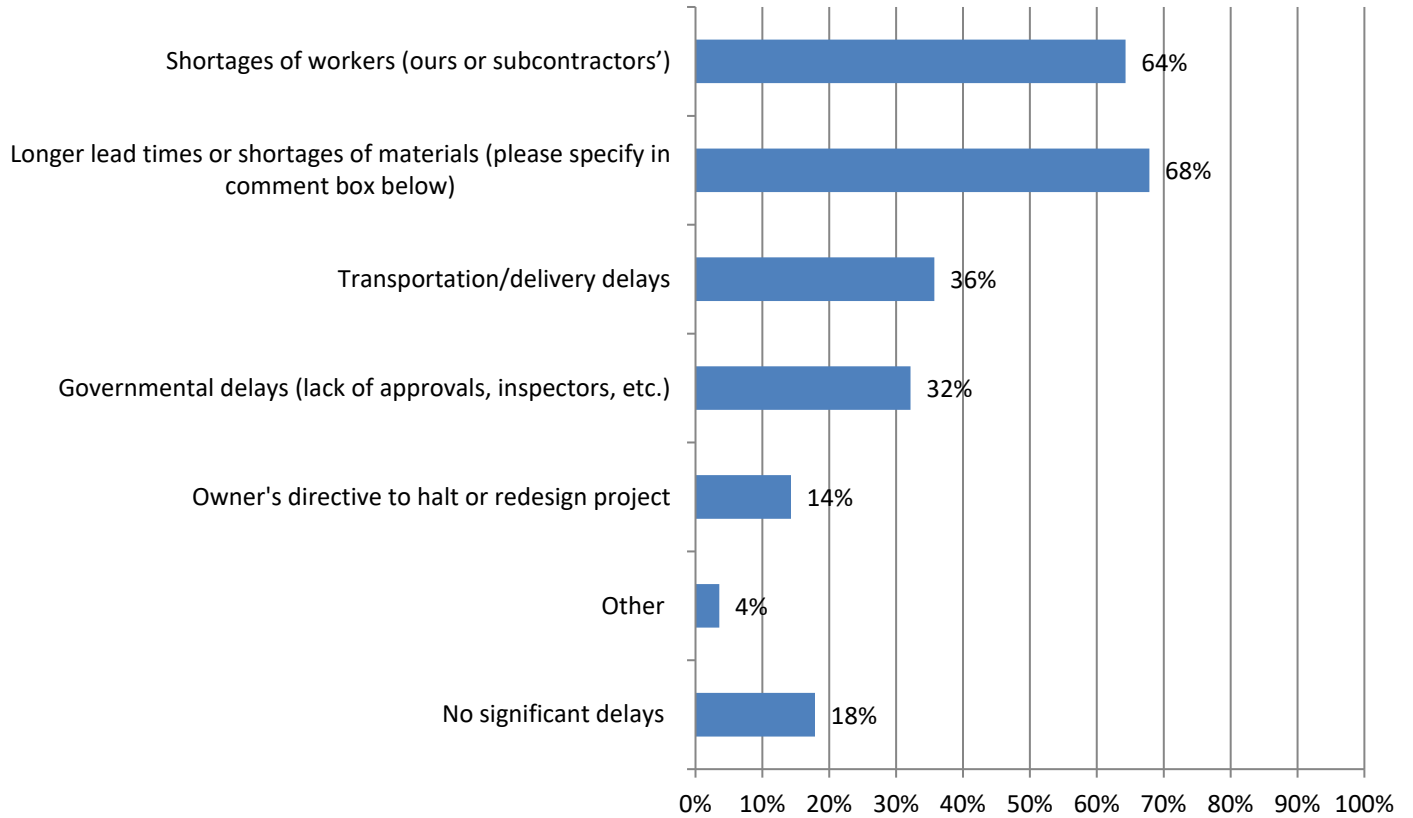

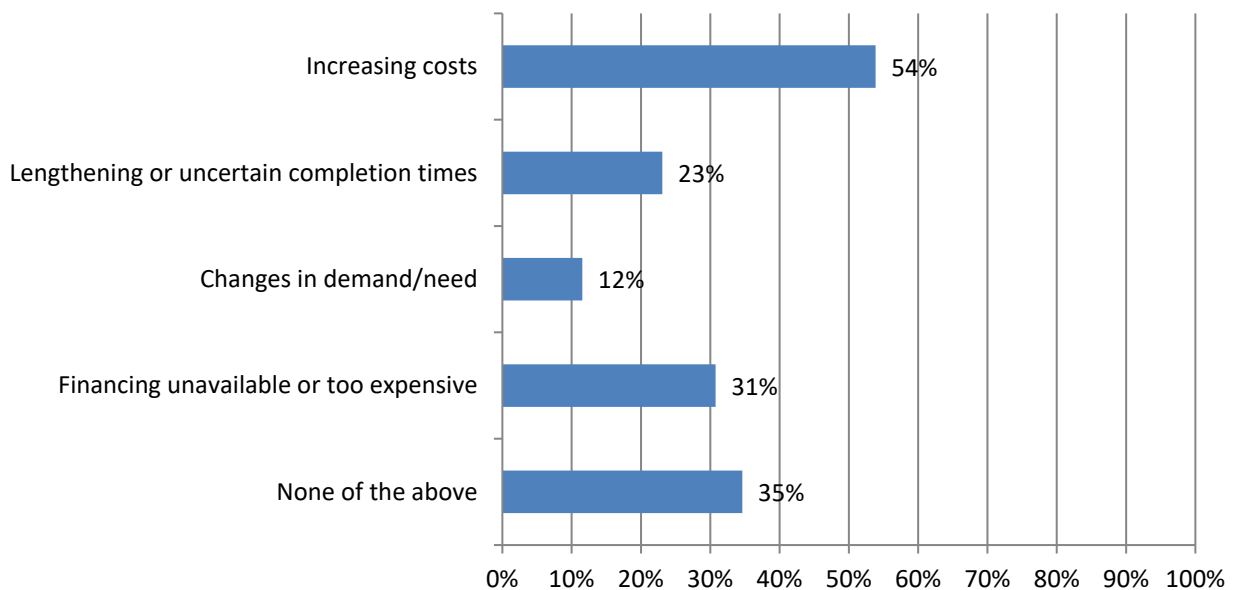

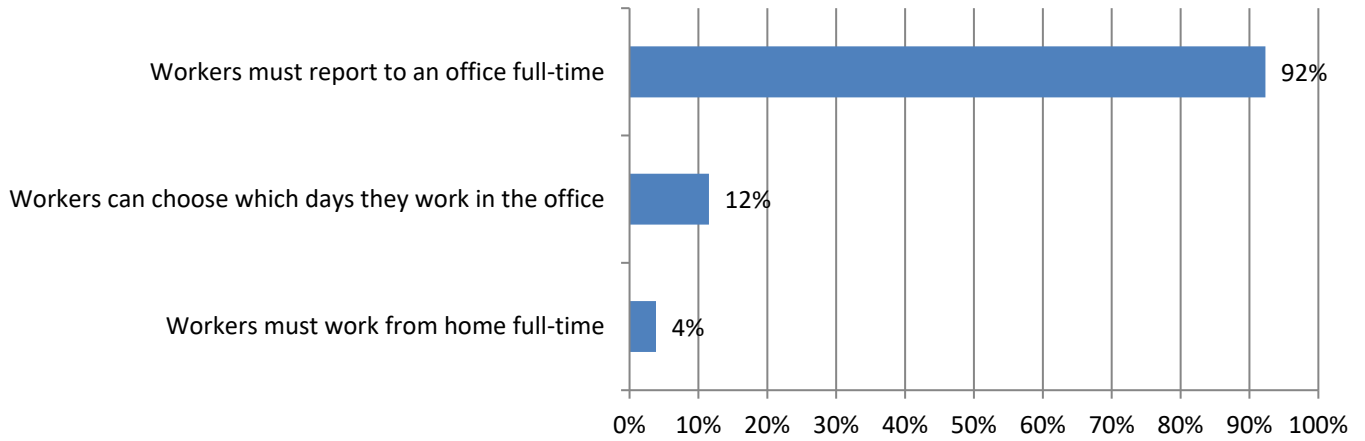

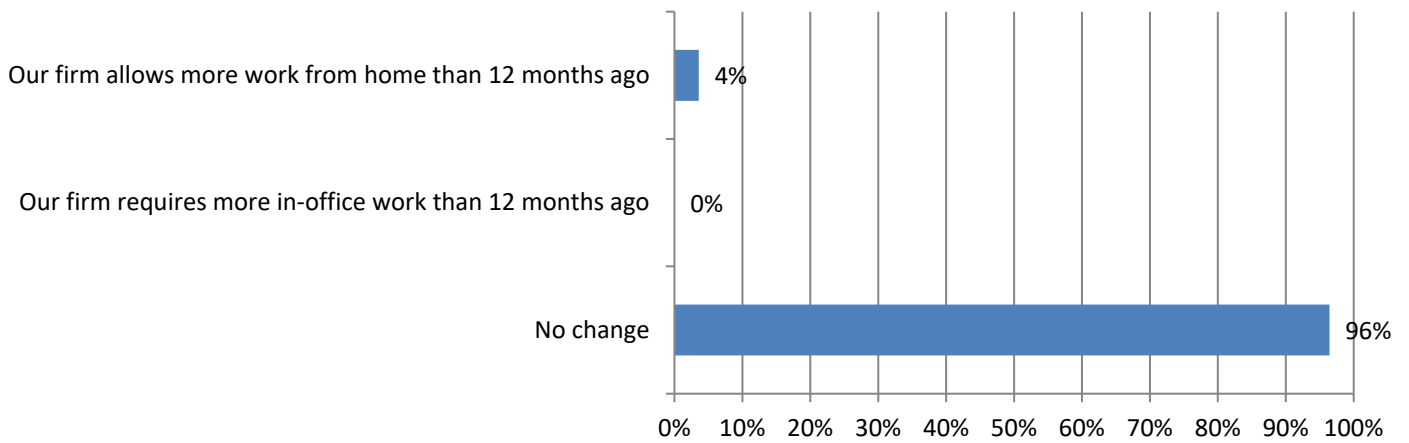

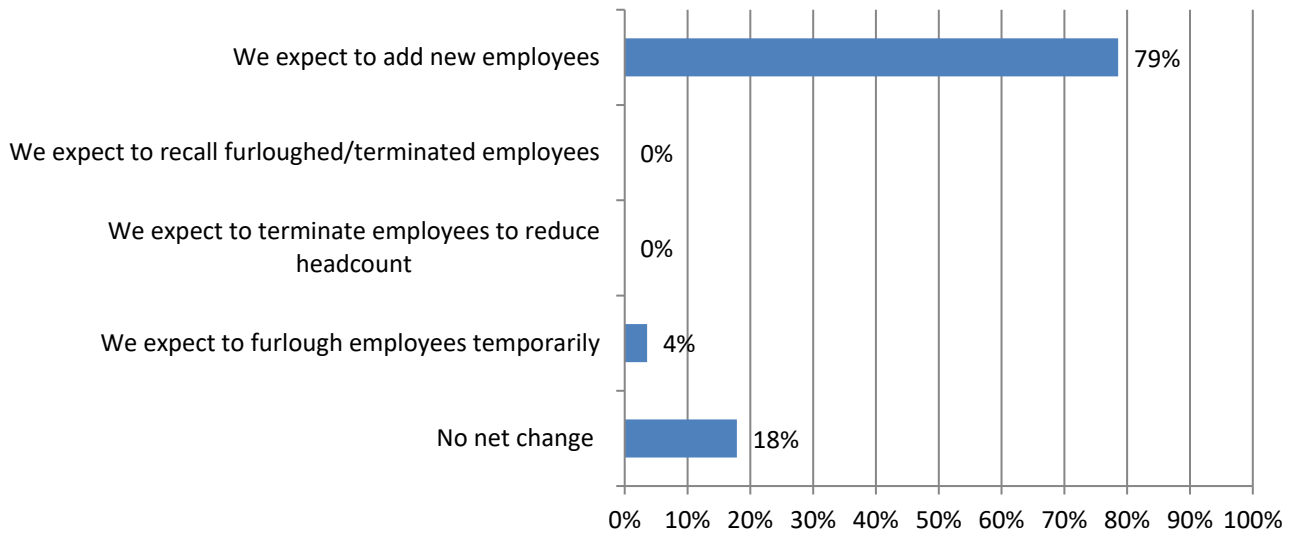

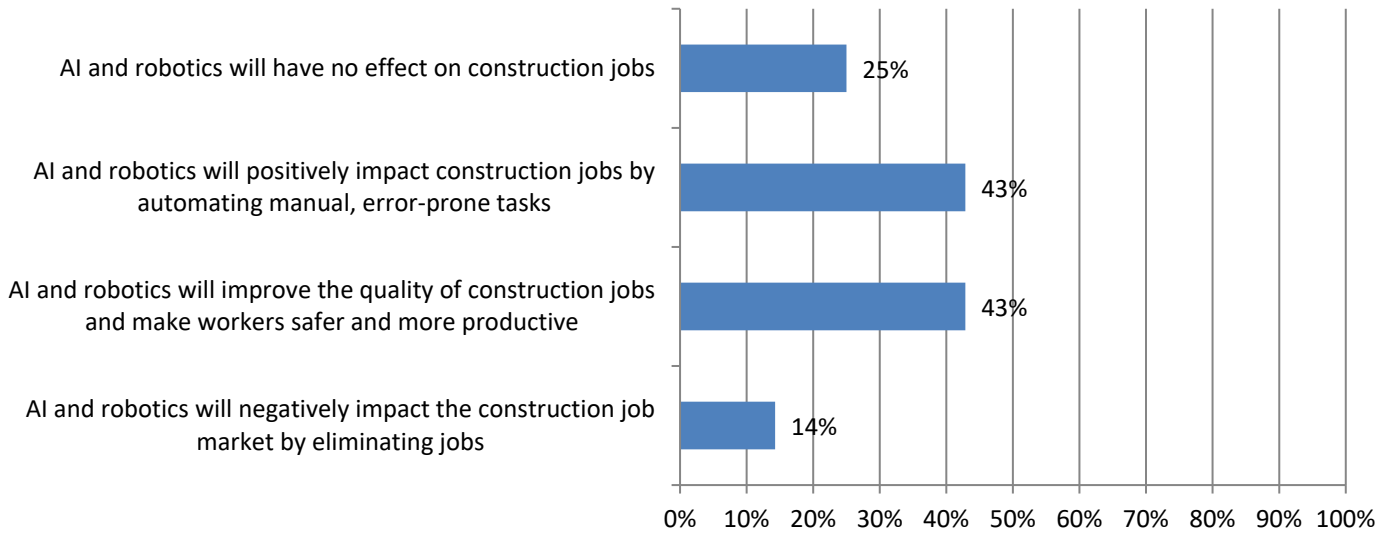

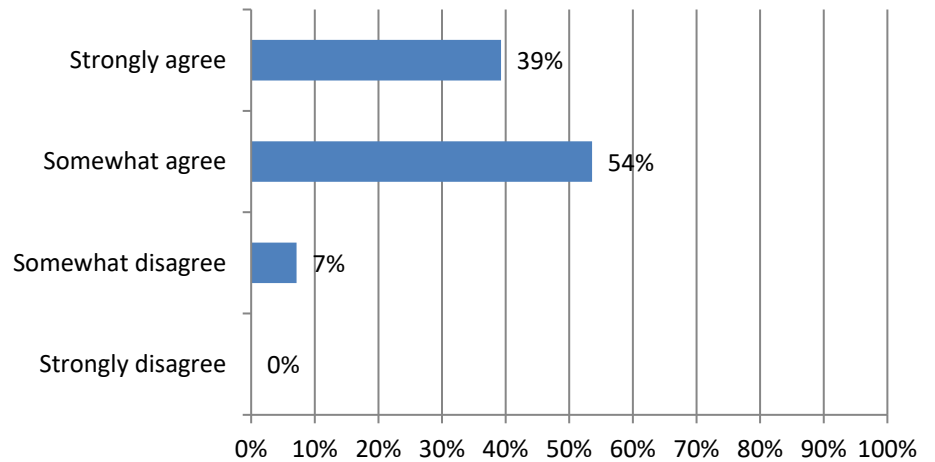

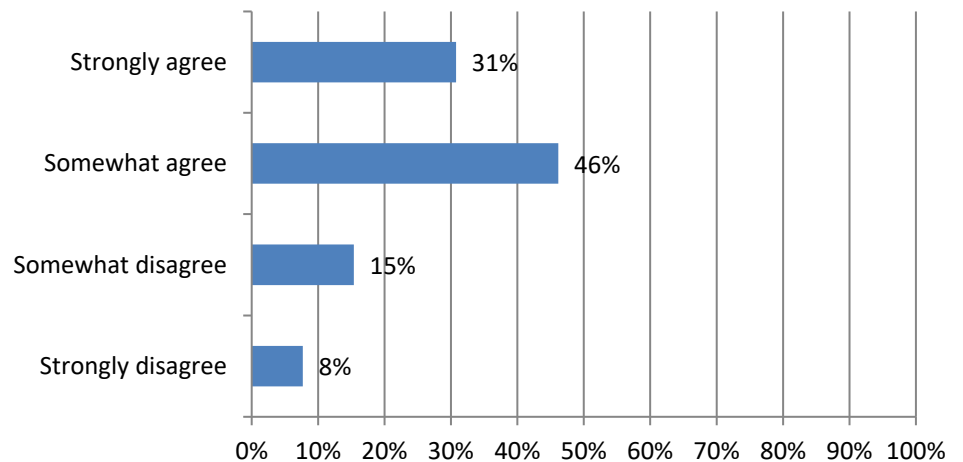

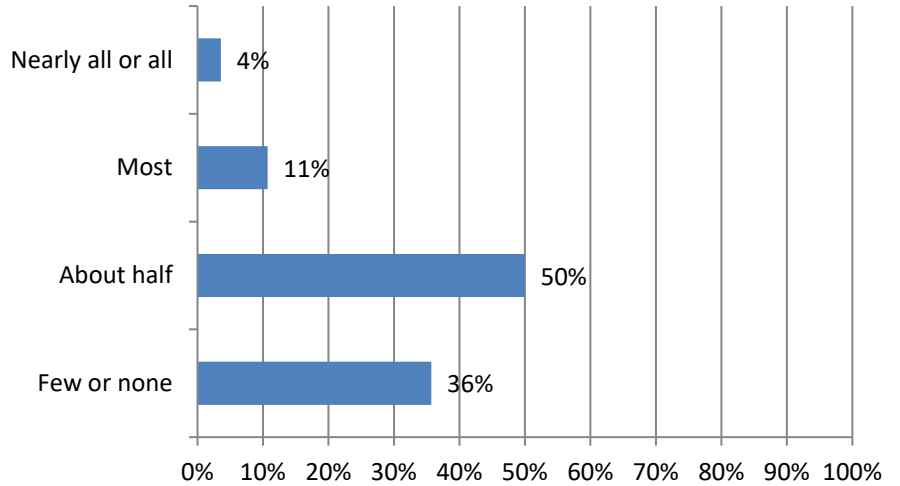

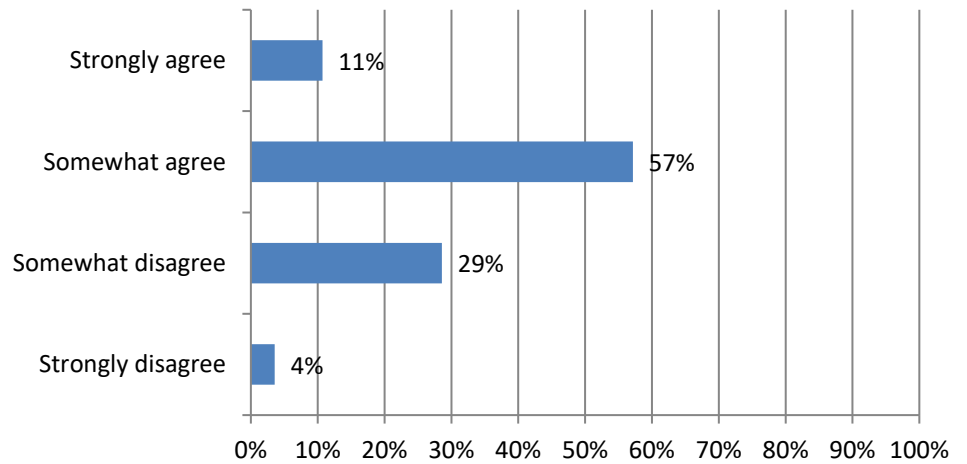

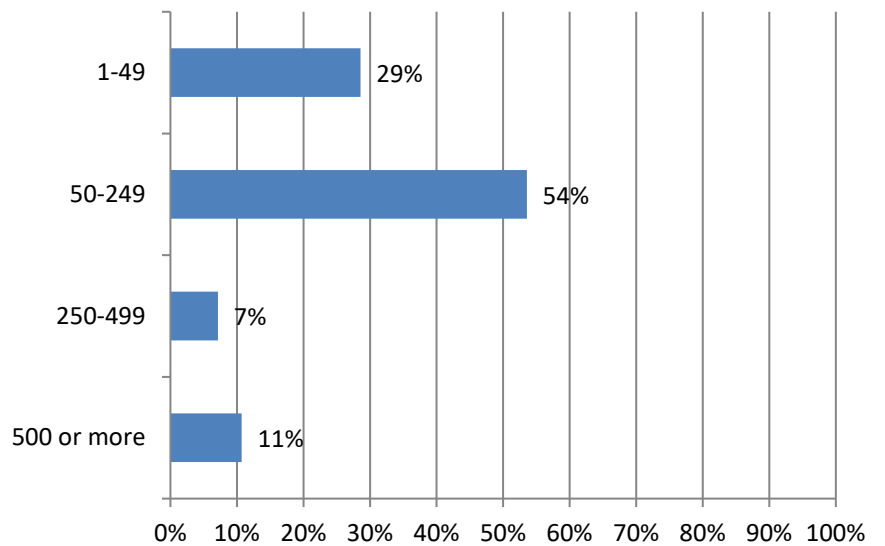

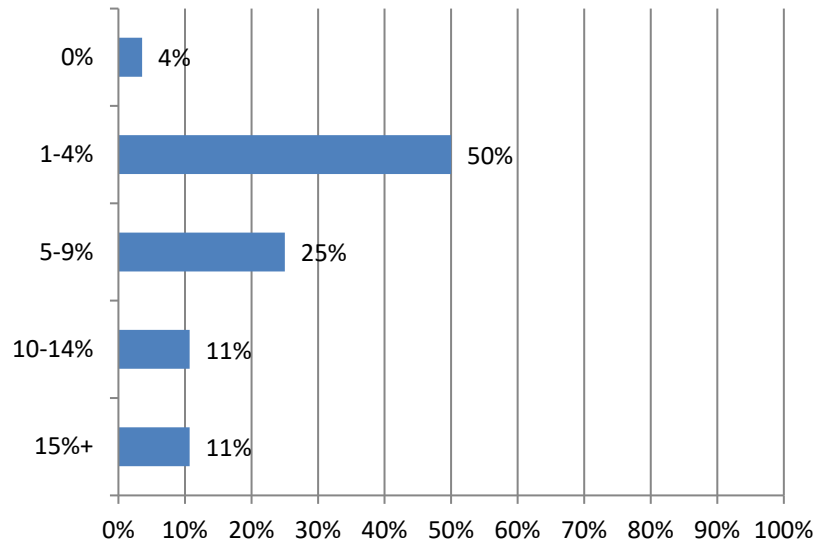

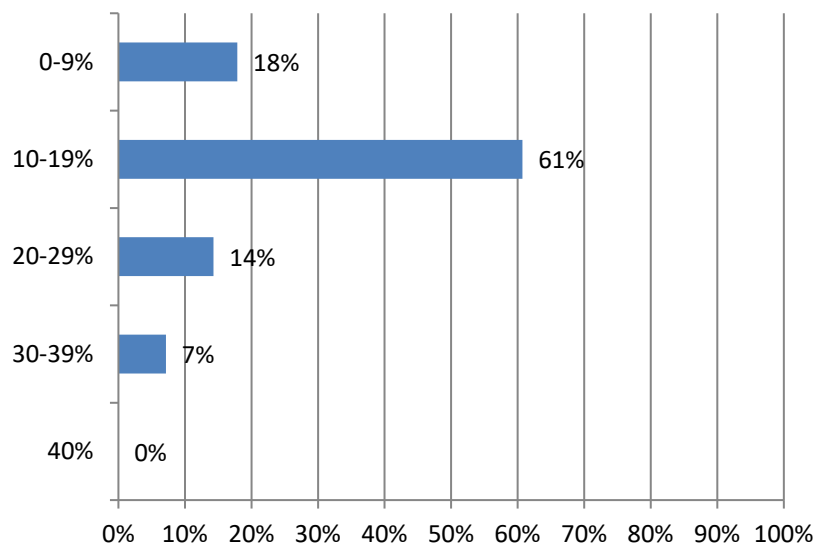

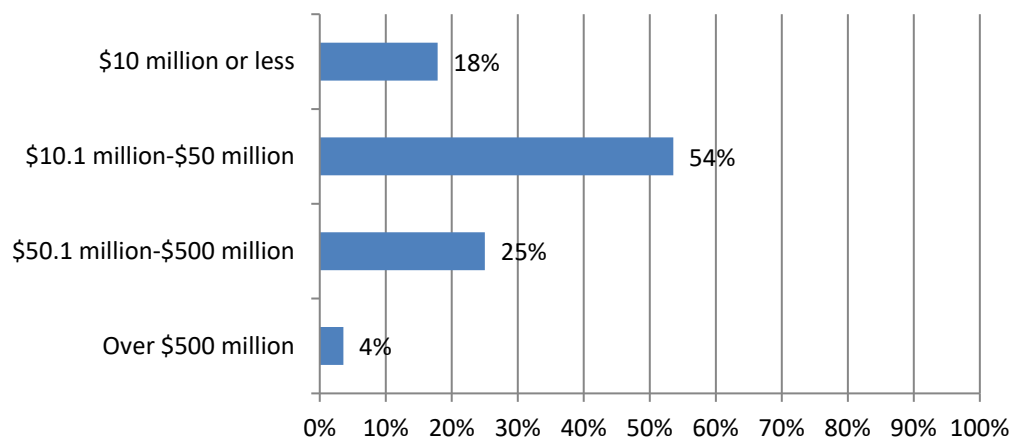

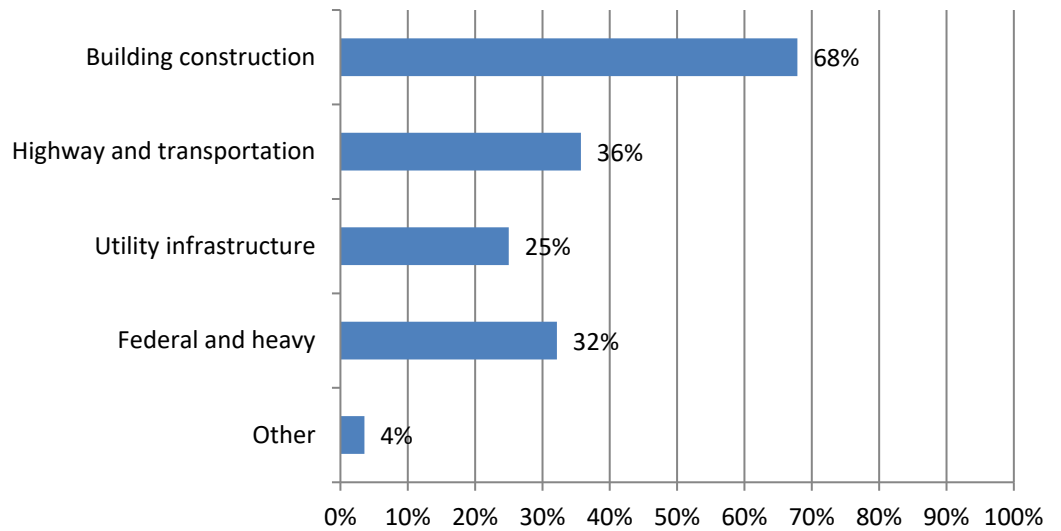
