- Regular Member, \$175 due.** Open to licensed attorneys who: (a) have at least five years' experience representing employers in labor, employment, and/or employee benefits legal matters, and (b) regularly represent chapters of The Associated General Contractors of America ("AGC") or AGC-member construction contractors in labor, employment, and/or employee benefits legal matters.
- Retired Member, \$175 due.** Open to individuals who: (a) have been Regular Members in good standing for at least five of the past eight years, and (b) have retired from the full-time practice of law.
- Retired Member Qualifying for Dues Waiver, \$0 due.** Individuals who (a) qualify as Retired Member per description above and (b) have referred a new Regular Member within five years prior to the date of retirement are entitled to a dues waiver in perpetuity. However, the dues waiver will not apply in any Membership Year in which the individual attends the Fall Meeting in person.

Council membership has many benefits, including eligibility to participate in the Council's Fall Meeting, LELC eForum (the Council's email discussion group), and all other Council activities and to receive all Council mailings, possible referrals by AGC staff and Council members, and a reduced registration fee for the Council's annual Construction Labor Law Symposium.

Council membership now runs on a calendar-year basis. Payments are accepted year-round, but dues will not be pro-rated for payments made mid-year.

Council membership is by individual, not by firm. Each individual desiring membership must submit his or her own dues.
