Speaker Bios

David Fosbroke, Statistician, NIOSH, Division of Safety Research (DSR)

David Fosbroke is a statistician at the National Institute for Occupational Safety and Health (NIOSH), Division of Safety Research, Surveillance and Field Investigations Branch in Morgantown, West Virginia. Since joining NIOSH in 1991, his research has focused on the analysis of fatal and nonfatal injuries among workers in the U.S. construction industry, collaboration with the roadway construction industry to evaluate injury prevention measures and advocacy for improvements in worker safety at roadway construction sites.

Fosbroke continues his interest in work zone safety while assisting the NIOSH Center for Motor Vehicle Safety conduct program evaluation and long-term planning. He received his master's degree in forestry from West Virginia University in 1993.
