Background and Overview

- The CSEA is sponsored by Willis Towers Watson and is an ongoing and evolving effort by AGC and Willis.
- The purpose of the CSEA is to recognize those construction companies who excel at safety performance.
- Unlike other awards programs that limits the criteria to frequency rates, the CSEA selection process is considerably more comprehensive.
- Judges will look for evidence of company management commitment, active employee participation, safety training, work site hazard identification and control, and safety program innovation.

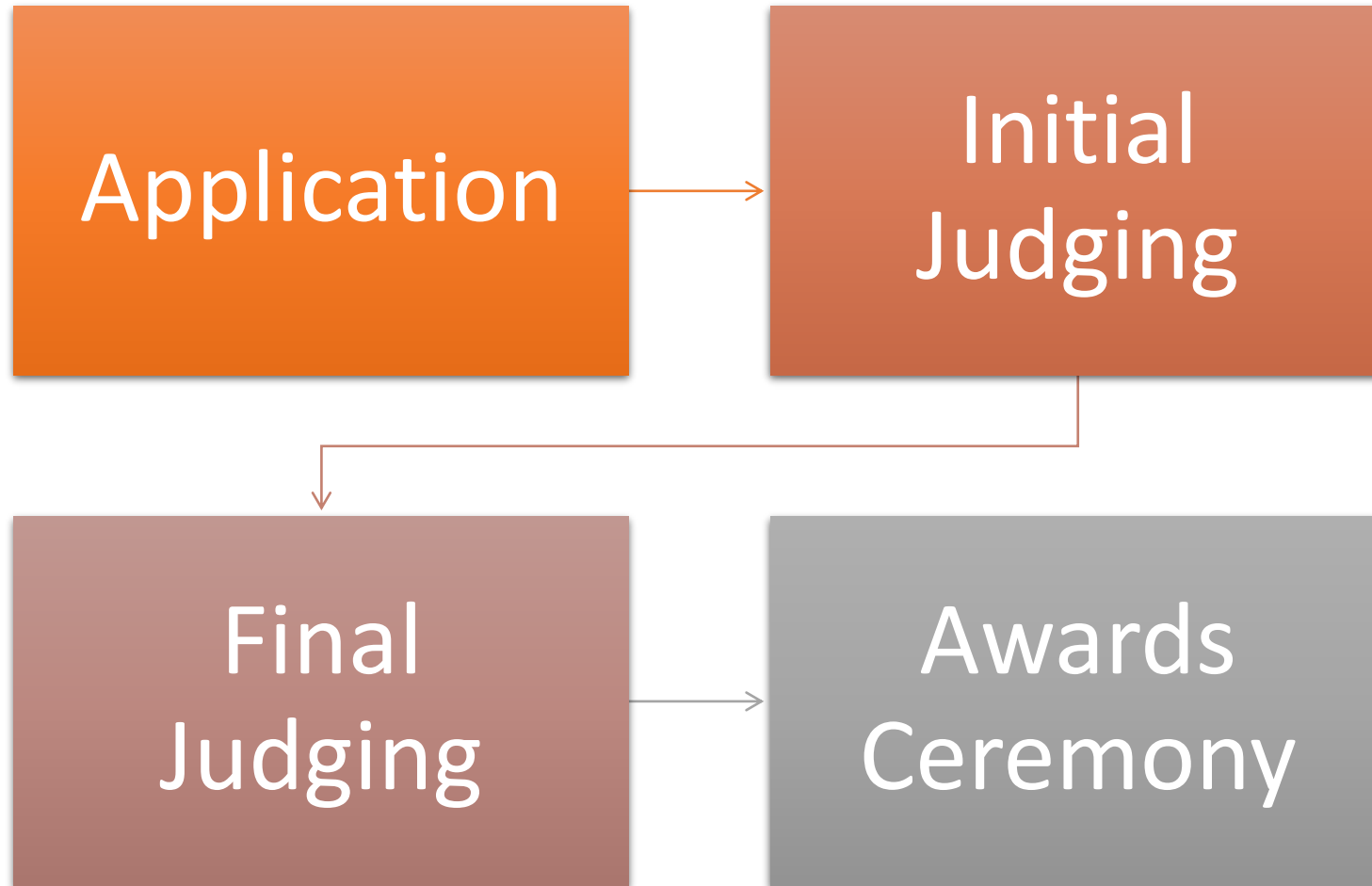


Why Participate?

Process





 - Feel free to ask for assistance from the contact list provided as well as your local AGC Chapter.



Application Review

- **Section 1:** Applicant information
- **Section 2:** Entry divisions and hours worked
- **Section 3:** Injury & illness incidents and frequency rate
- **Section 4:** Executive summary – why do you deserve to win?
- **Section 5:** What are you doing for safety that is innovative?
- **Section 6:** Description of company projects
- **Section 7:** Description of safety program
- **Section 8:** Safety program assessment

Initial Judging

- Initial judges are experienced safety and health professionals who are active AGC members.
- These members come from companies of like size and perform similar scopes of work as your organization.
- Judging teams are assembled to balance the volunteers' individual talents to match the divisional categories they will be judging.
- Typically, initial judging occurs in person, for two days, prior to the AGC Construction Safety & Health Conference in January each year.



Initial Judging

- In 2021, initial judging will take place virtually, but mimic the in-person process.
- Judges review quantitative measures, narratives and the program evaluation checklist and complete scoresheets accordingly.
- Finalists and non-finalists will be notified during the week of January 25 – 29, 2021. You will also receive feedback from the judges regarding your application.

Final Judging

- Marriott World Center – Orlando, FL
- March 27 – April 1, 2021
- Finalists presentations and interviews with an independent panel of five judges.
- Specific date/time for each finalist presentation
- 30-minute orientation
- 5-minute presentation & 10-minute Q&A
- Exit interview



Final Judging

- There is no limit on the number of presenters on your presentation team.
- PowerPoint presentations and props are allowed, but handouts are not.
- Finalists are not allowed to view other presentations until their presentation is complete.
- If you qualify for the finals, you will receive a detailed email including these and other instructions.
- *Companies not participating in the CSEA are welcome to view presentations.*



Awards Ceremony

- Marriott World Center – Orlando, FL
- March 31, 2021, Luncheon, 2-3 hours
- At least one company representative should be available to accept award
- Rehearsal for the awards ceremony will take place in the evening of March 30



Other Important Events

AGC 2021 Convention

- March 29 – April 1, 2021
- Finalists who want to attend the AGC Convention can do so at a reduced registration rate of \$650.00
- Finalists can attend the awards ceremony **ONLY** for \$125 pp. The first registration is **FREE**.
