

Q1 Are you familiar with the 811/call before you dig program/requirements in areas you work in?





Q2 What means do you use to submit locate requests to your local 811 center in advance of all excavation activities you undertake? (mark all that apply)





Q3 Do you "white line" the area you would like located in advance of submitting a locate request?









Q6 Are there any weaknesses in the 811 process?






Q8 In some states 811 centers are governed by a board of directors that does not have excavator/construction industry representation; do you think excavators/the construction industry should have vested representation on those boards?



















Q17 Are you familiar with the Common Ground Alliance safe digging practices?












