## AGC's Building Infrastructure Advocacy:

- An AGC-led coalition of organizations in the building design and construction industry was formed to ensure that funding to modernize aging and inefficient public buildings and tax incentives to stimulate new private-sector building projects are included in an economic stimulus package.
- The coalition sent two letters to congressional leaders and President-elect Obama; the first one concerning building infrastructure investment and the identified needs in the different building markets, and the second concerning tax incentives that would stimulate the economy, improve energy efficiency, and create job opportunities in a stimulus package.
- The coalition also placed a full page ad in the *Roll Call* newspaper.
