




### 2. What percent change do you expect in your headcount in 2023? Responses: 65




### 3. How would you describe your current situation in filling salaried and hourly craft positions? Responses: 65




# 4. Do you expect any changes in the availability of hourly craft or salaried personnel over the coming 12 months? Responses: 65









9. Did an owner postpone or cancel any projects that were scheduled to start in 2022 or 2023? (mark all that apply) Responses: 65








