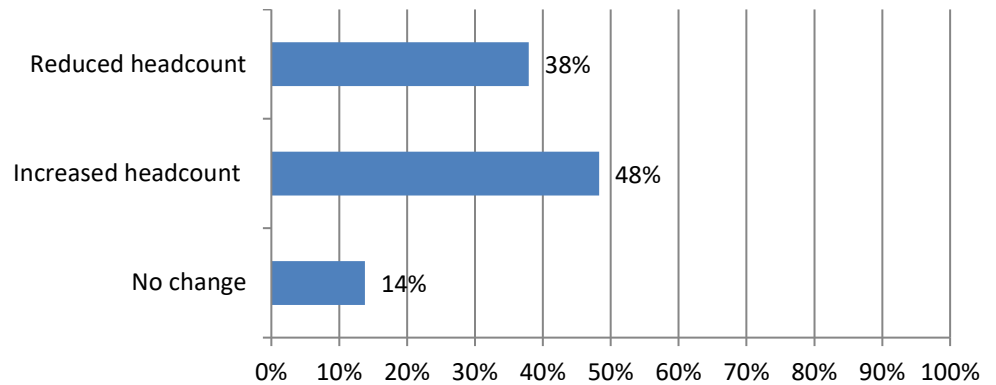

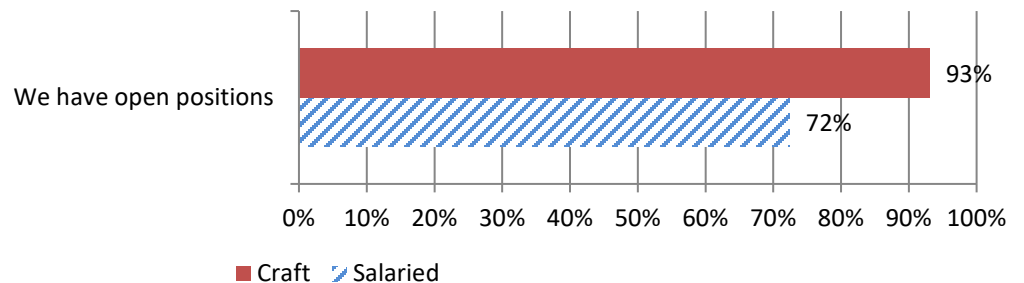

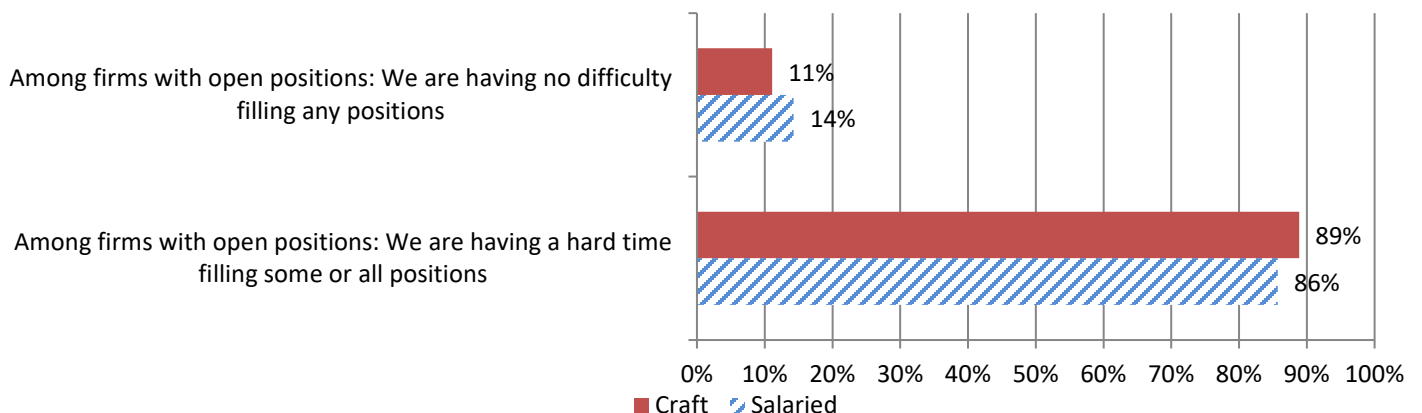
1. By what percentage has your firm's headcount changed in the past 12 months? Responses: 29



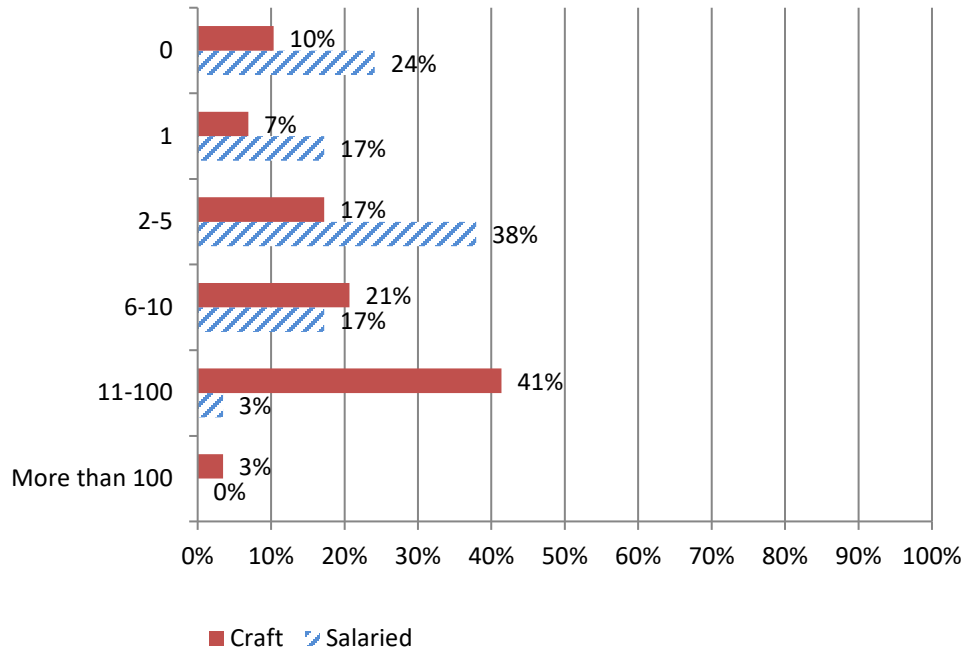
2. How would you describe your current situation in filling hourly craft or salaried positions? Responses: 29 Salaried; 29 Craft



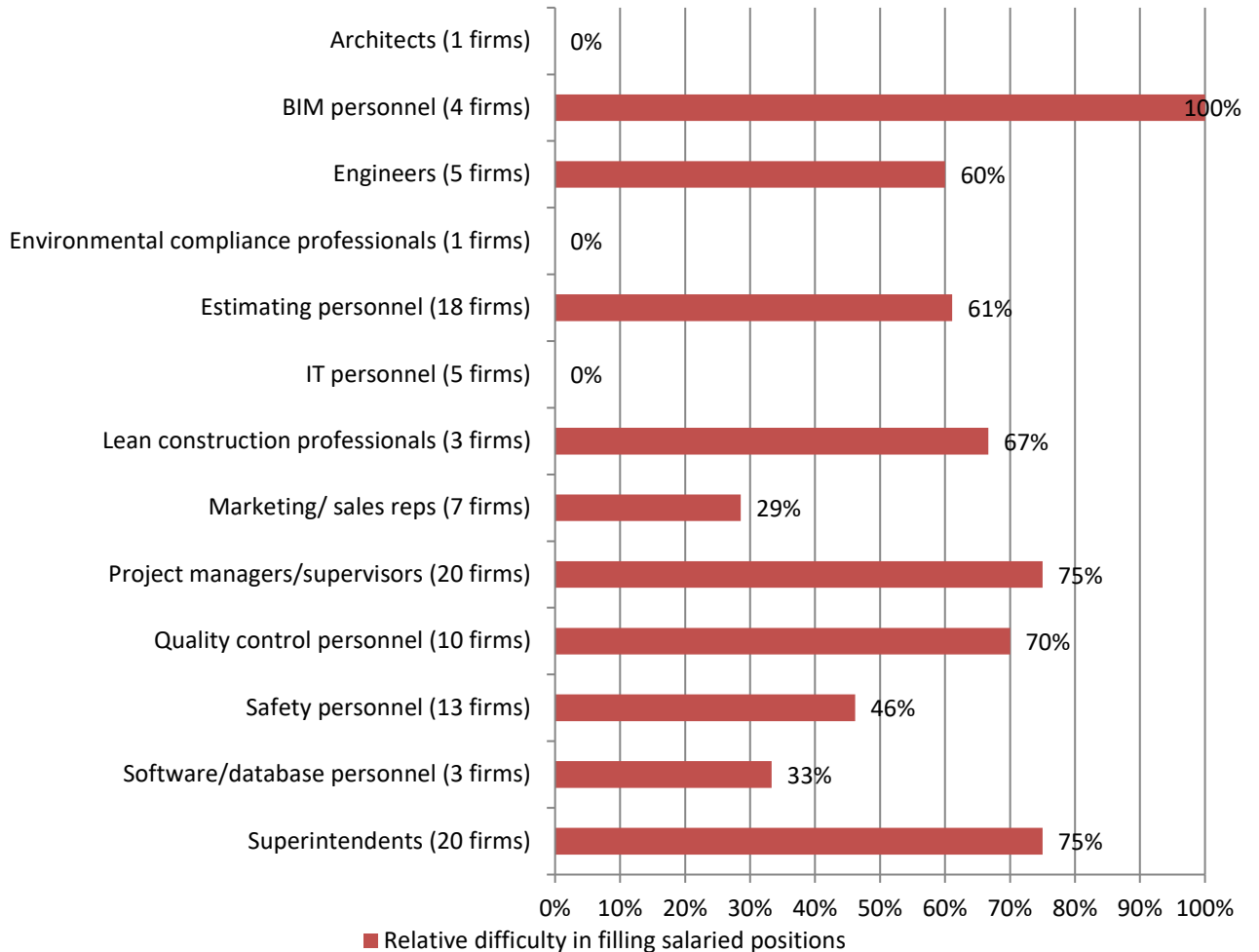
3. Describe your difficulty in filling open positions: Responses: 29 Salaried; 29 Craft



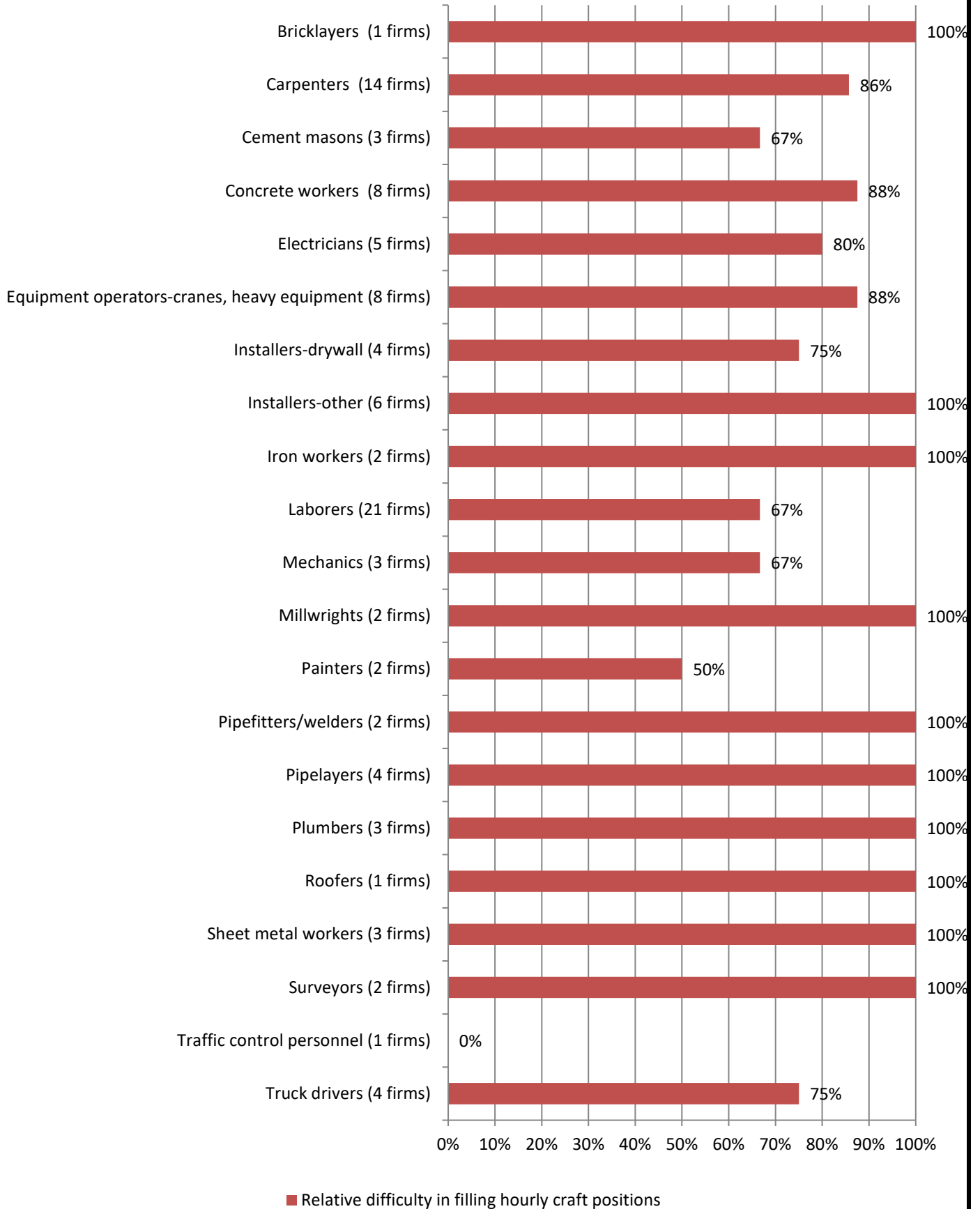

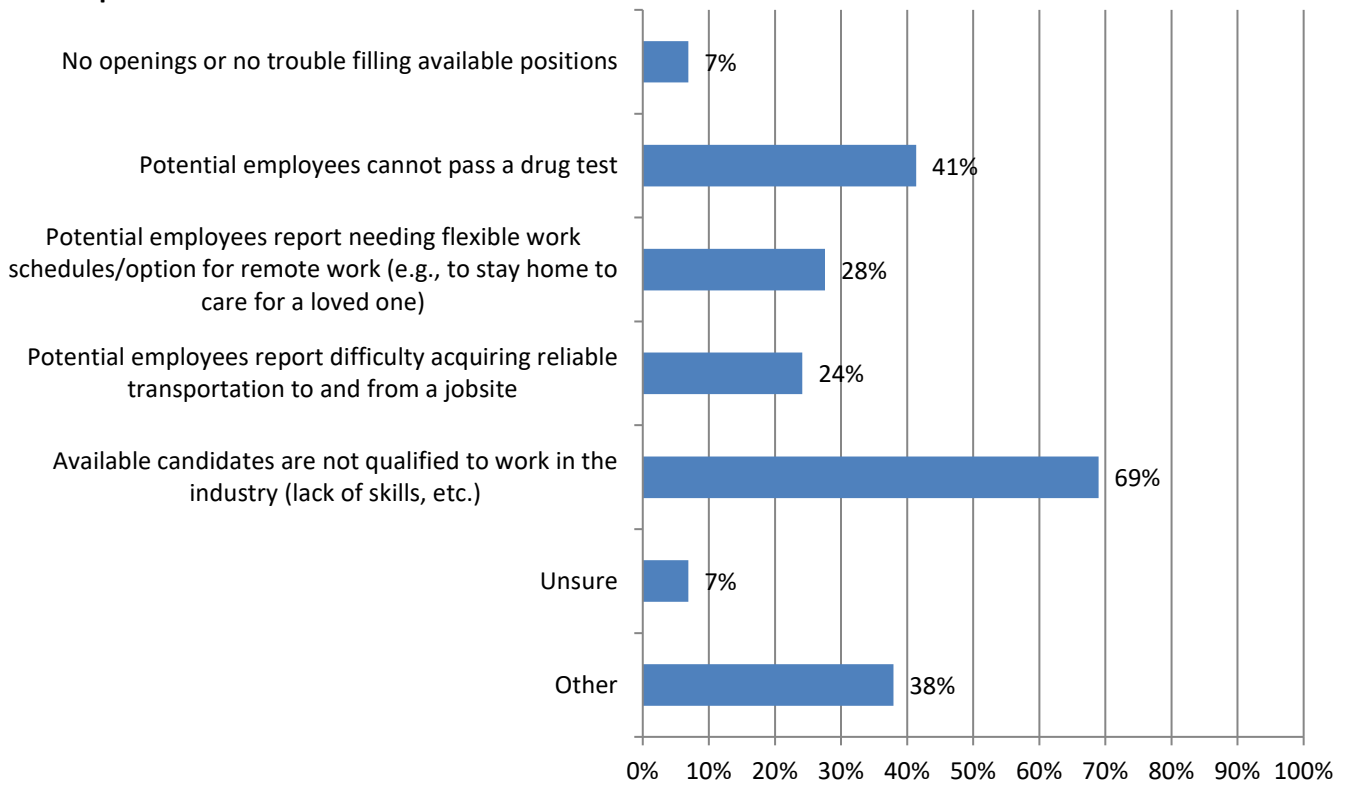

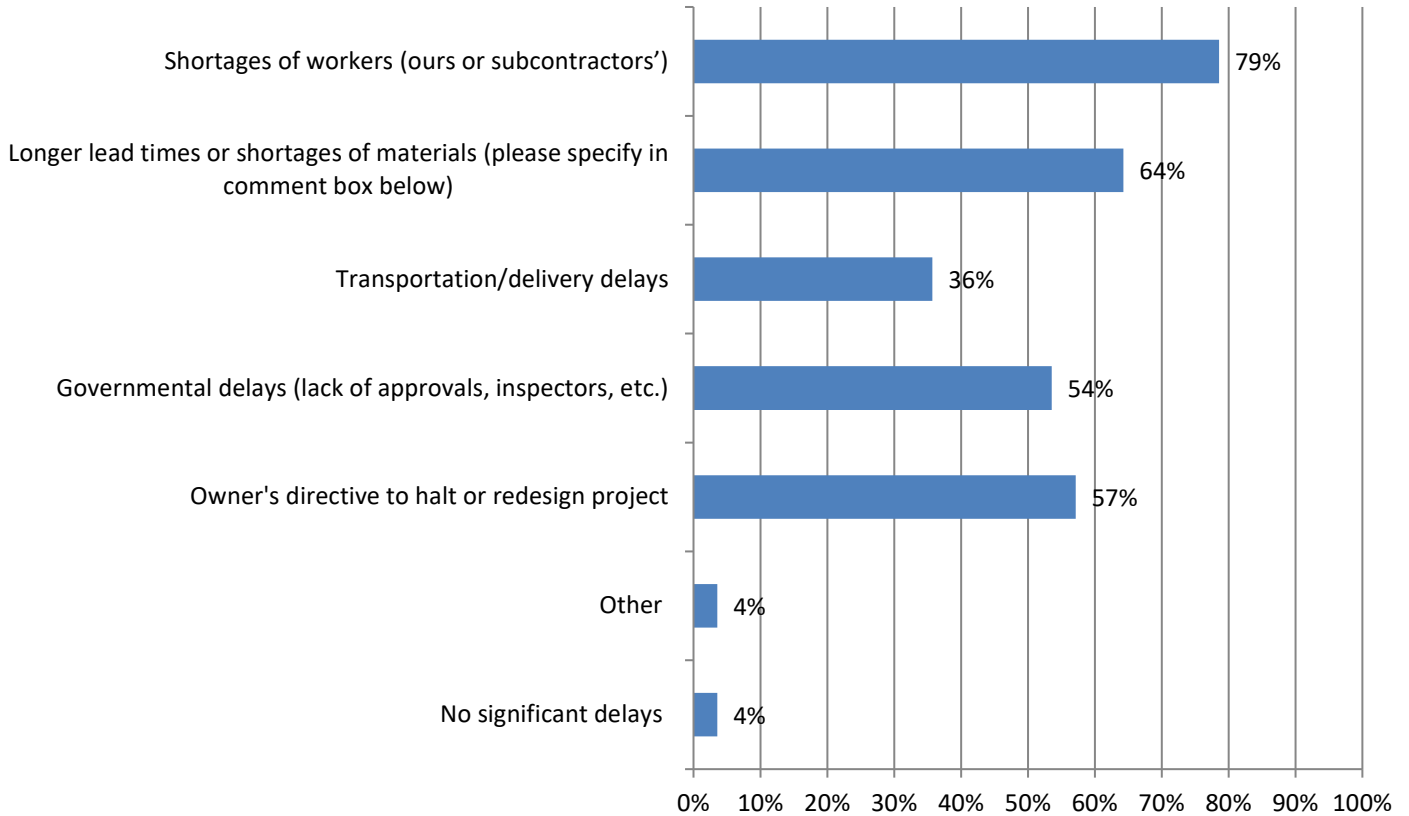

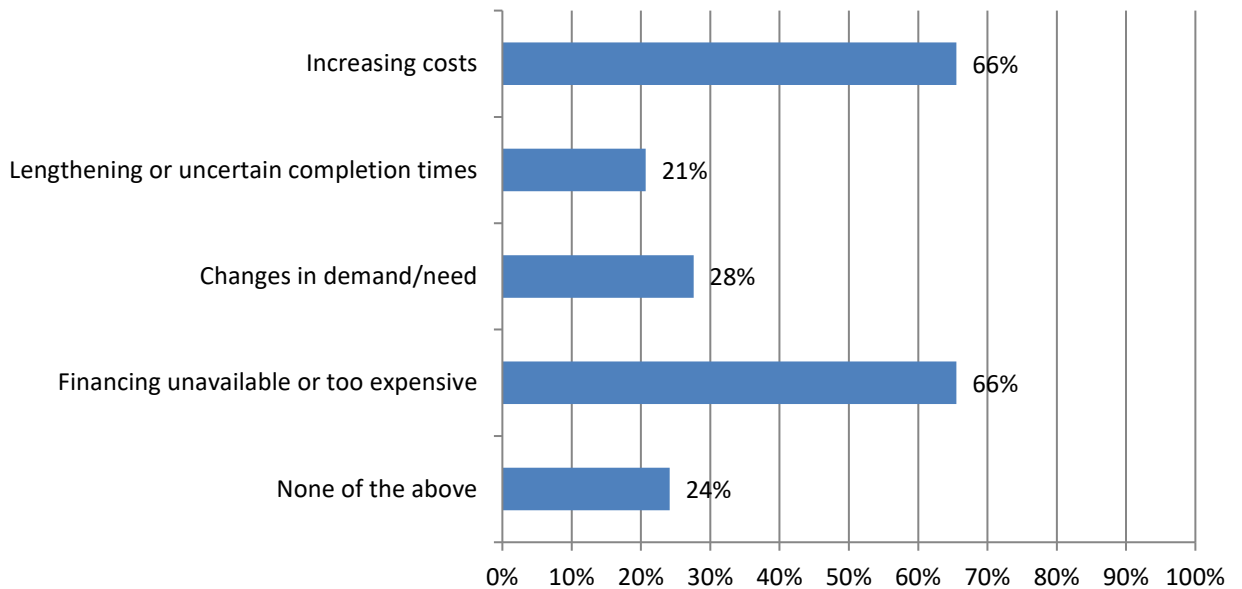

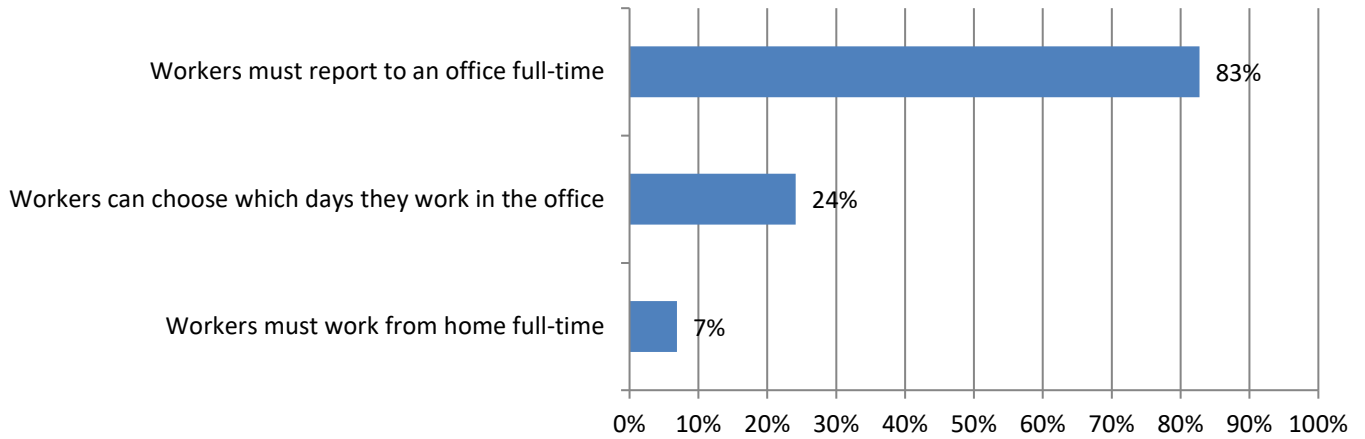

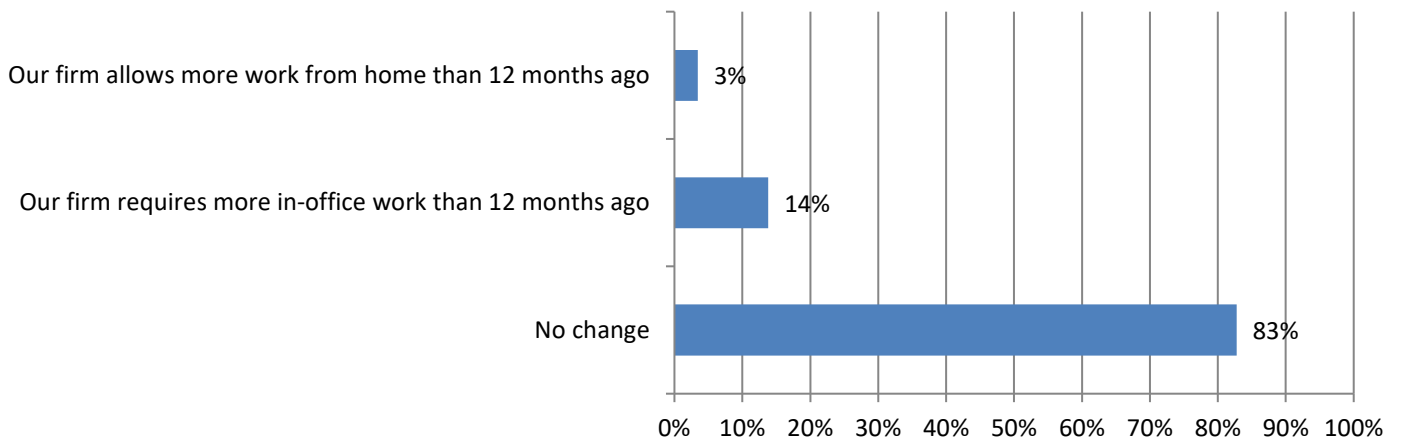

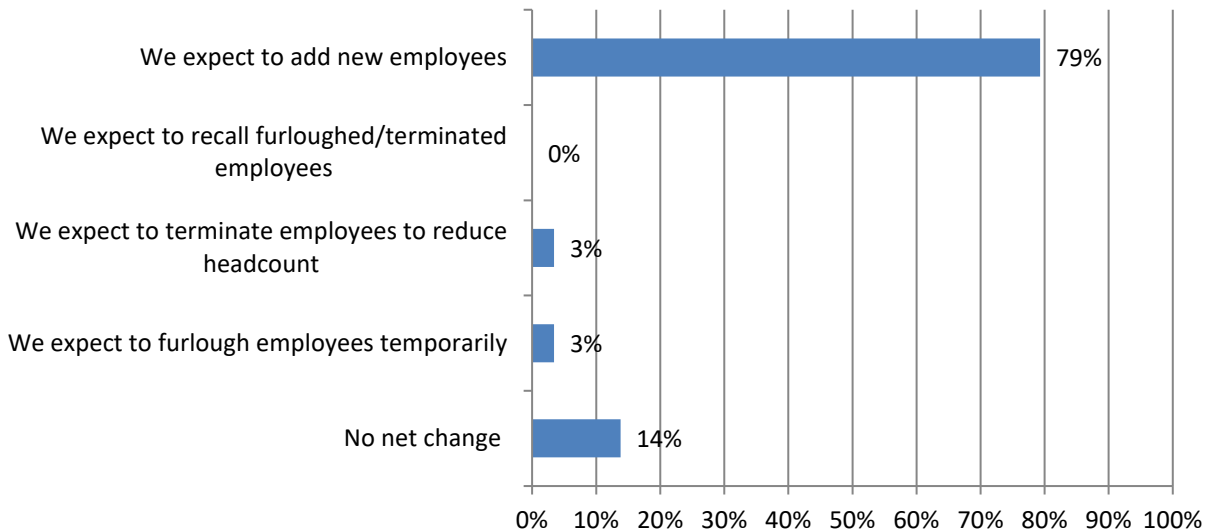

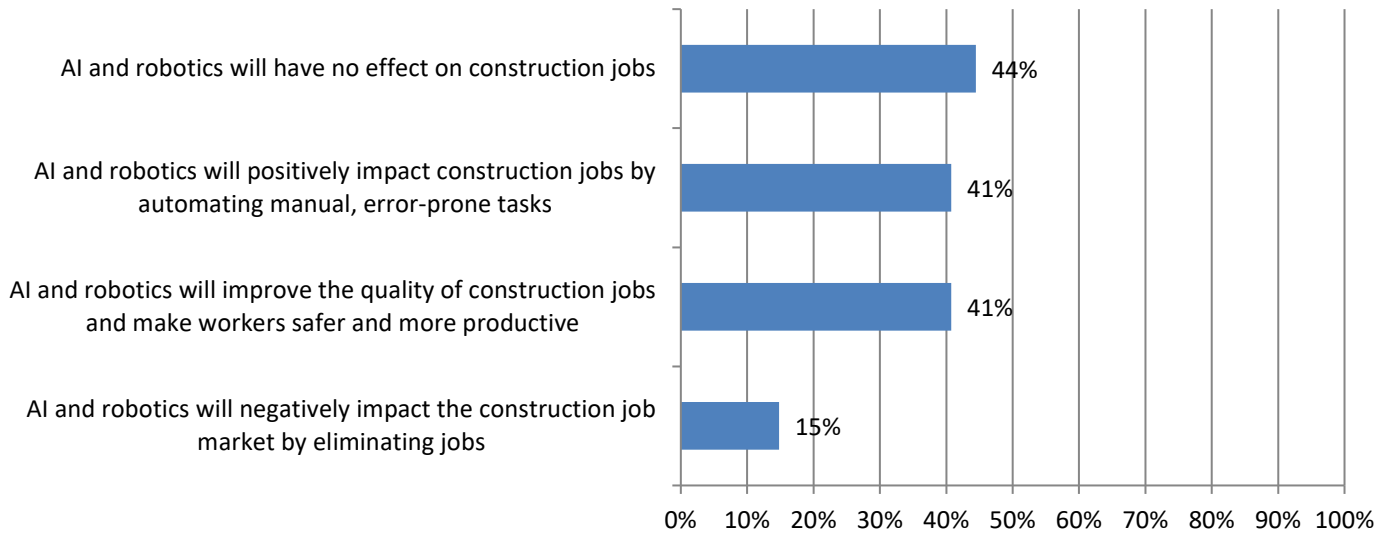

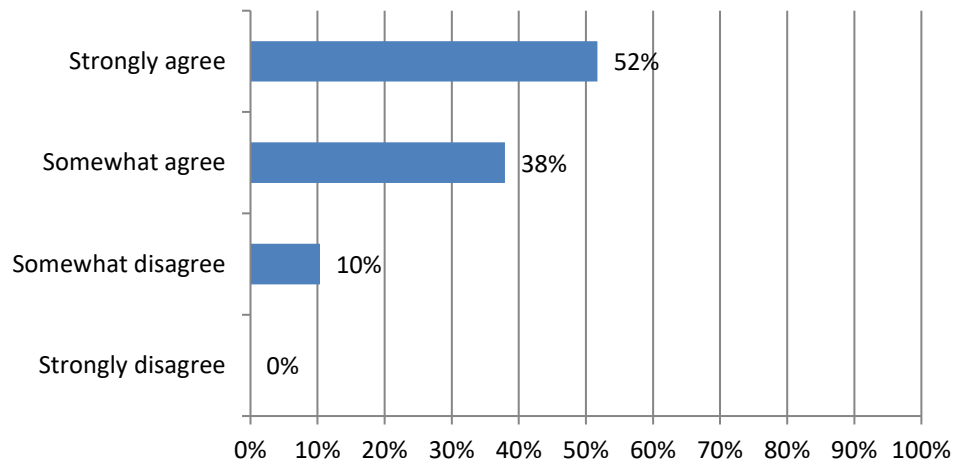

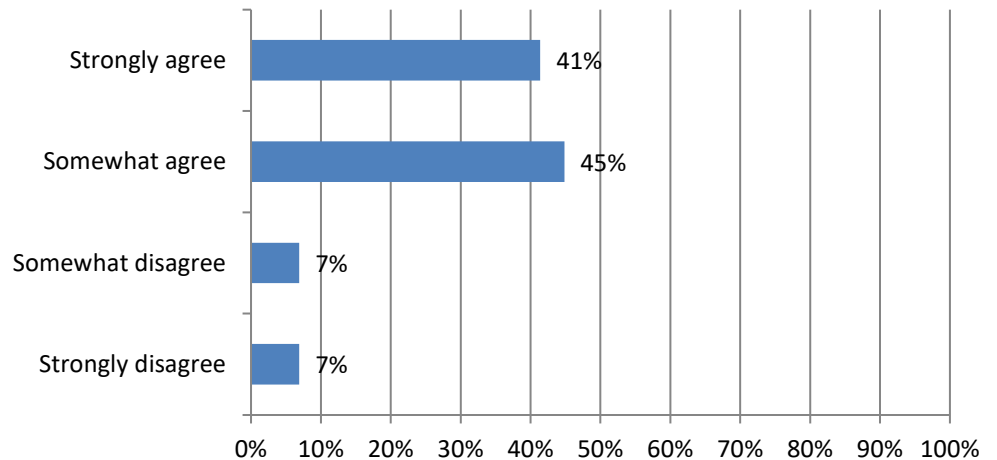

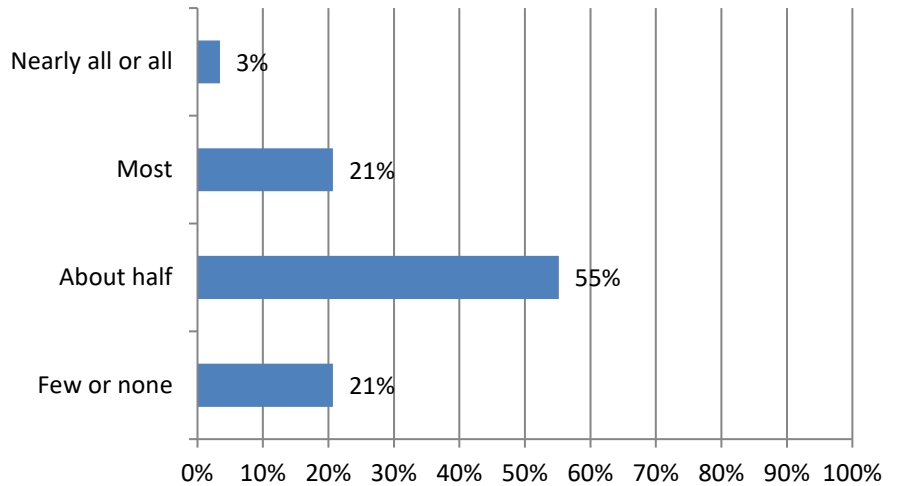

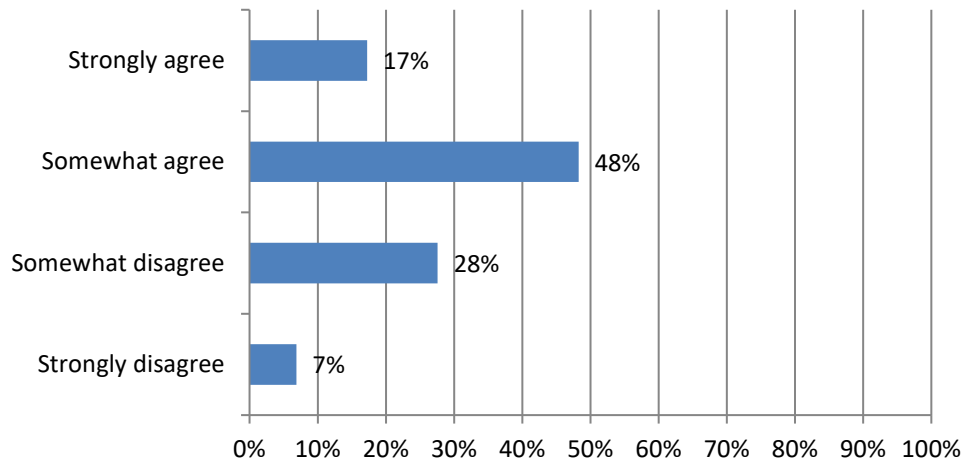

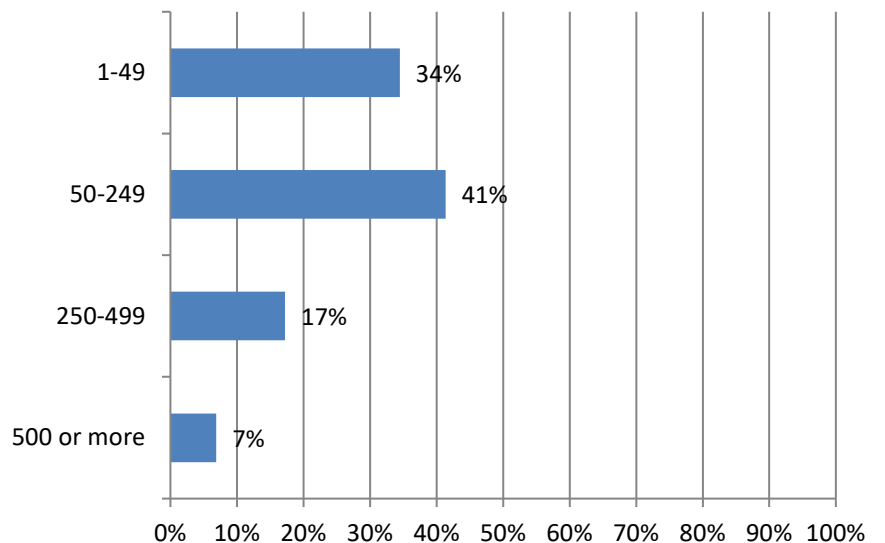

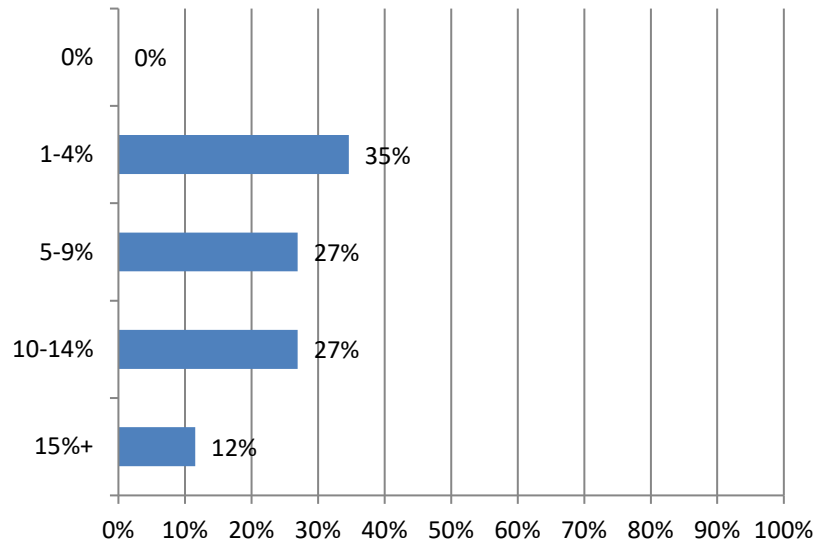

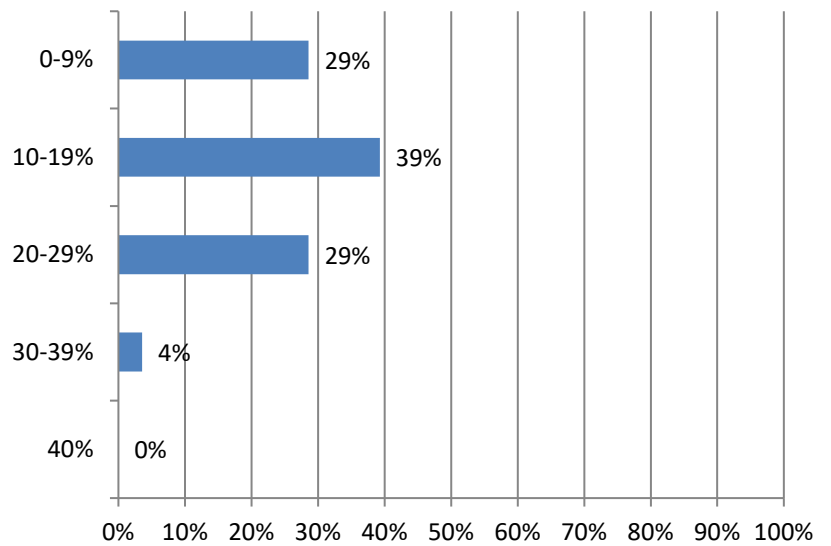

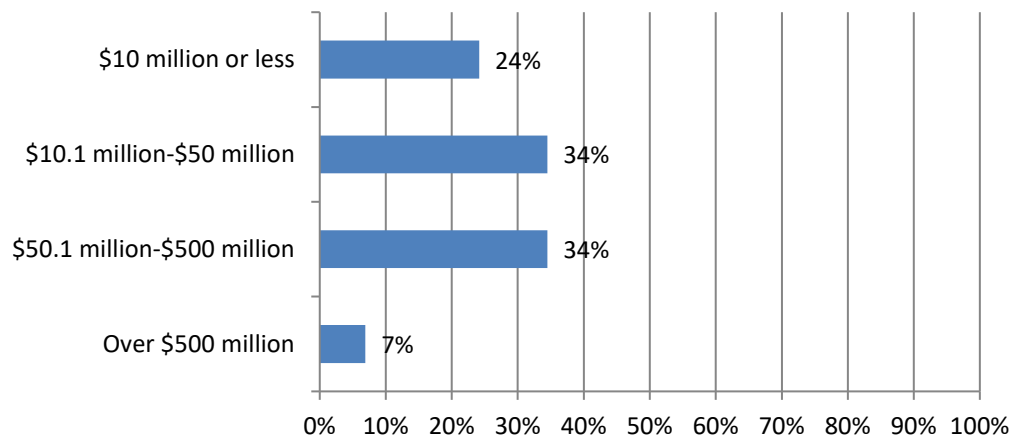

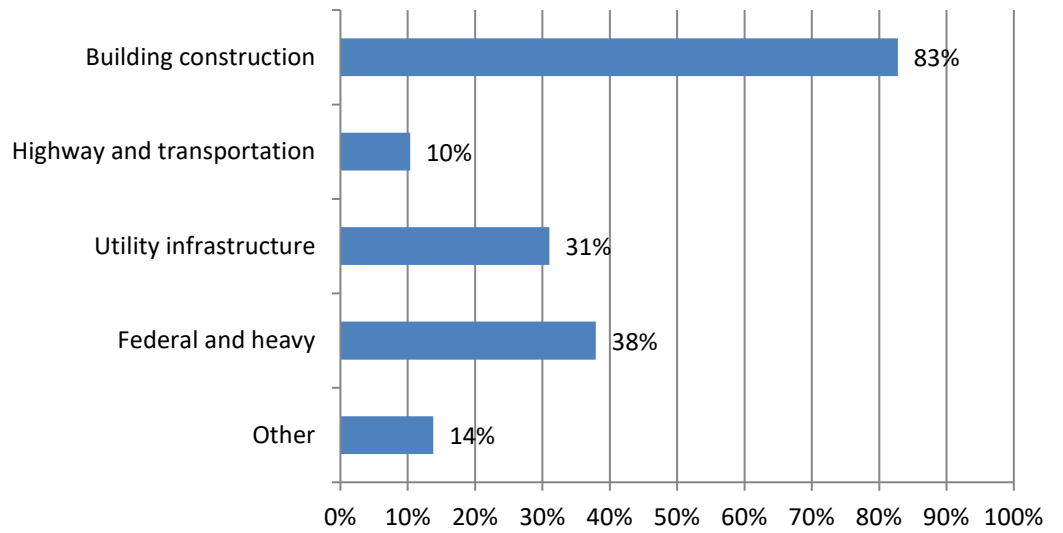
