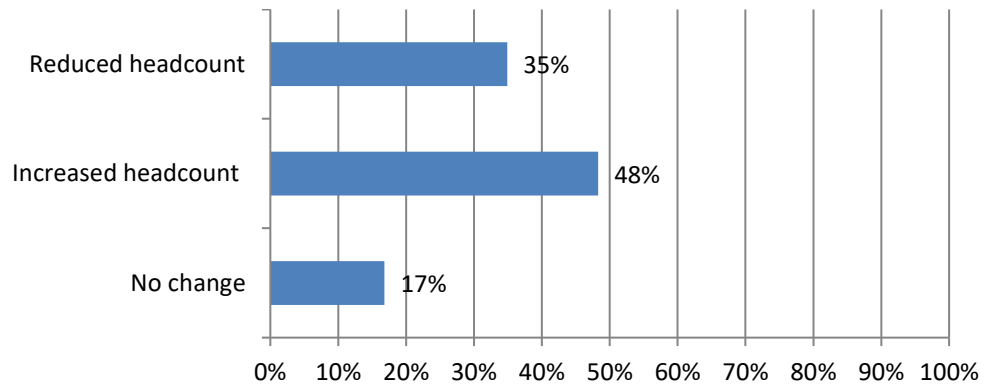

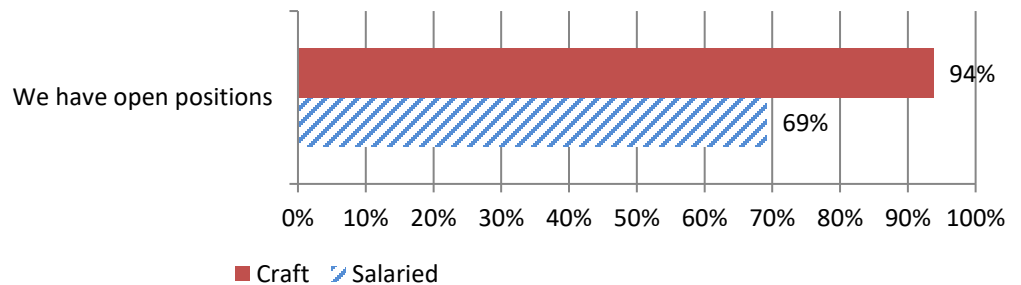

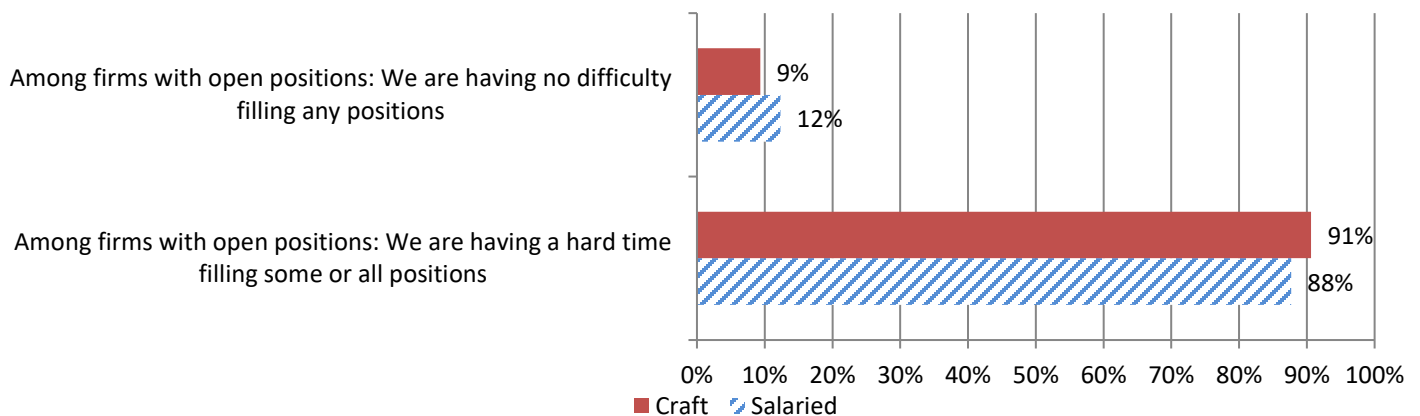
1. By what percentage has your firm's headcount changed in the past 12 months? Responses: 321



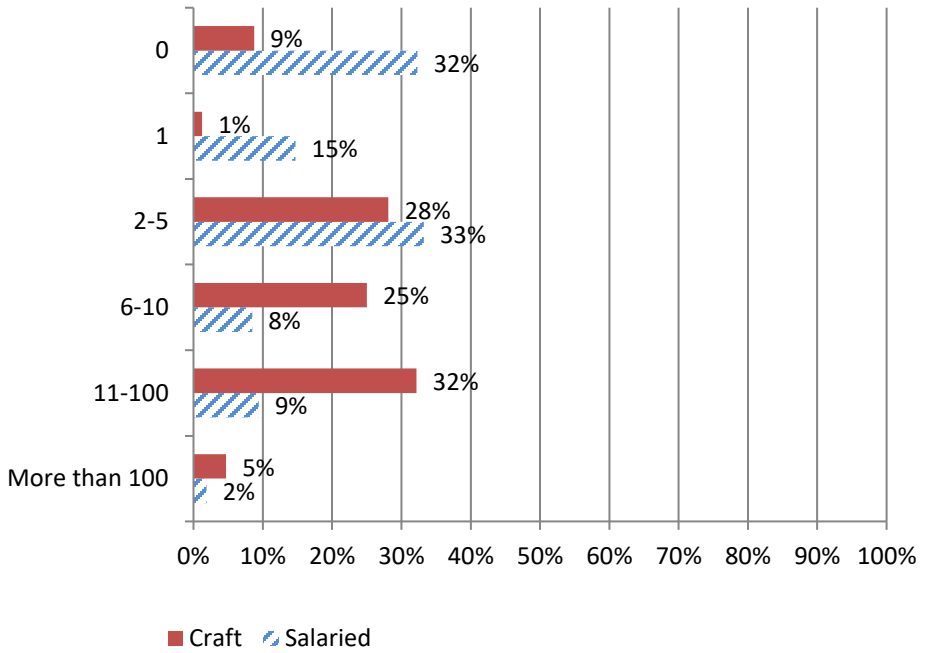
2. How would you describe your current situation in filling hourly craft or salaried positions? Responses: 317 Salaried; 319 Craft



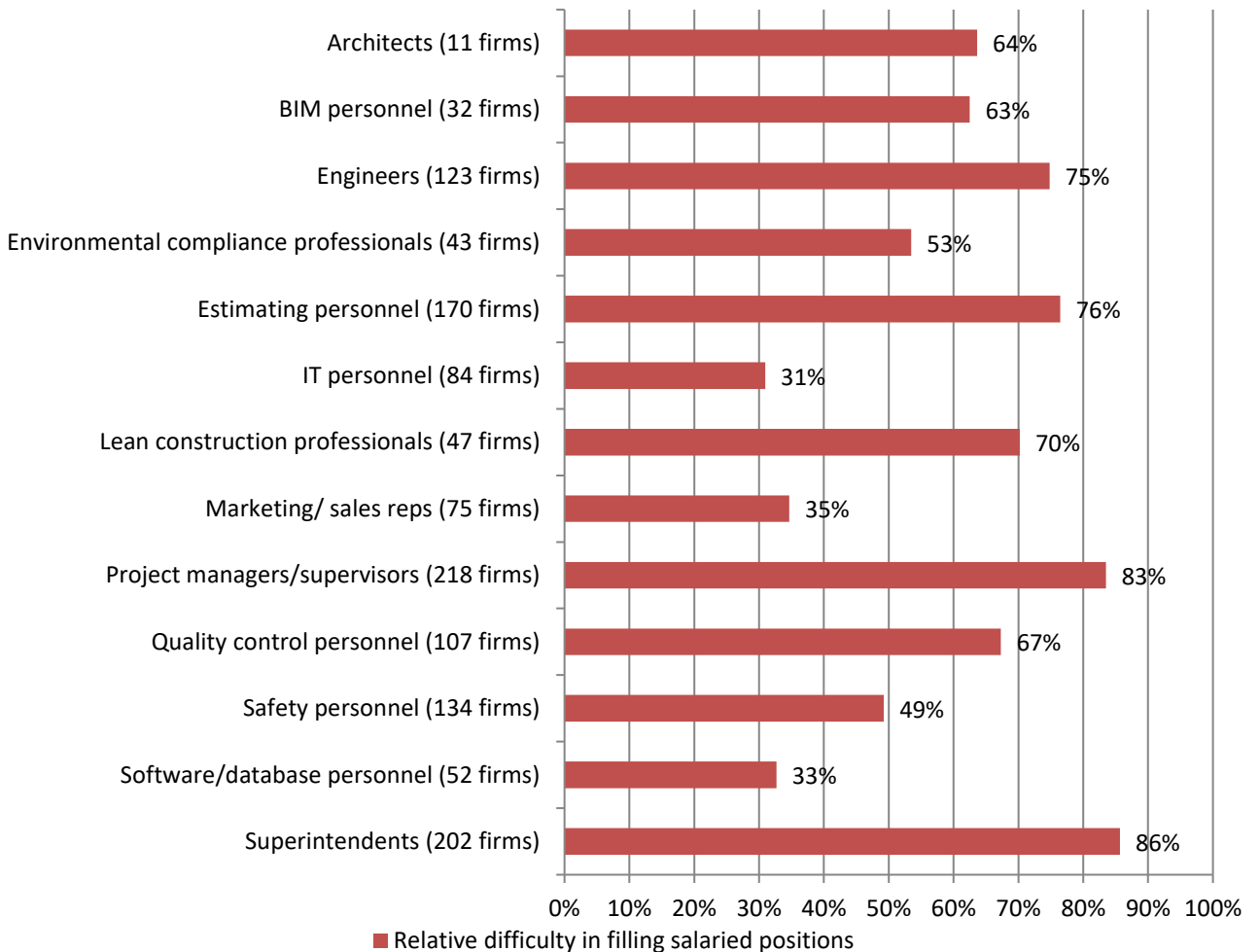
3. Describe your difficulty in filling open positions: Responses: 317 Salaried; 319 Craft



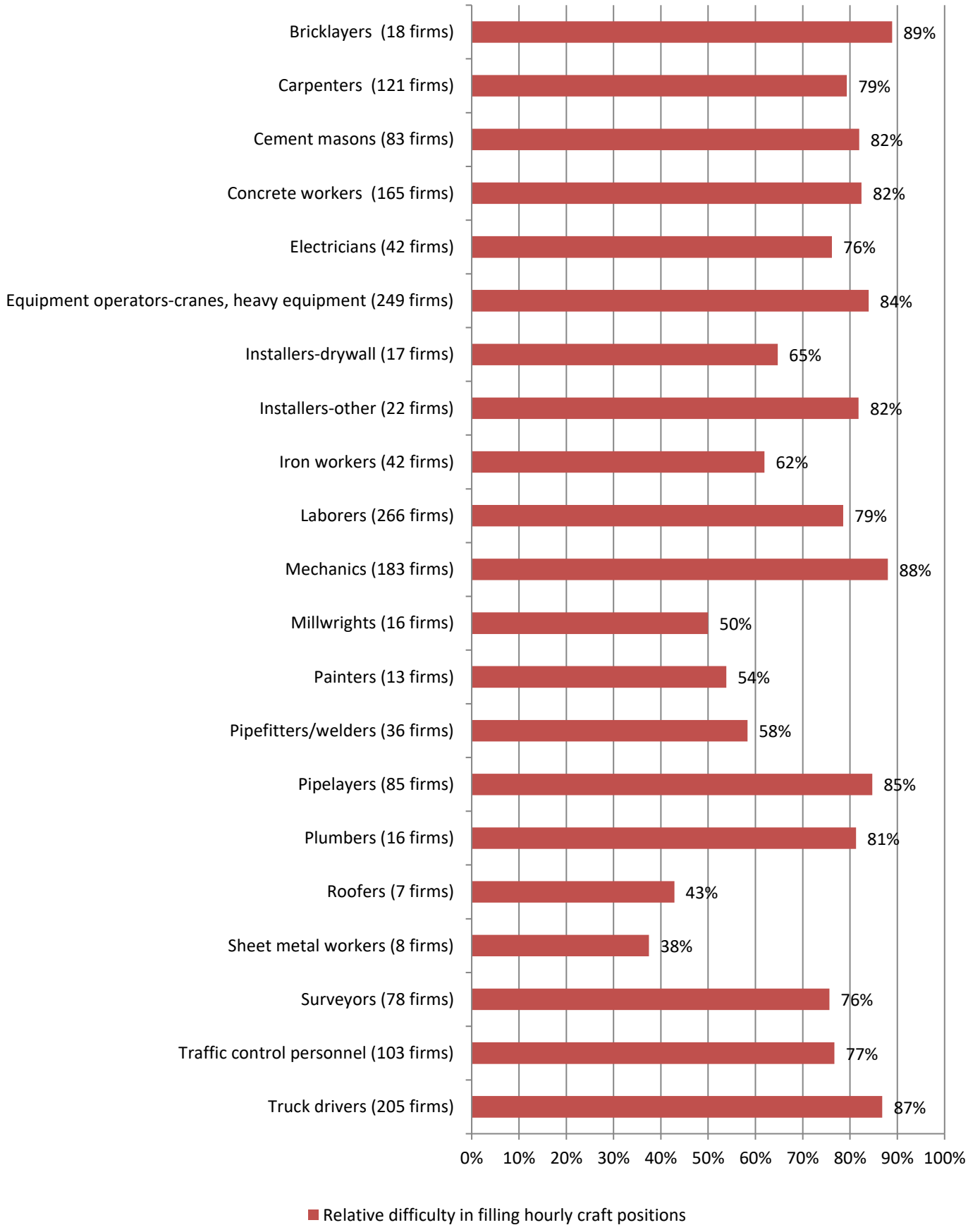
4. How many unfilled hourly craft or salaried positions did you have on June 30, 2023? Responses: 319 Salaried; 320 Craft



5. If your firm is having trouble filling salaried positions, please indicate all the position types you are having trouble filling (Mark all that apply): 308

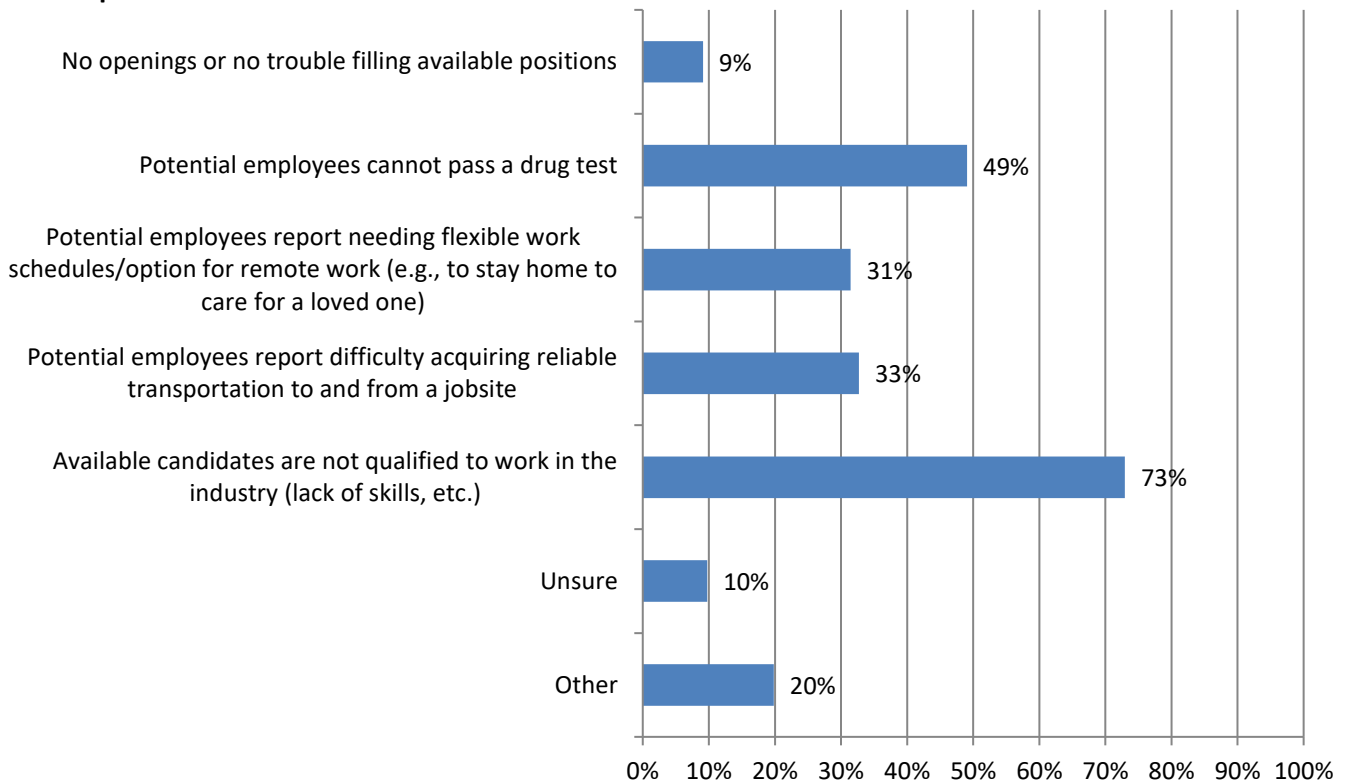

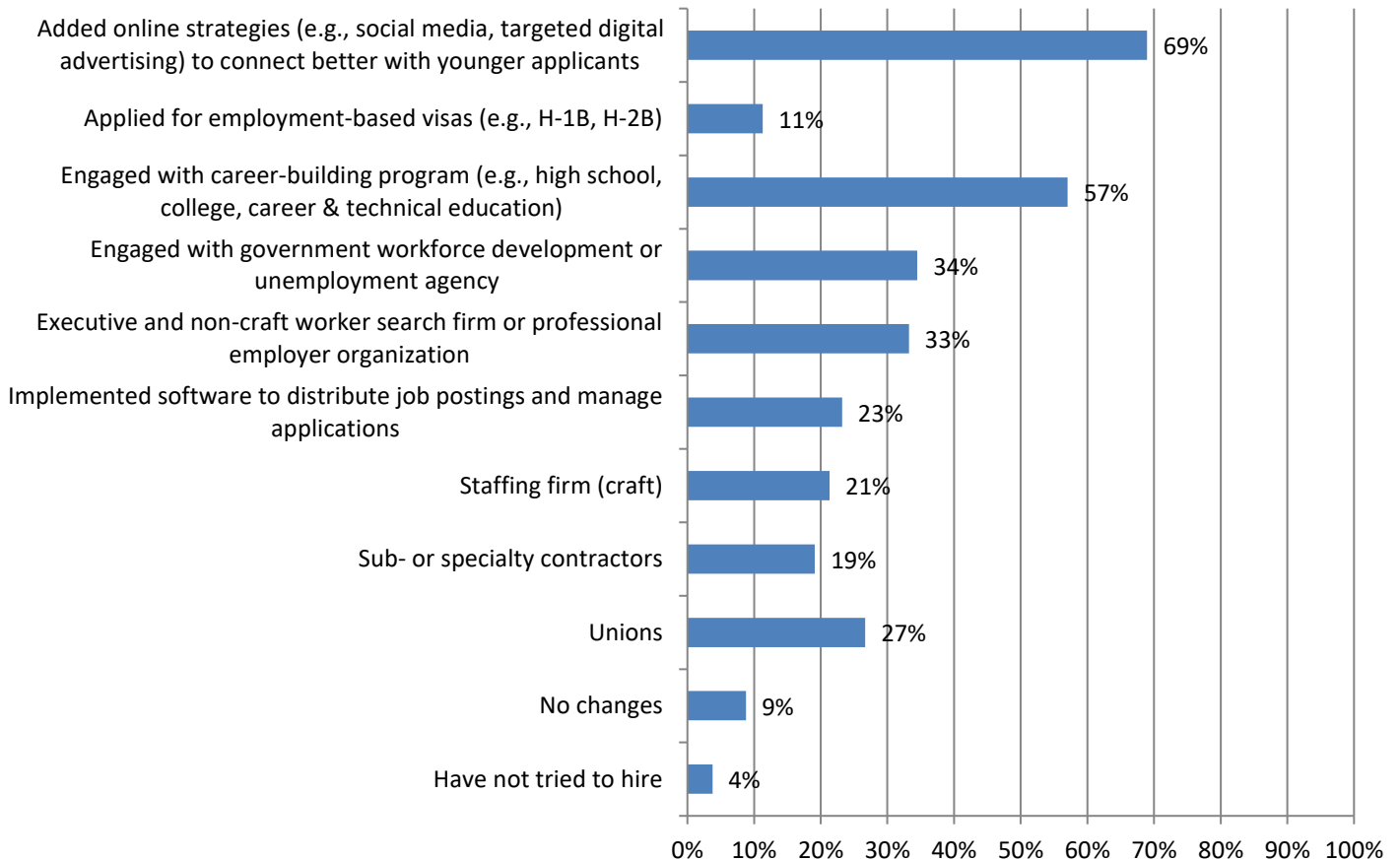

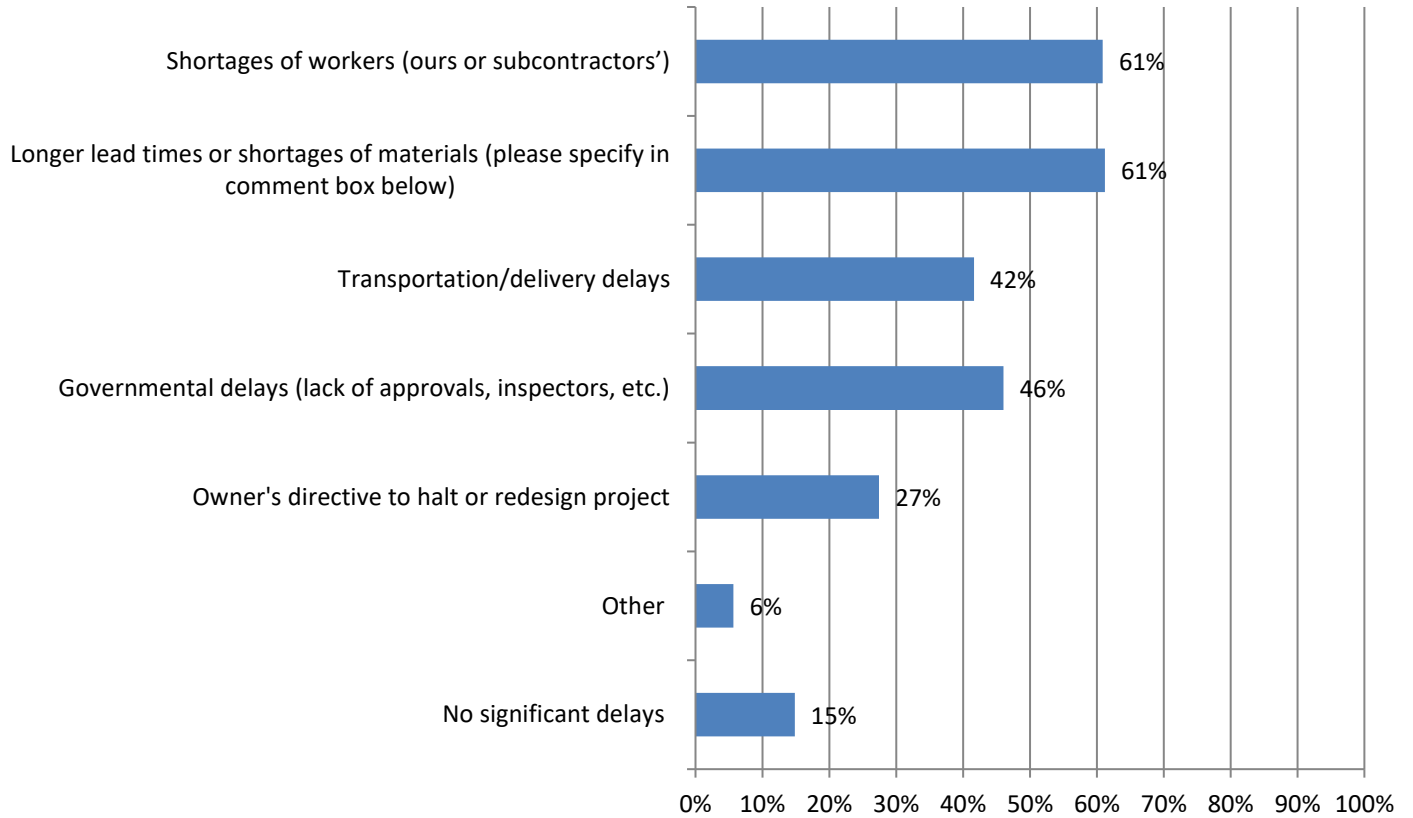

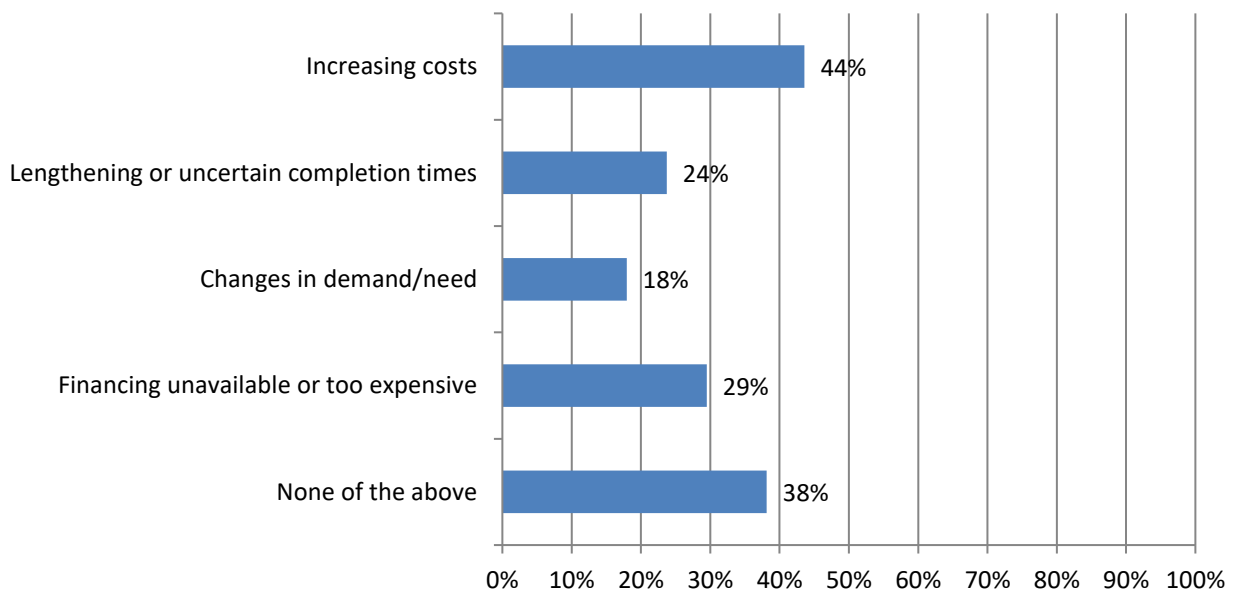

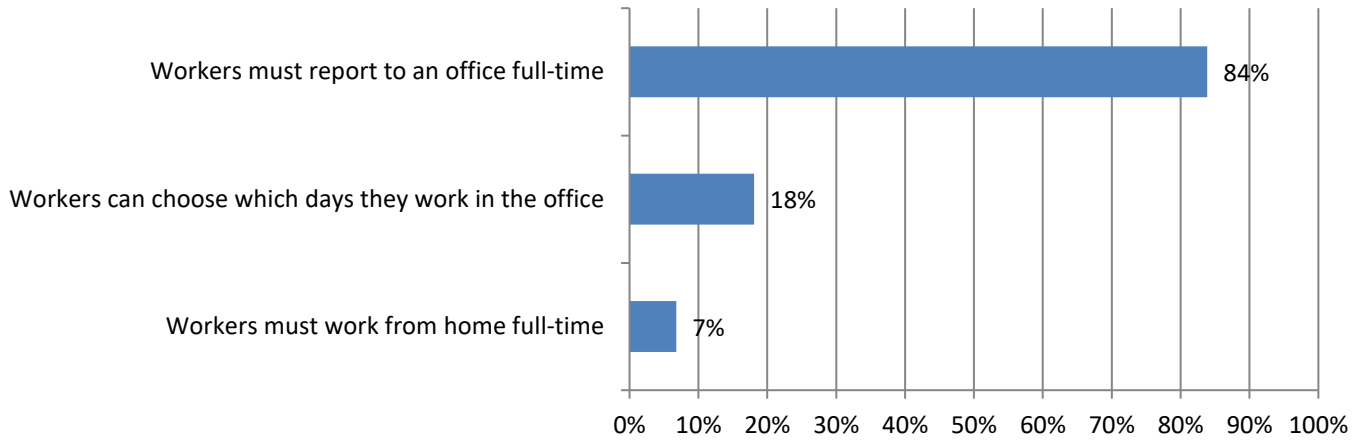

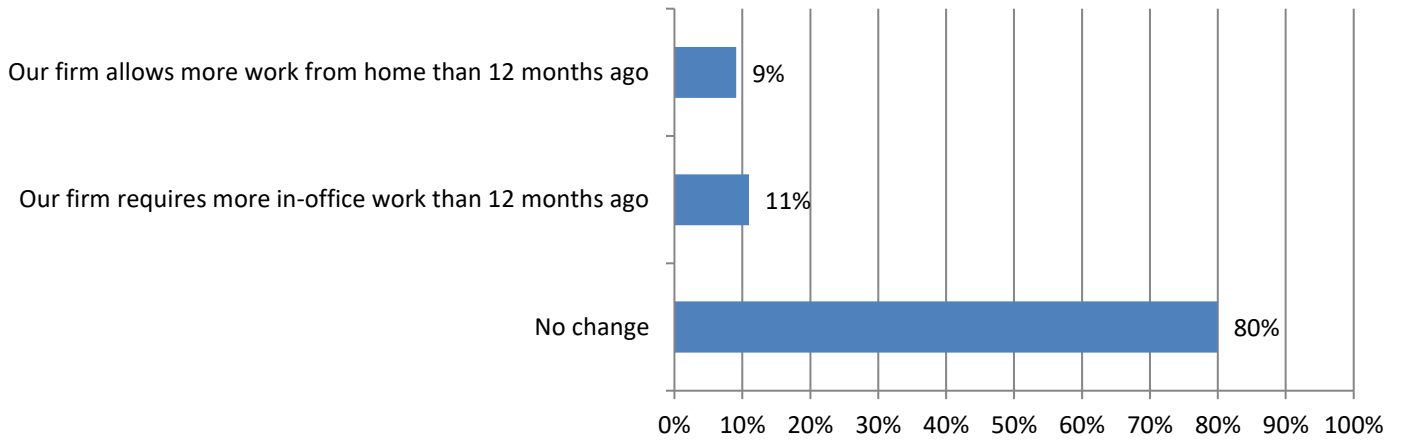

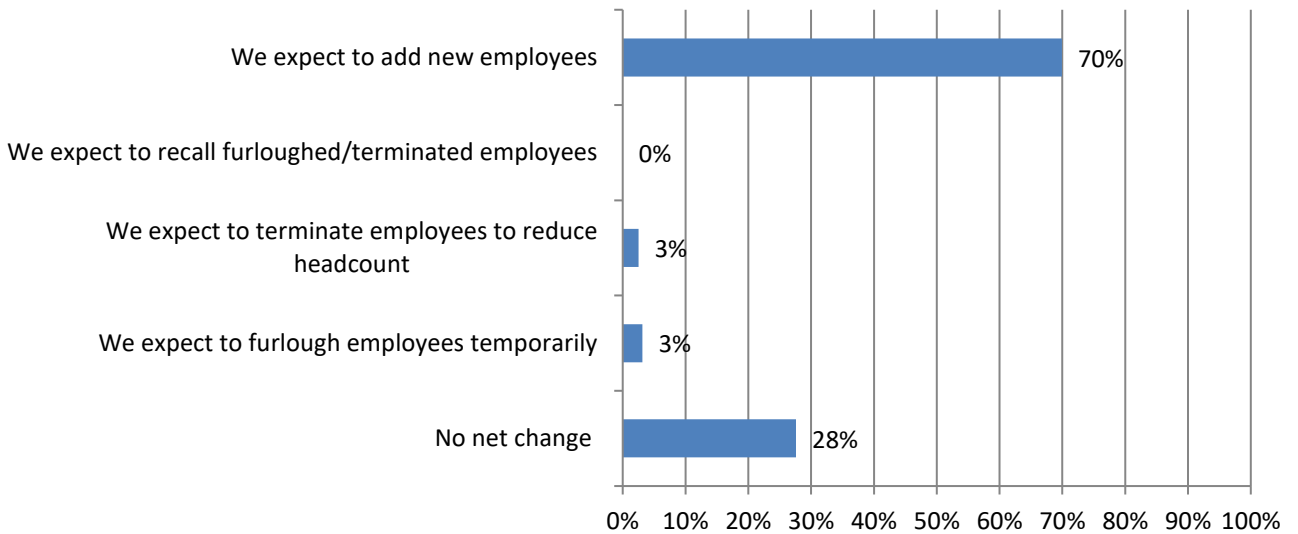

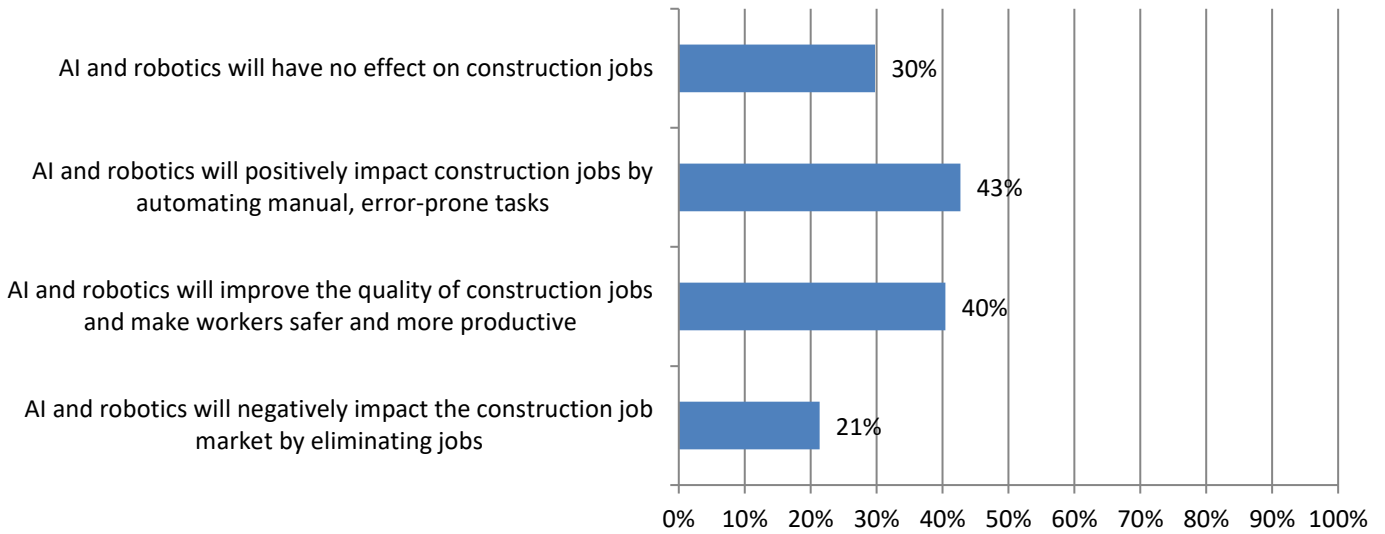

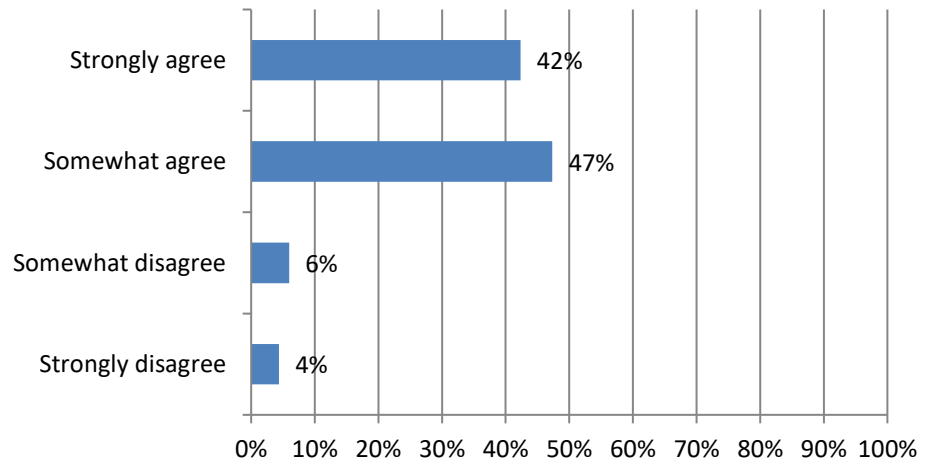

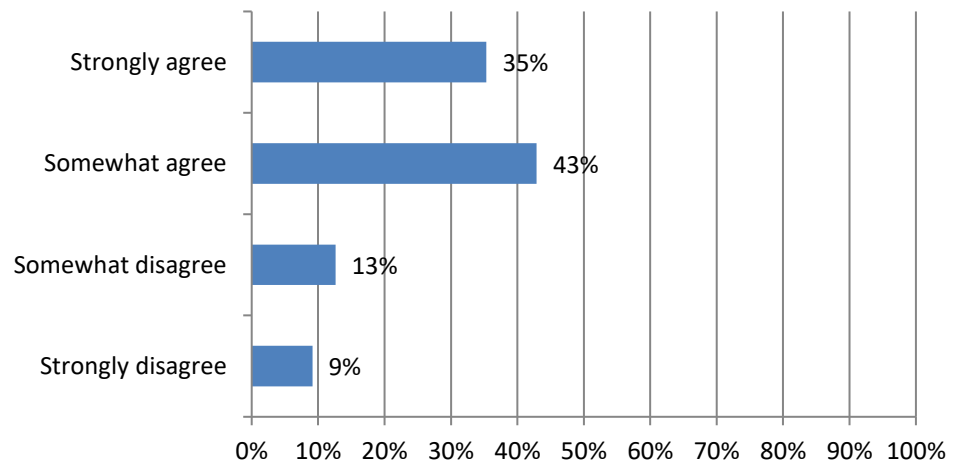

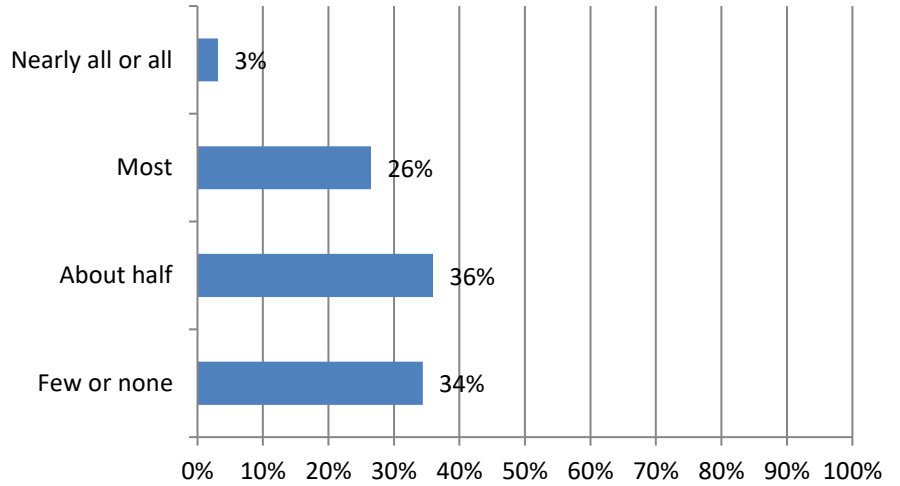

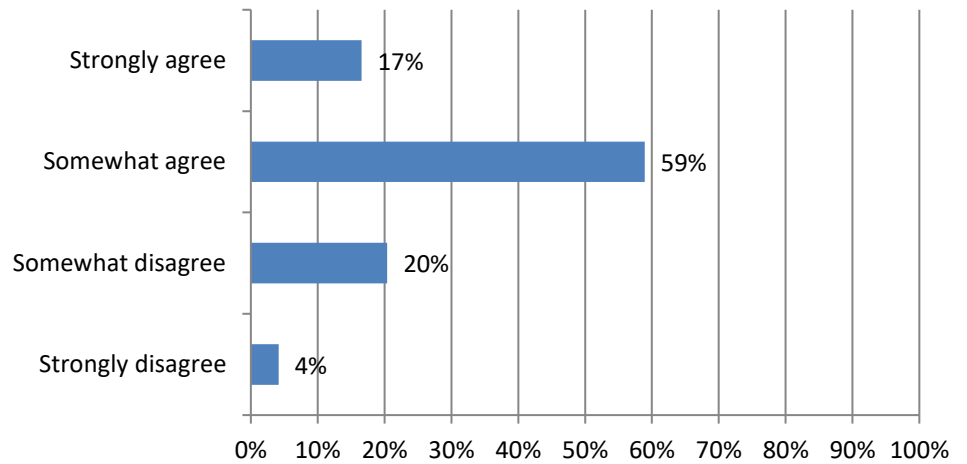

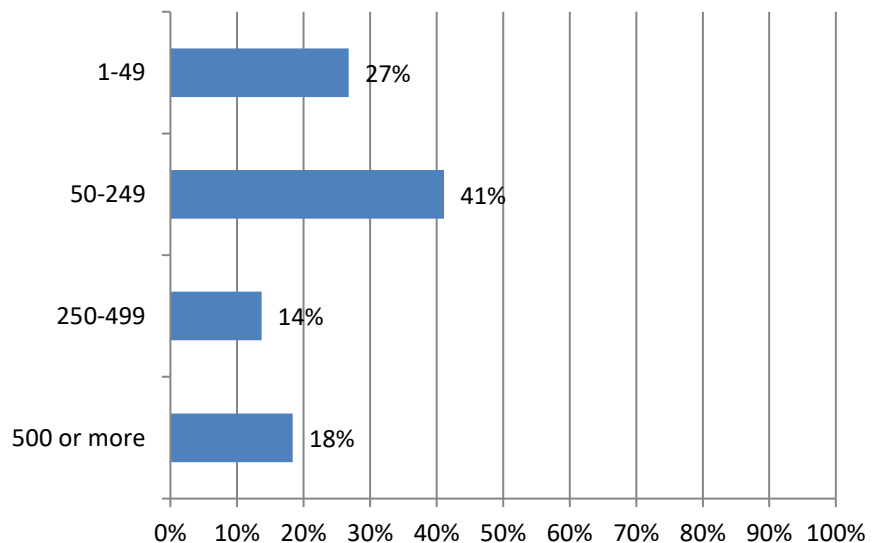

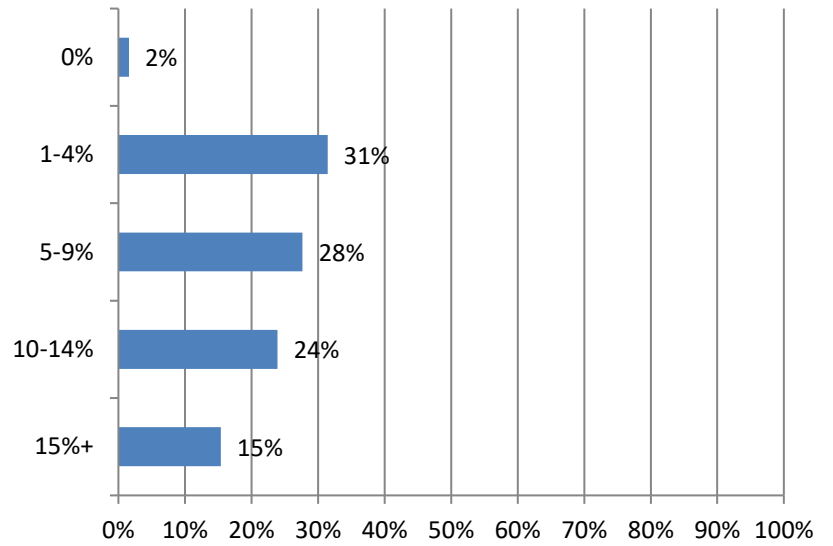

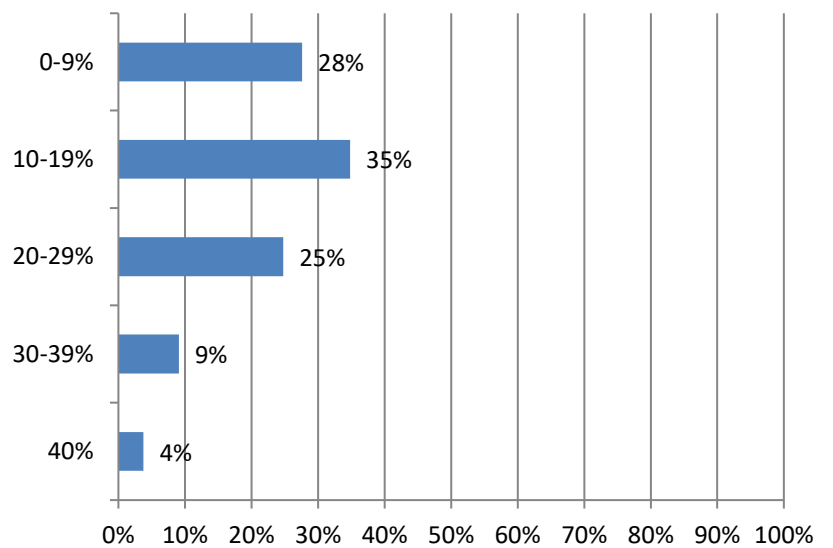

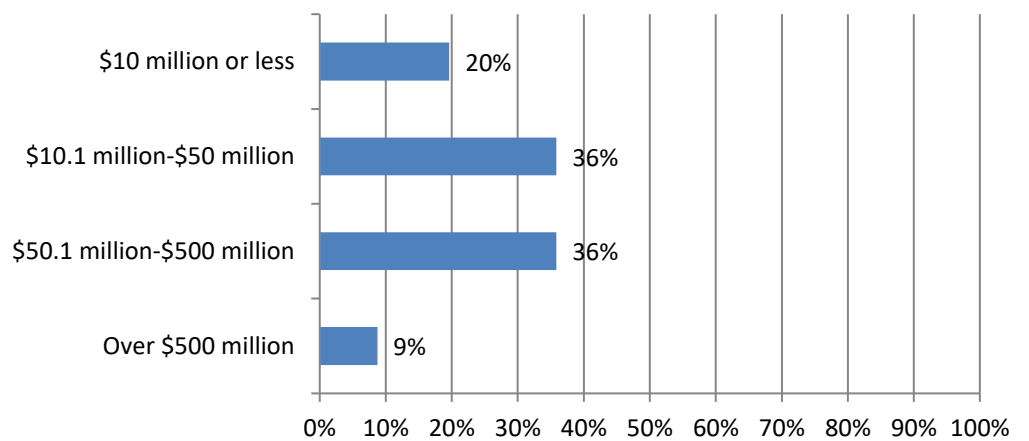

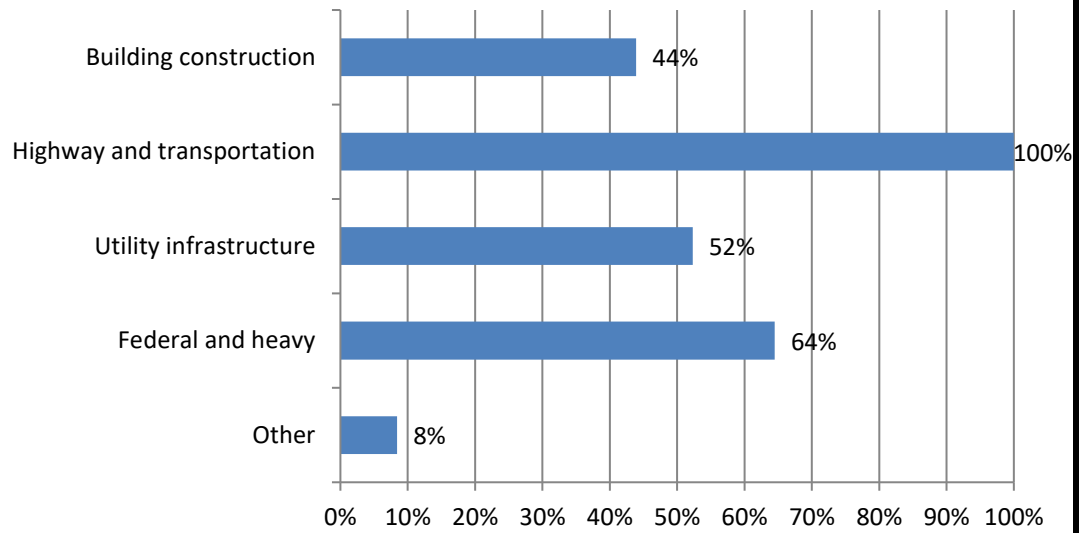
