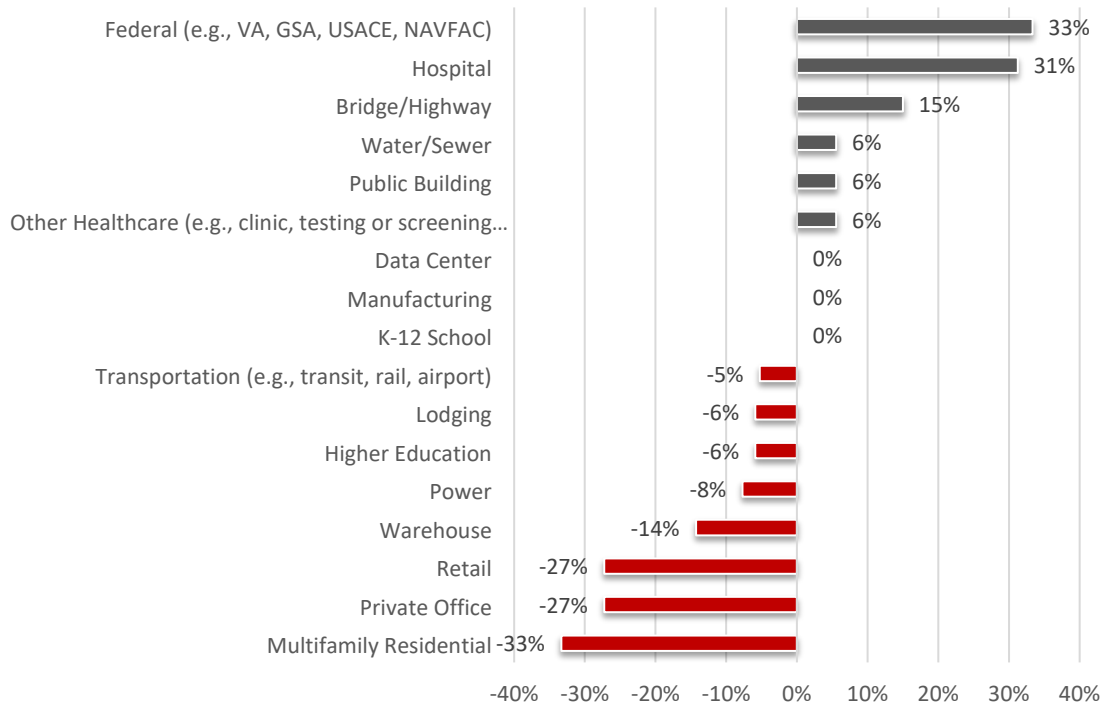

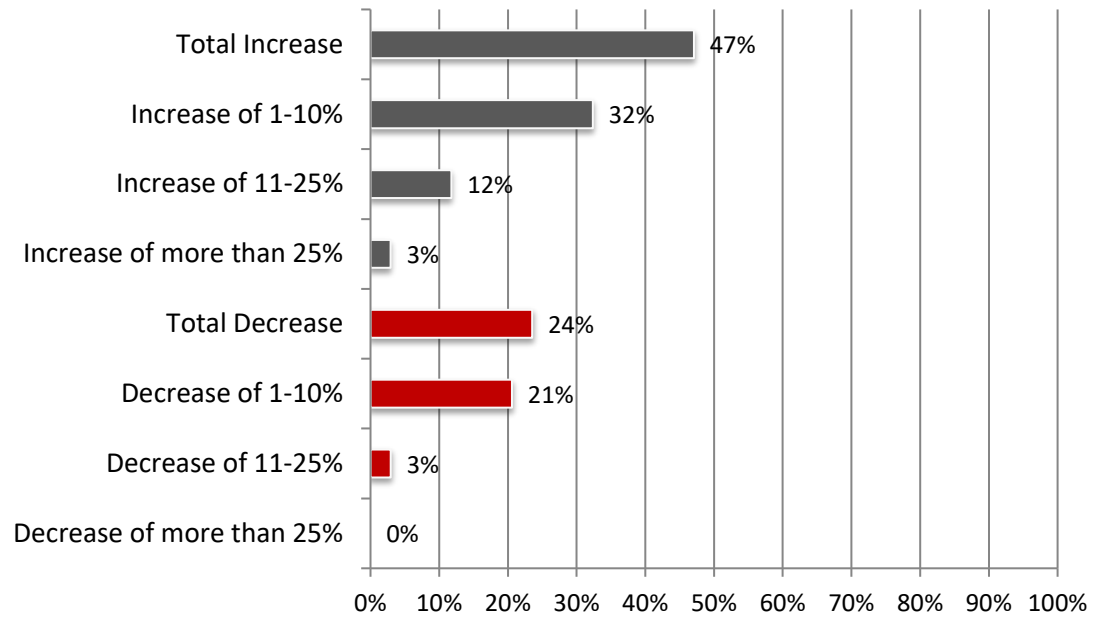

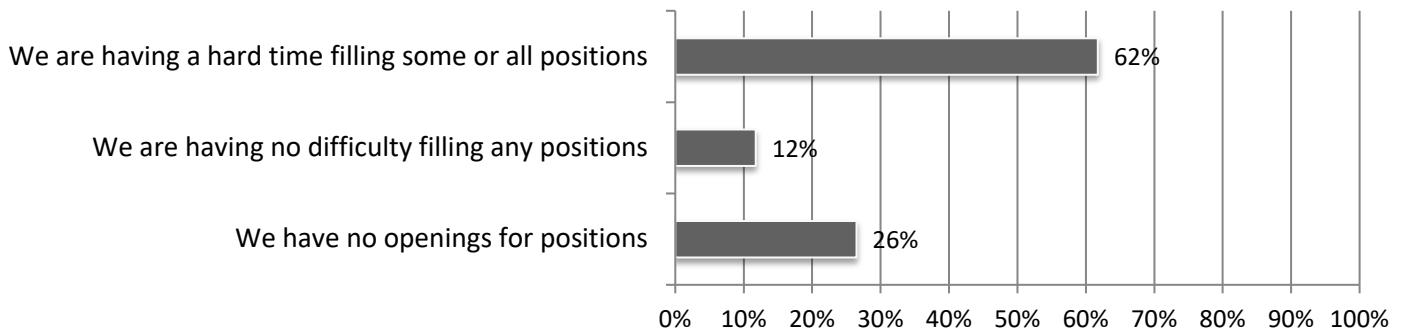

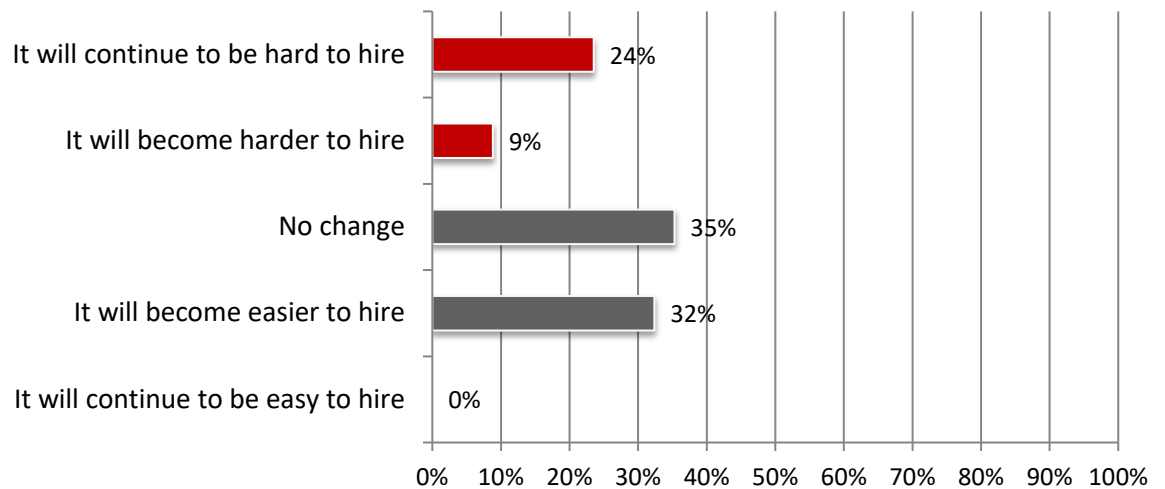

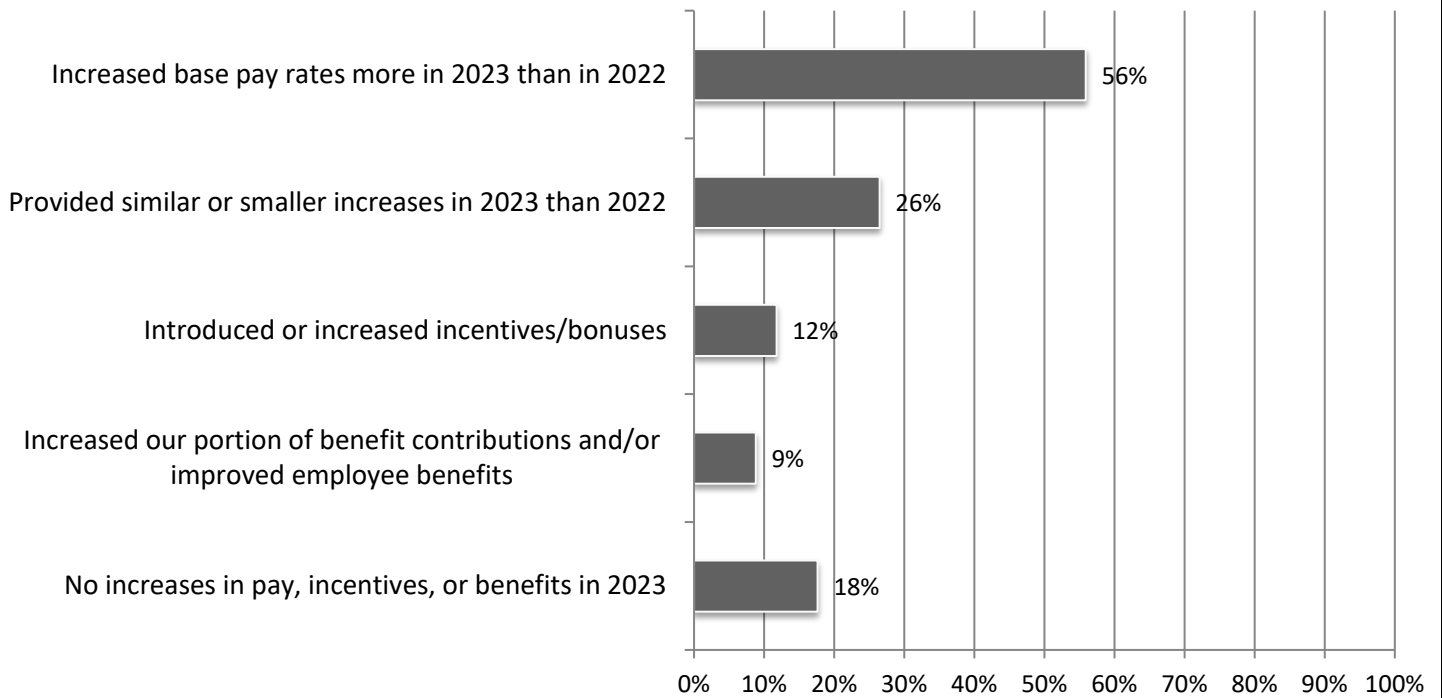
3. How would you describe your current situation in filling salaried and hourly craft positions? Responses: 34



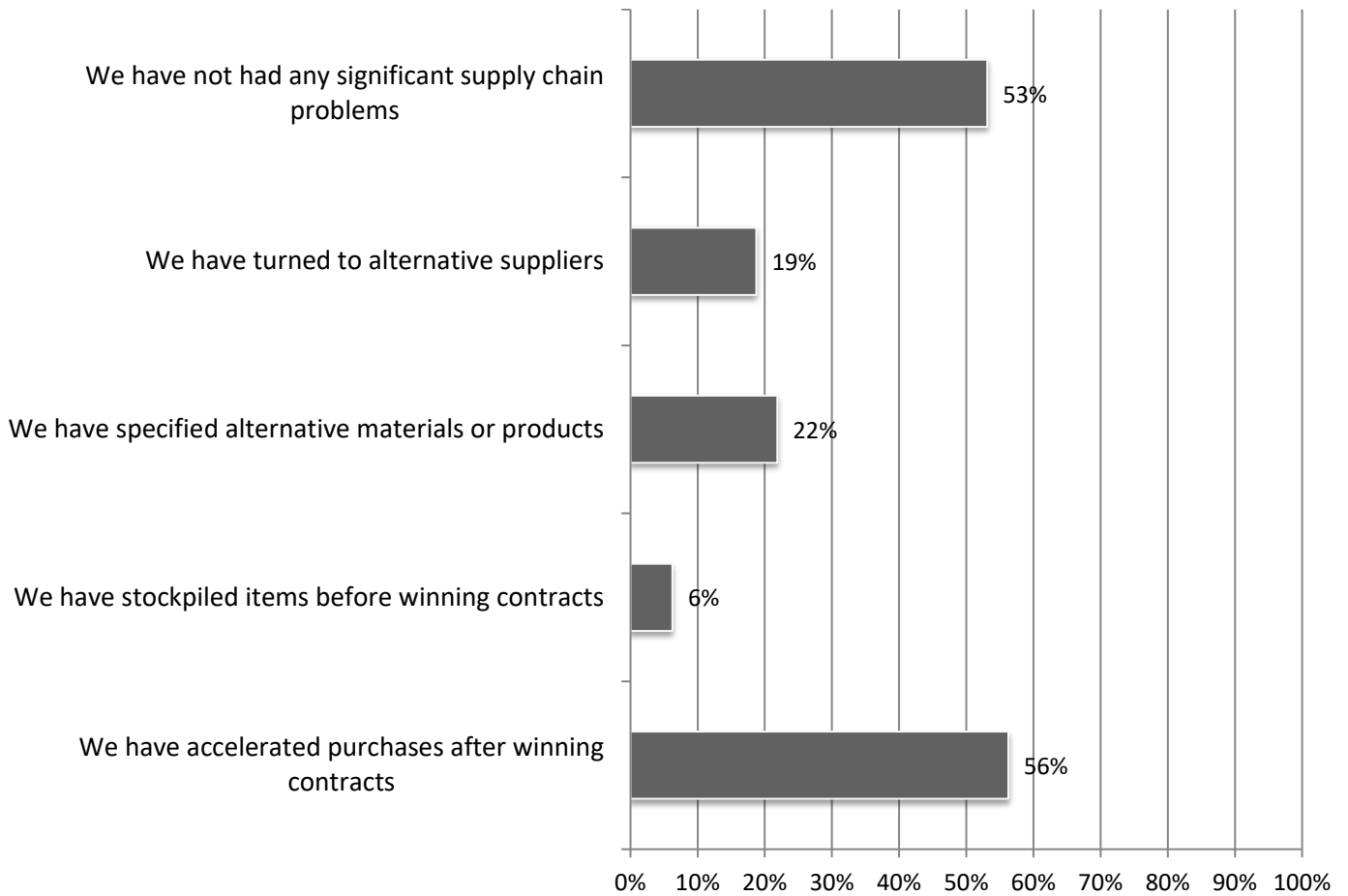
4. Do you expect any changes in the availability of hourly craft or salaried personnel over the coming 12 months? Responses: 34



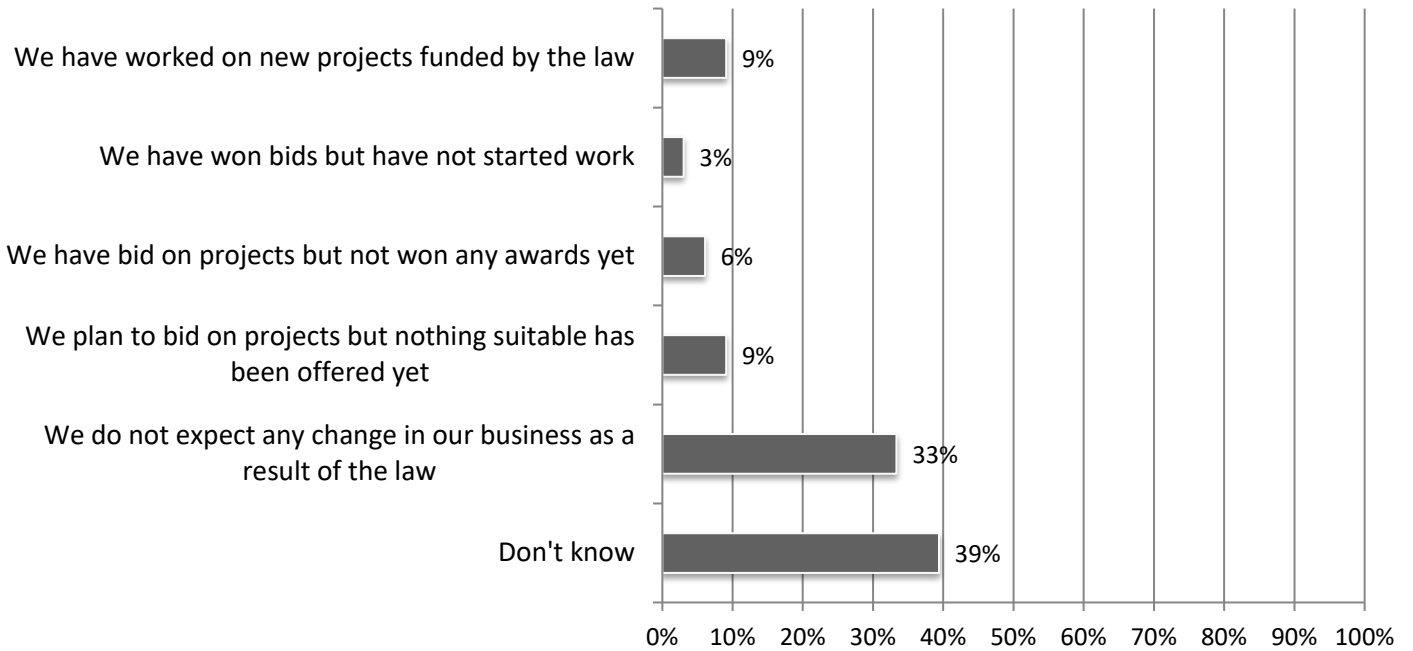
5. What changes did your firm make in pay or benefits in 2023? (mark all that apply) Responses: 34



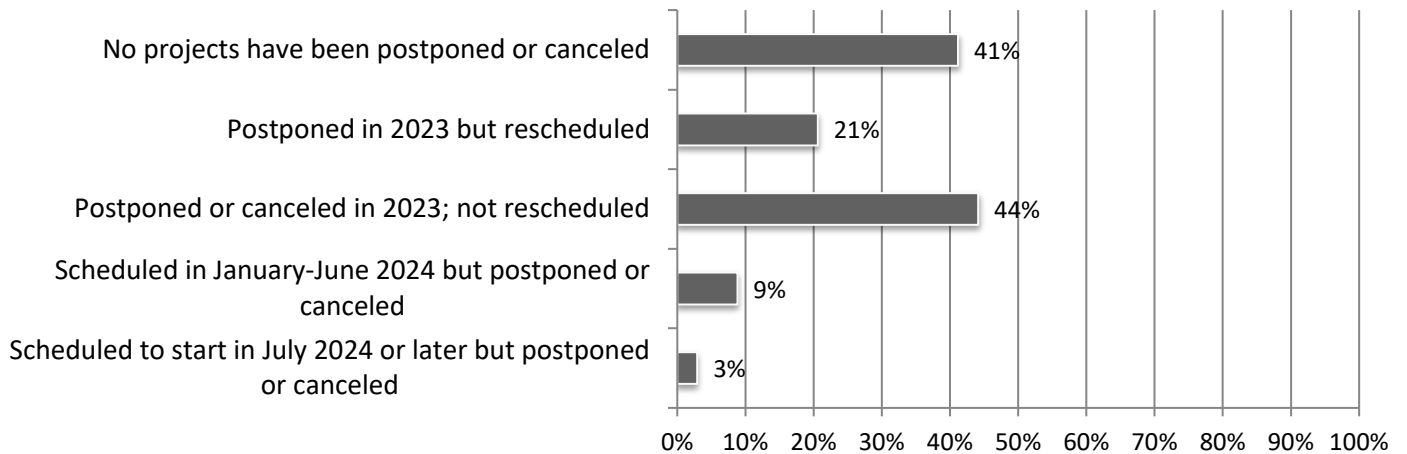
6. How has your firm responded to supply-chain issues, if any? (mark all that apply) Responses: 32



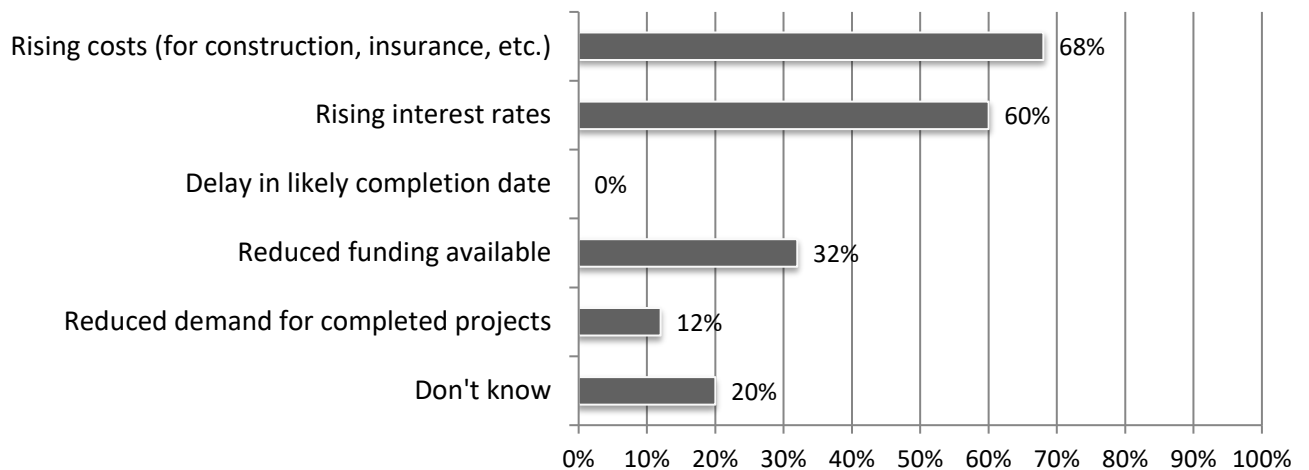
7. What difference, if any, has the Infrastructure Investment and Jobs Act (also known as the Bipartisan Infrastructure Law), made to your business? Responses: 33



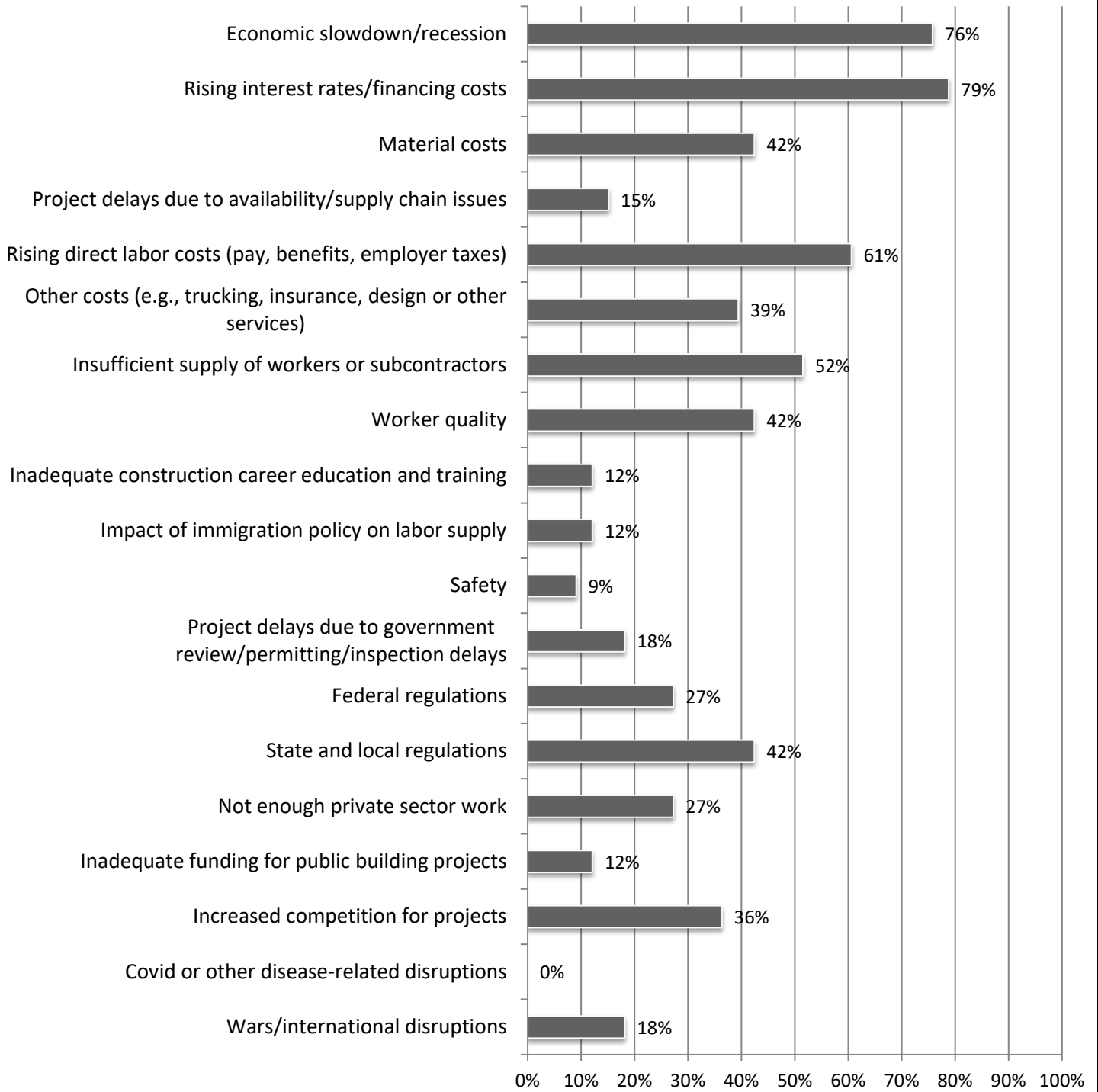

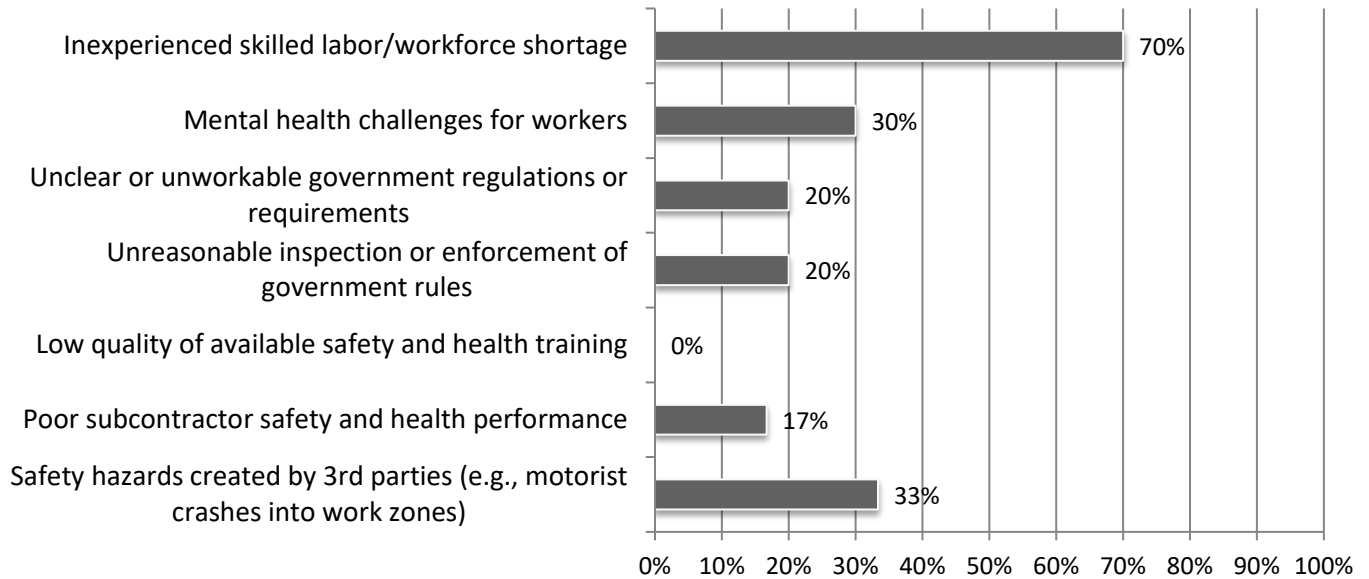

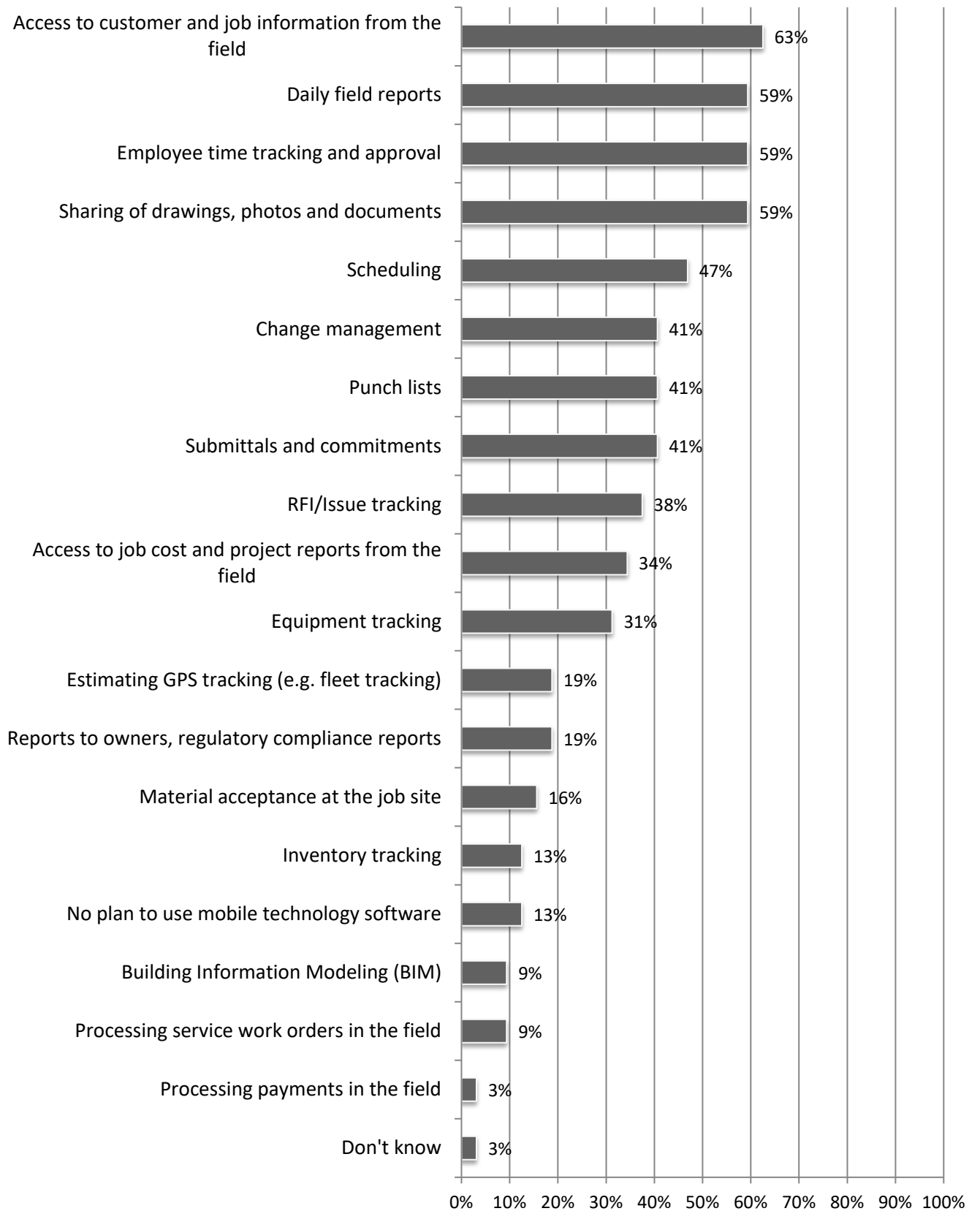
