




2024 Construction Outlook Pennsylvania Survey Results










3. How would you describe your current situation in filling salaried and hourly craft positions? Responses: 22




4. Do you expect any changes in the availability of hourly craft or salaried personnel over the coming 12 months? Responses: 22







6. How has your firm responded to supply-chain issues, if any? (mark all that apply) Responses: 22




7. What difference, if any, has the Infrastructure Investment and Jobs Act (also known as the Bipartisan Infrastructure Law), made to your business? Responses: 22




8. Did an owner postpone or cancel any projects that were scheduled to start in 2023 or 2024? (mark all that apply) Responses: 22




