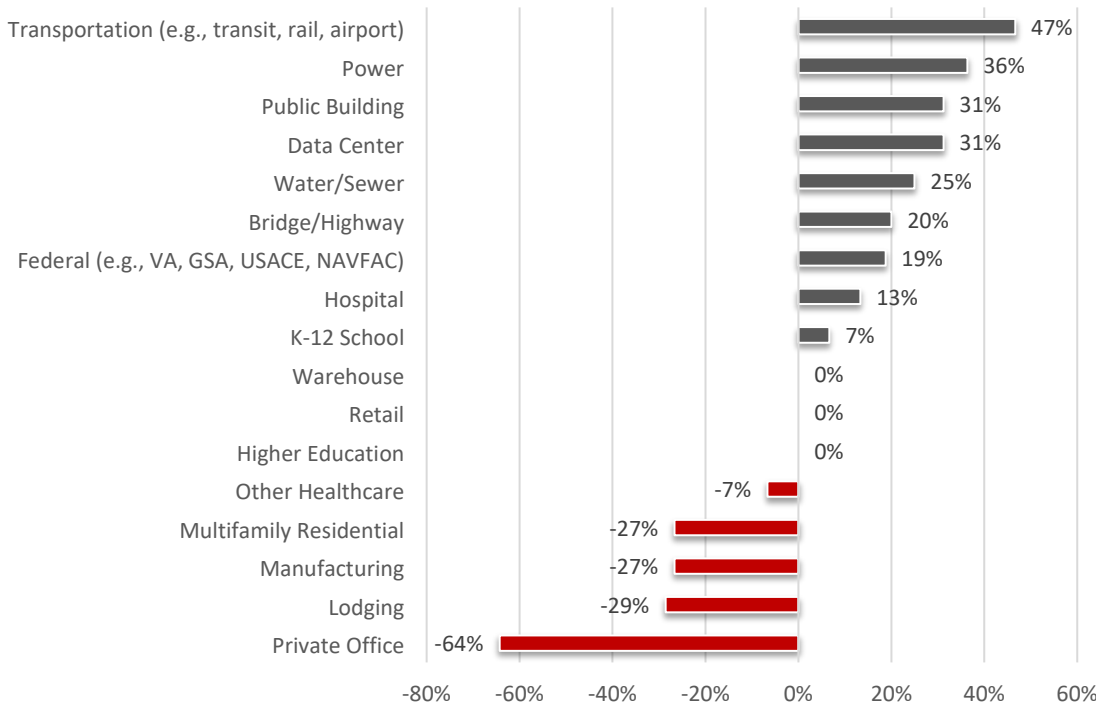

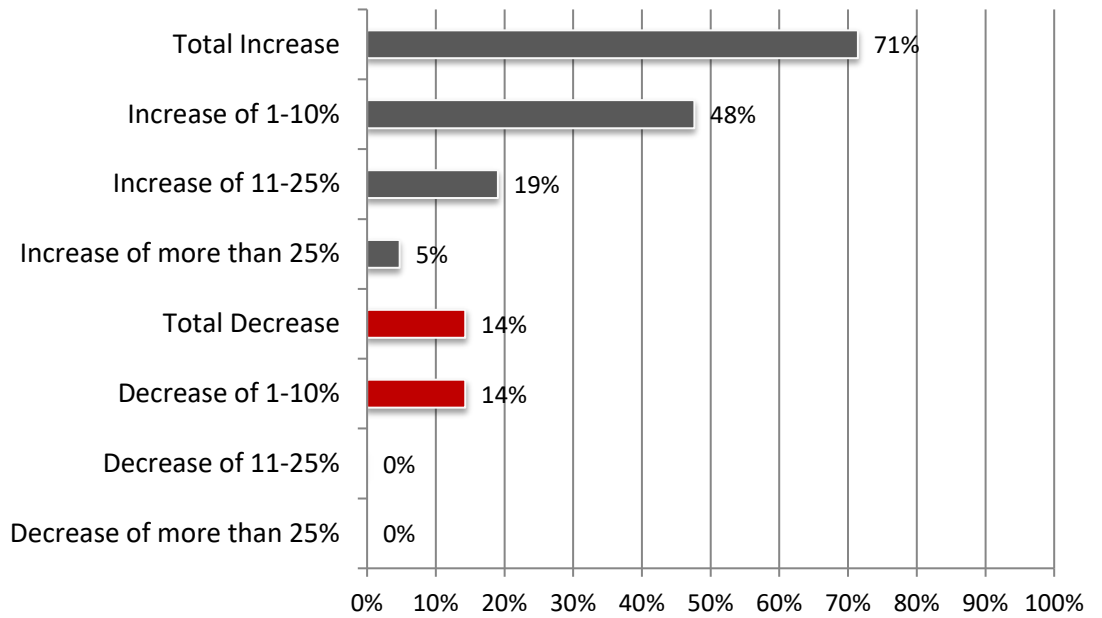

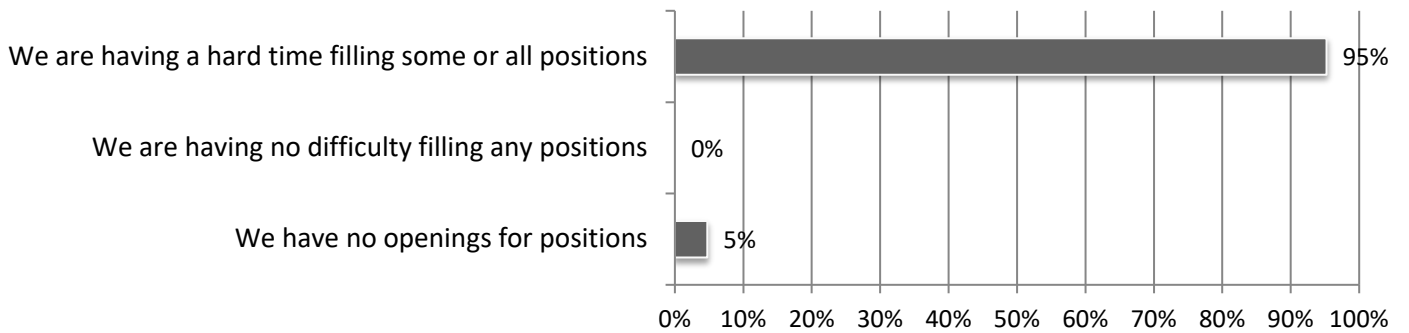

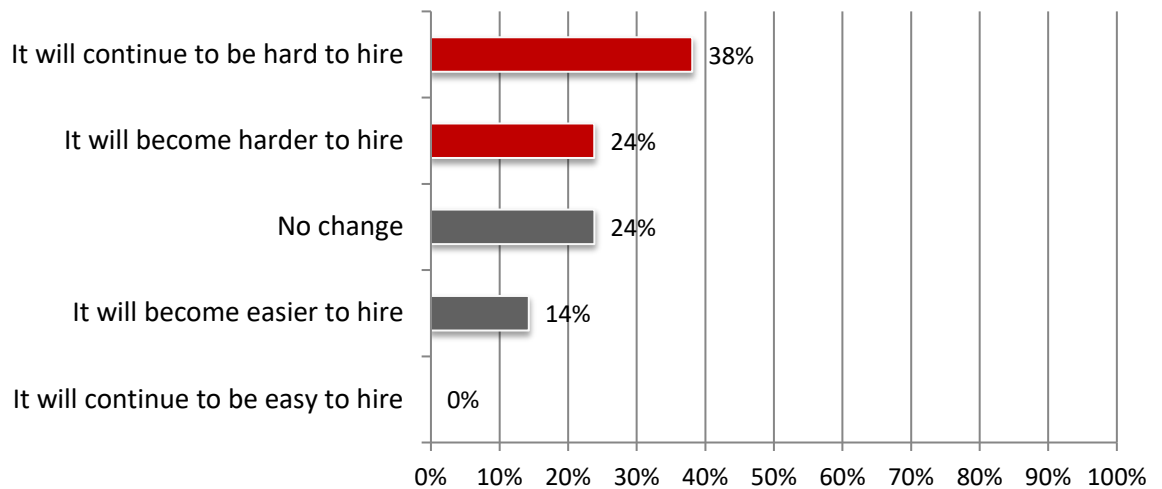
**2. What percentage change do you expect in your headcount in 2024? Responses: 21**



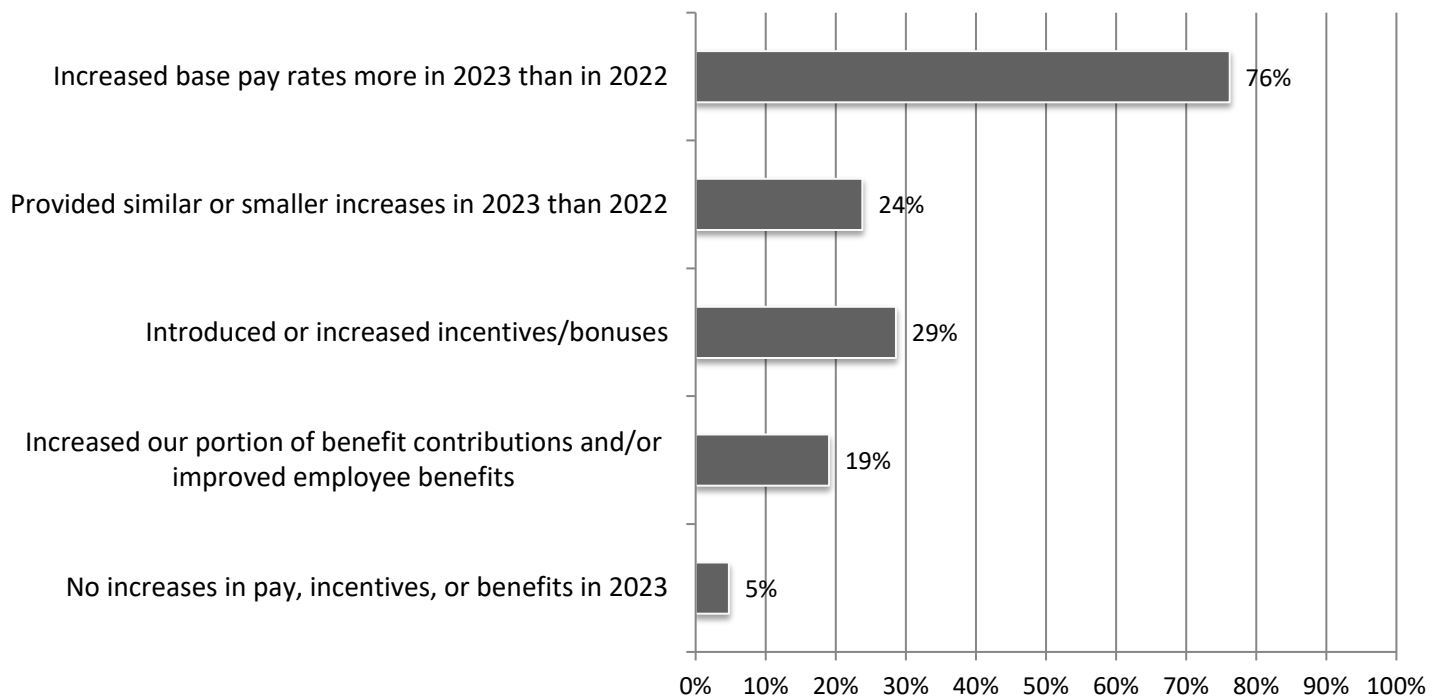
**3. How would you describe your current situation in filling salaried and hourly craft positions? Responses: 21**



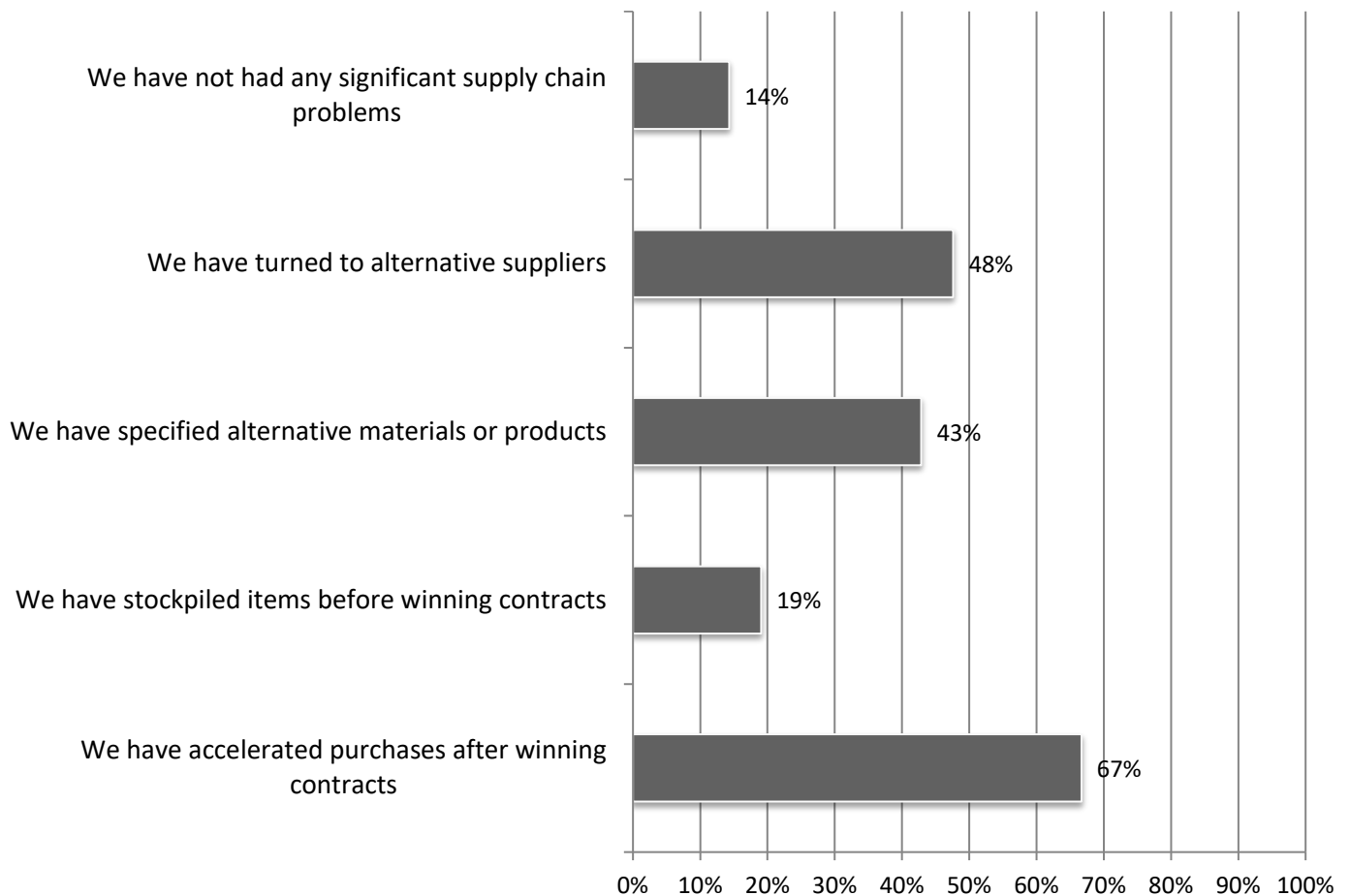
**4. Do you expect any changes in the availability of hourly craft or salaried personnel over the coming 12 months? Responses: 21**



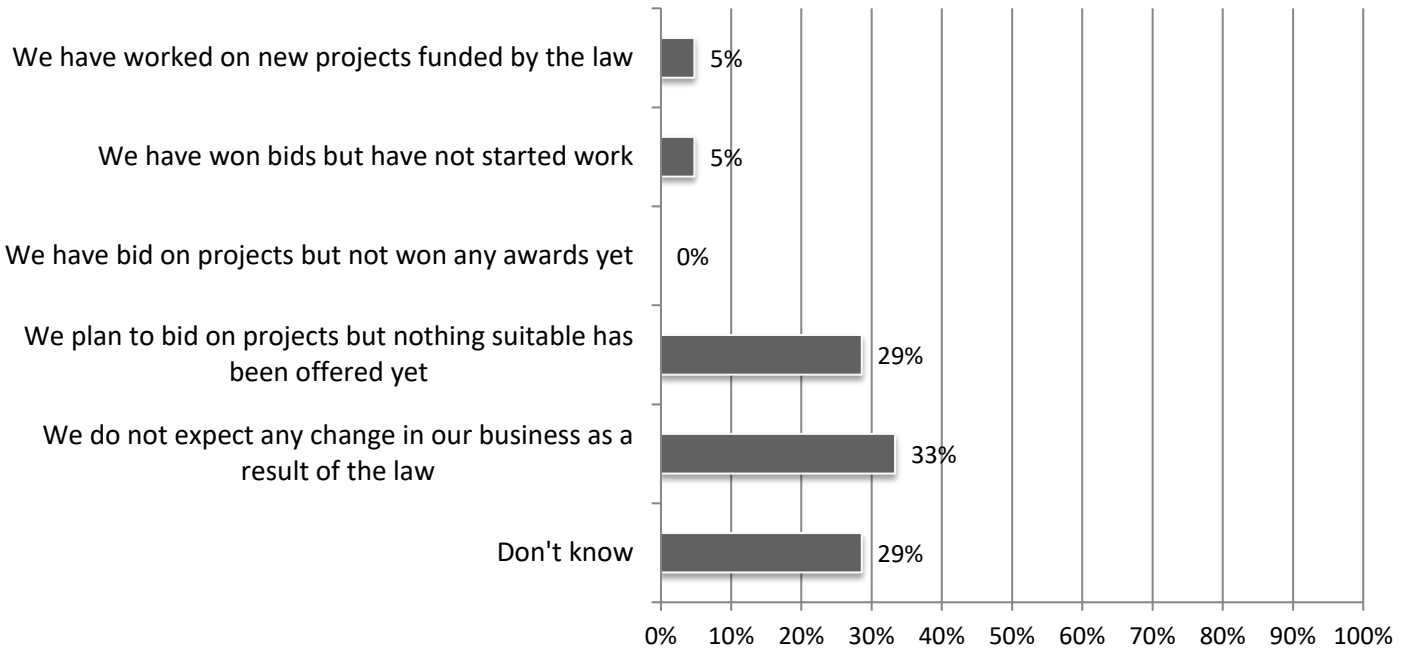
**5. What changes did your firm make in pay or benefits in 2023? (mark all that apply) Responses: 21**



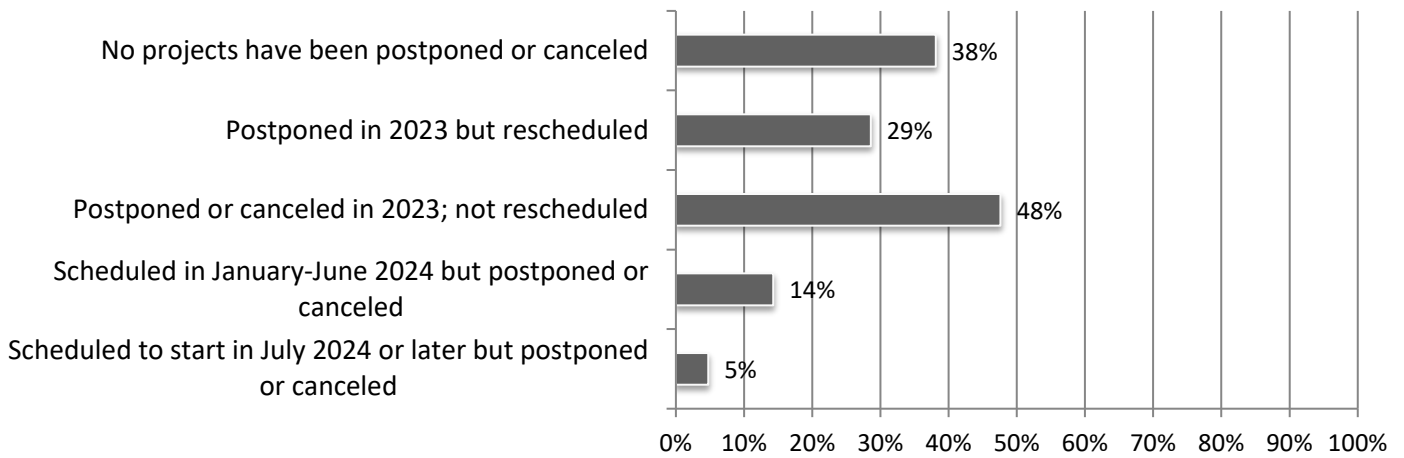
**6. How has your firm responded to supply-chain issues, if any? (mark all that apply) Responses: 21**



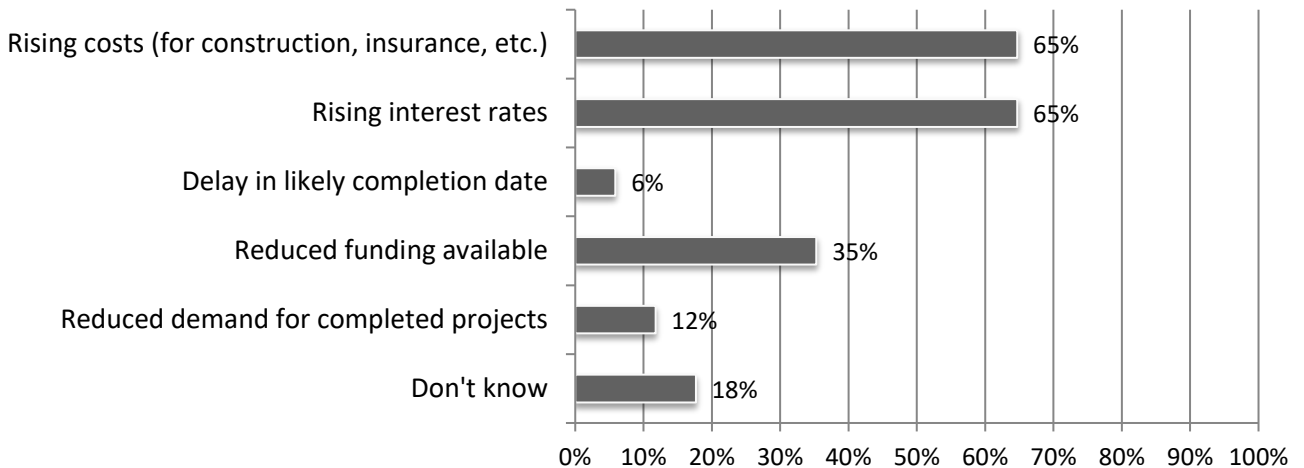

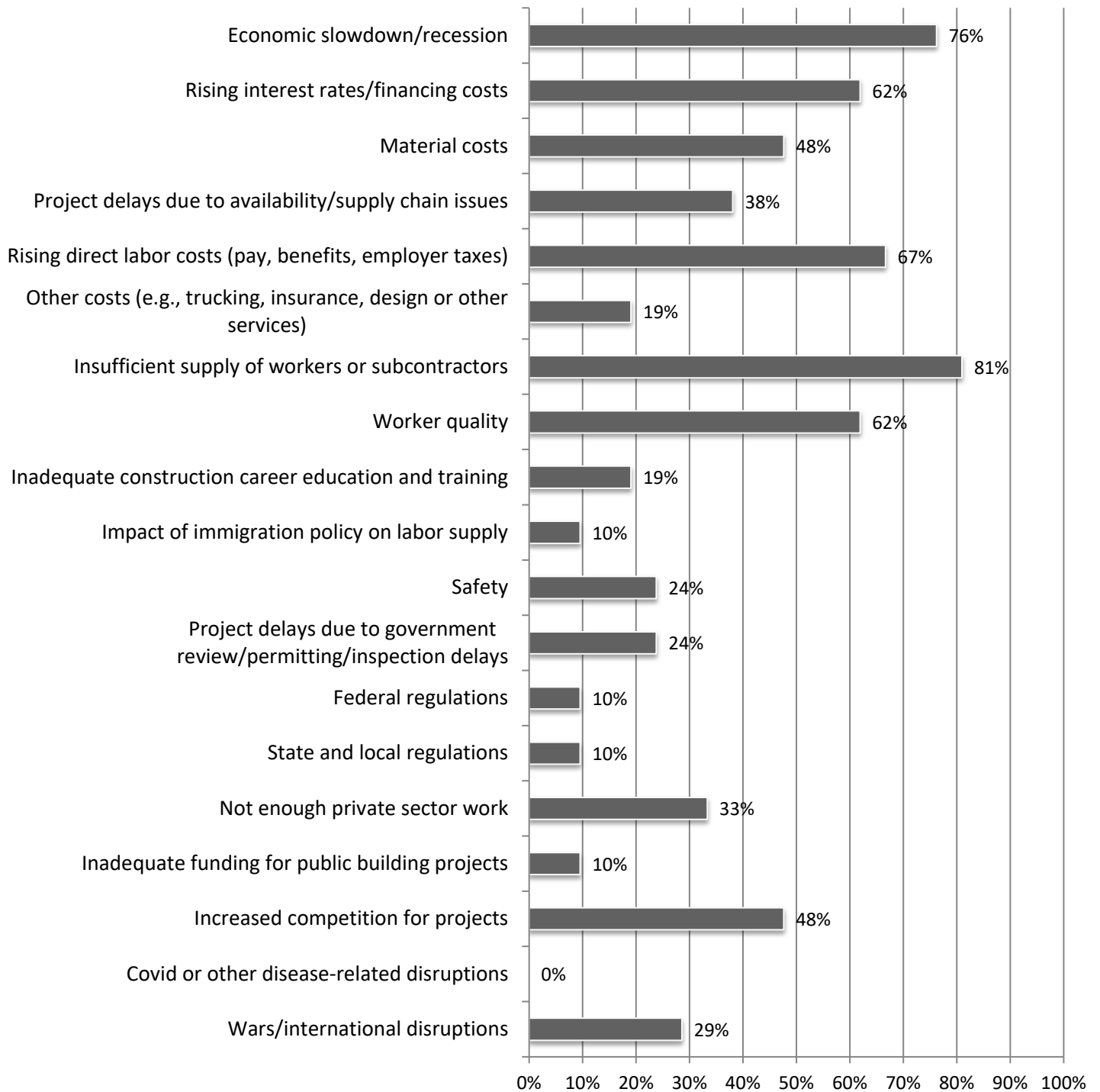

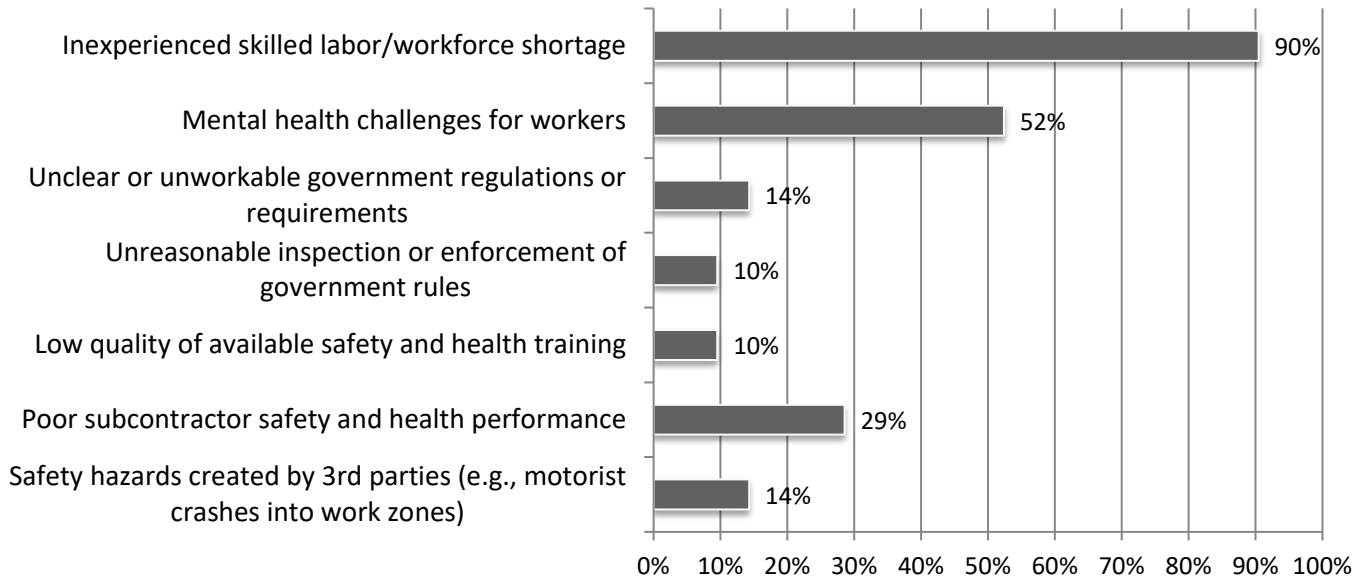

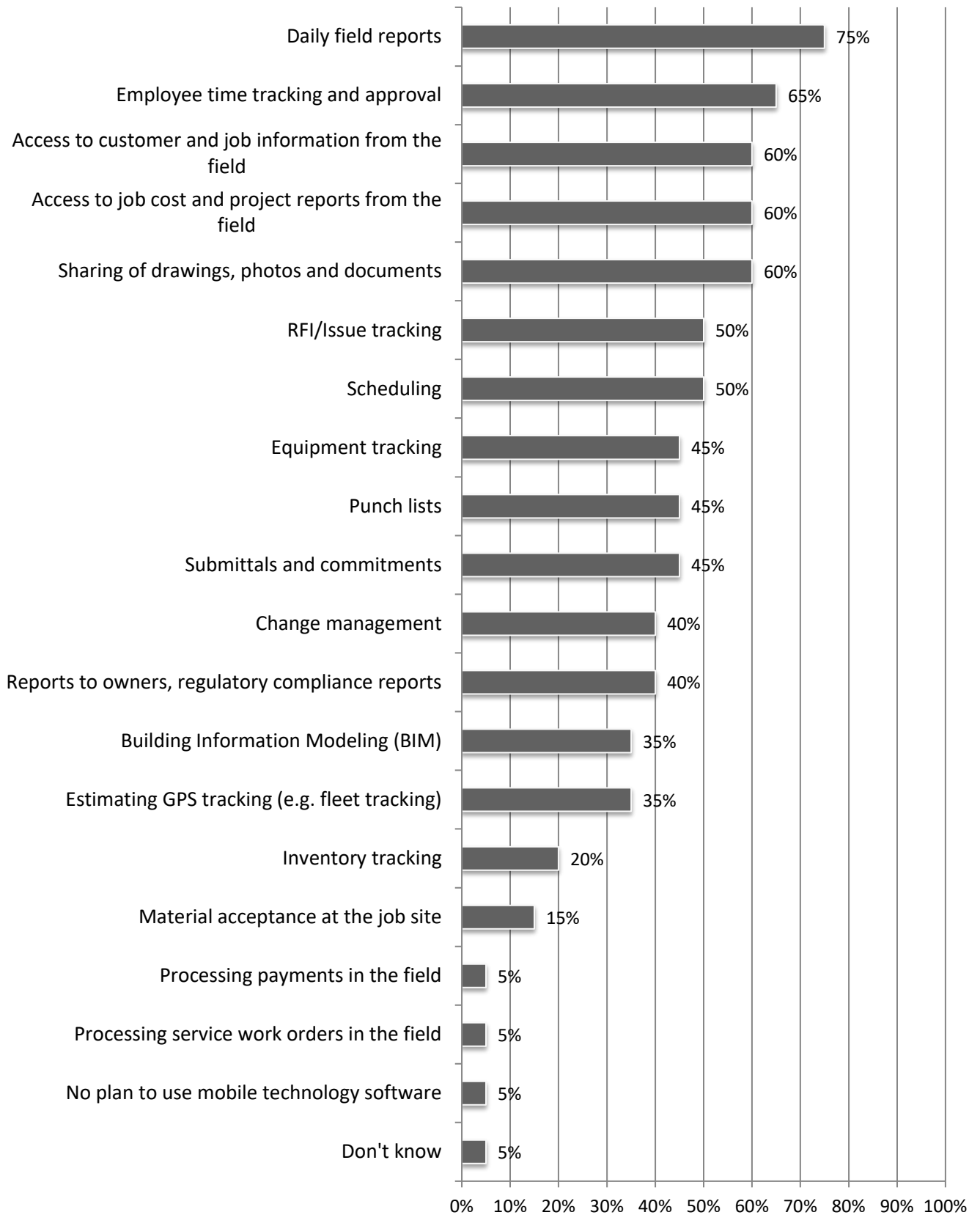

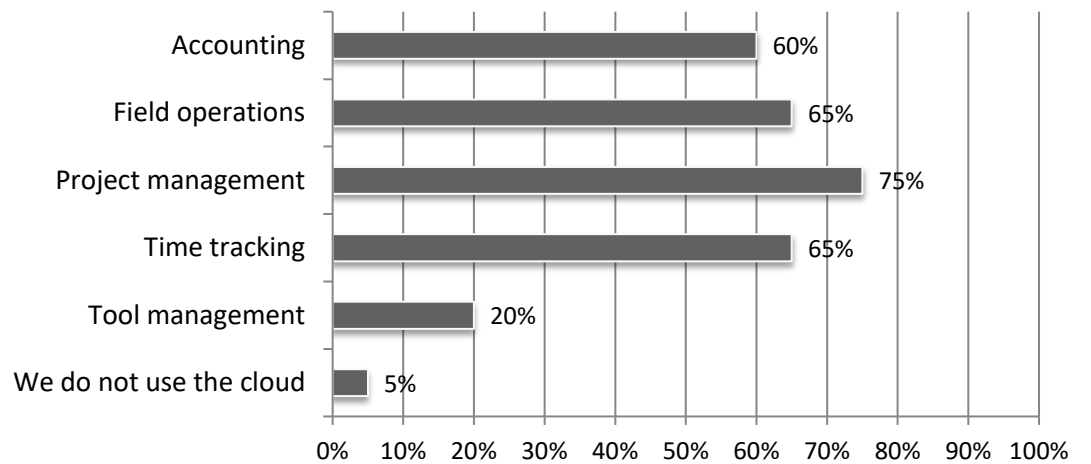

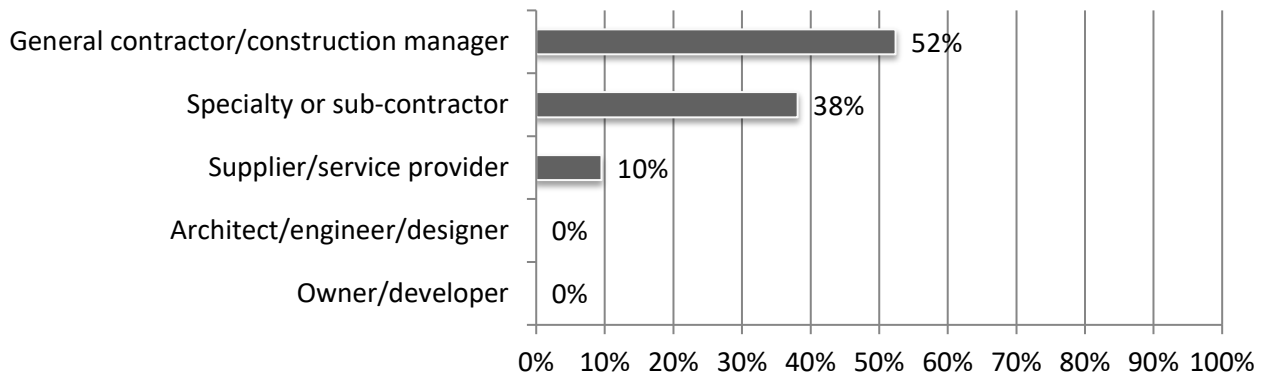


**16. Does your firm use cloud-hosted technology in any of the following ways (mark all that apply)? Responses: 20**

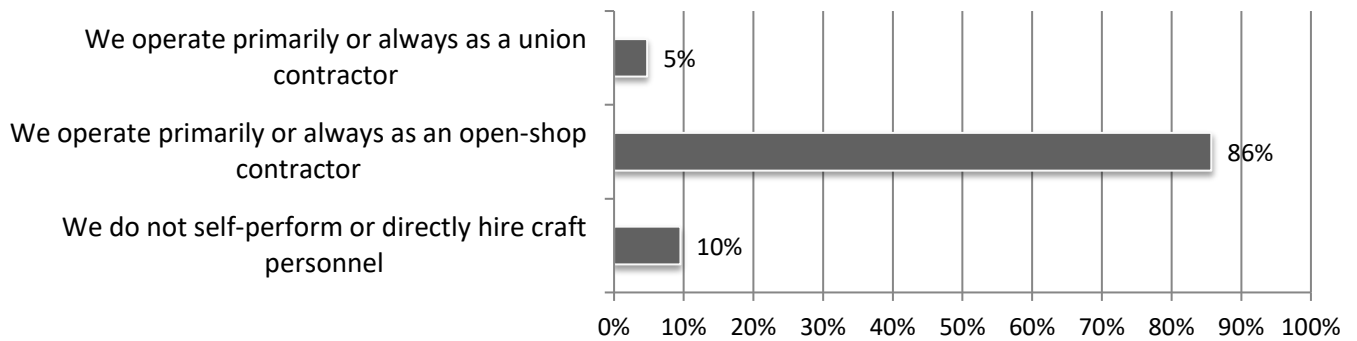




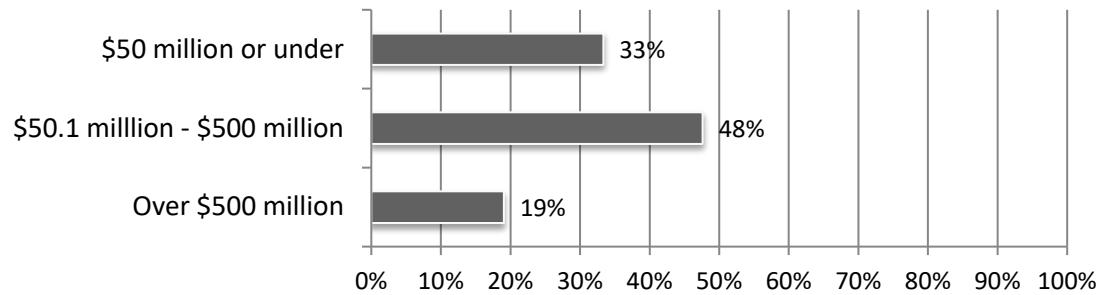
