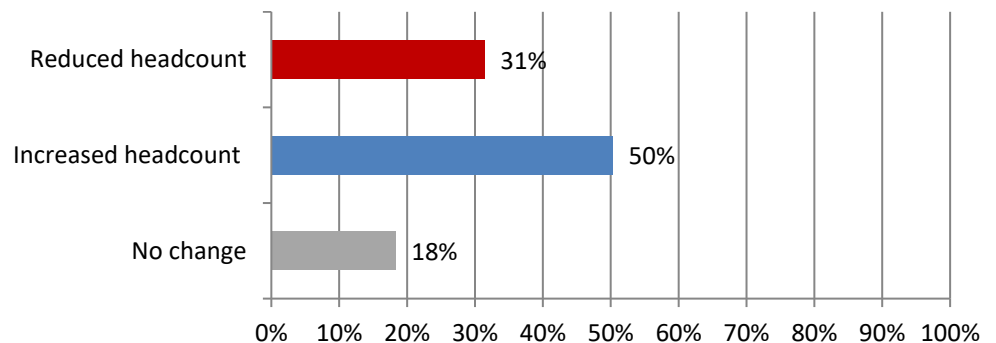

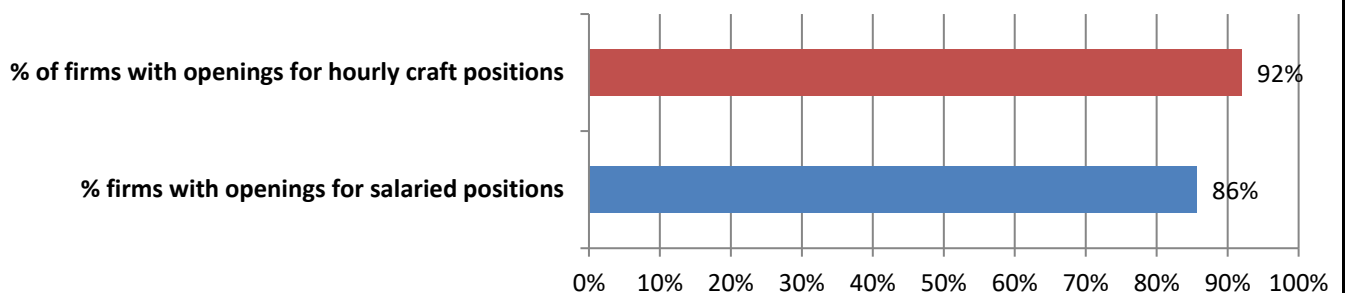

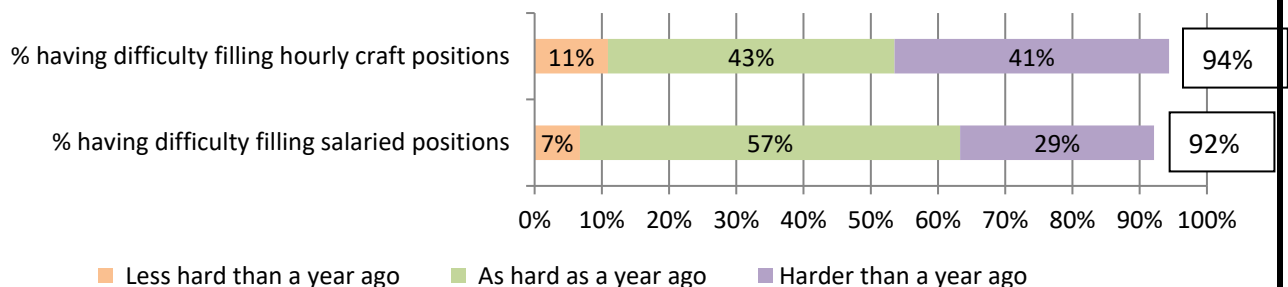
1. By what percentage has your firm's headcount changed in the past 12 months? Responses: 312



2. Do you currently have an open hourly craft or salaried position? Responses: 312 Salaried; 309 Craft

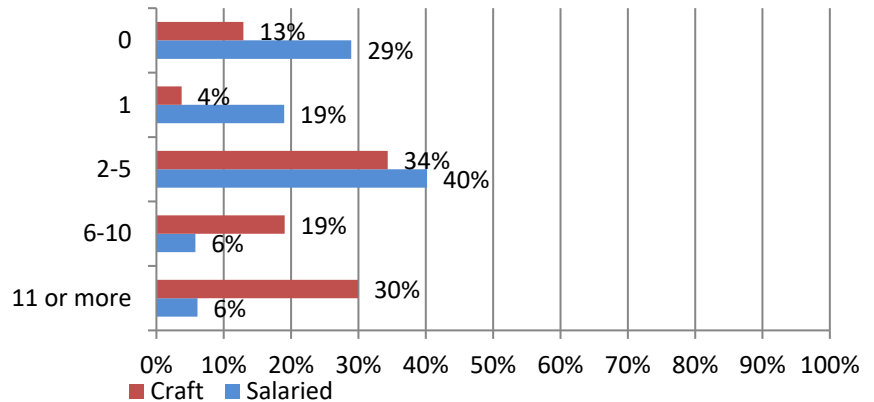


3. Describe your difficulty in filling open positions: Responses: 312 Salaried; 309 Craft*

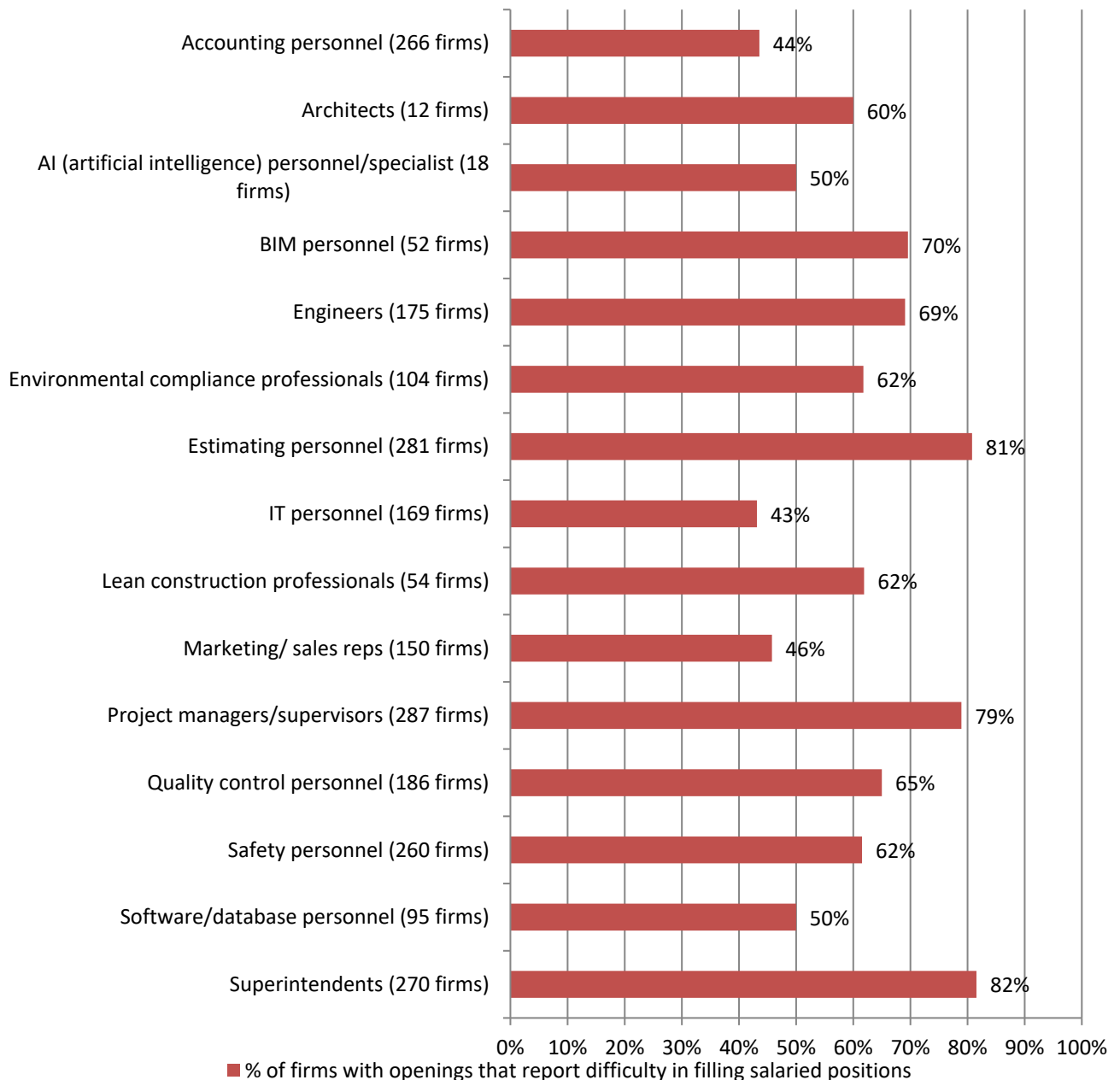

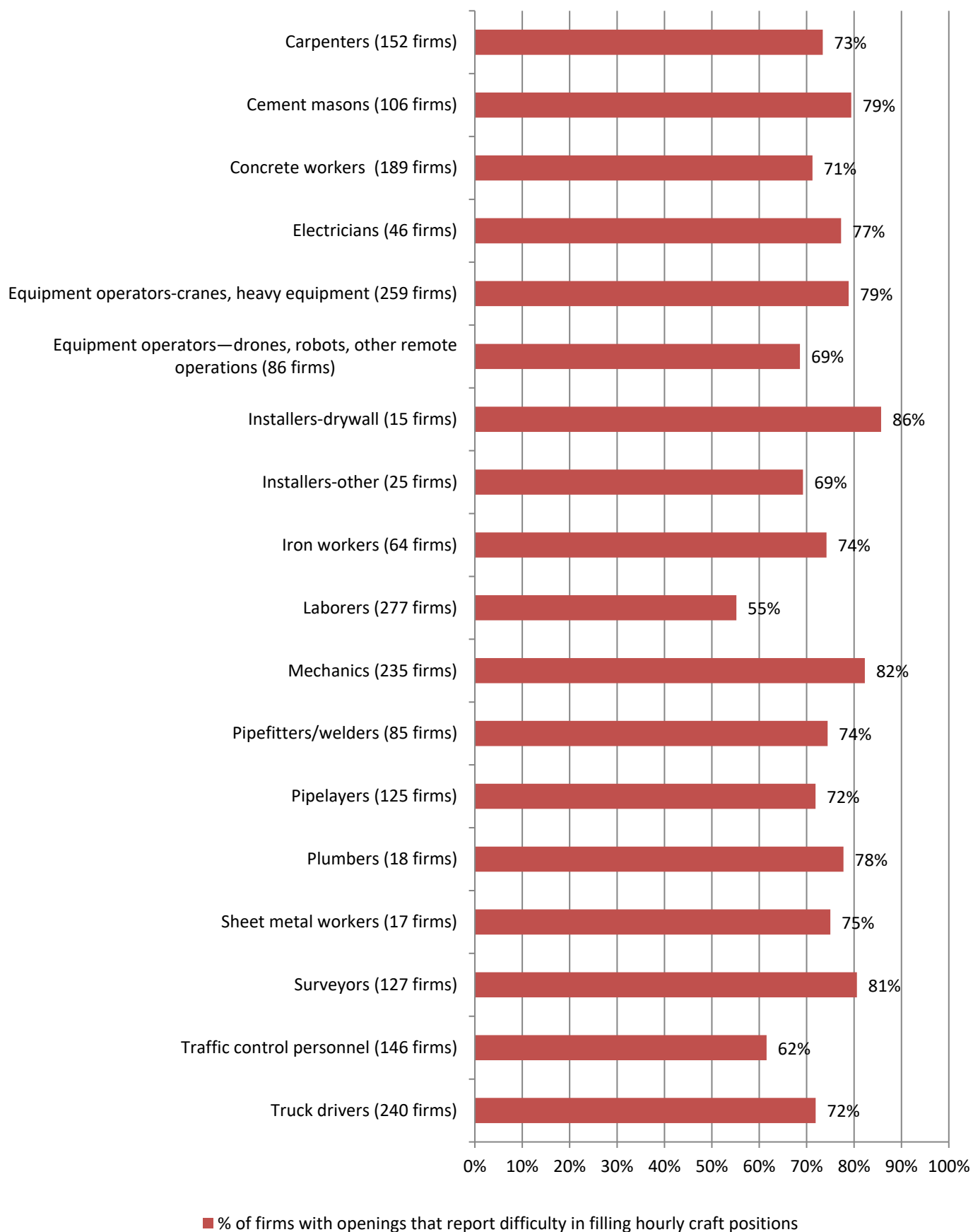
4. How many unfilled hourly craft or salaried positions did you have on June 30, 2025? Responses: 311 Salaried; 294 Craft



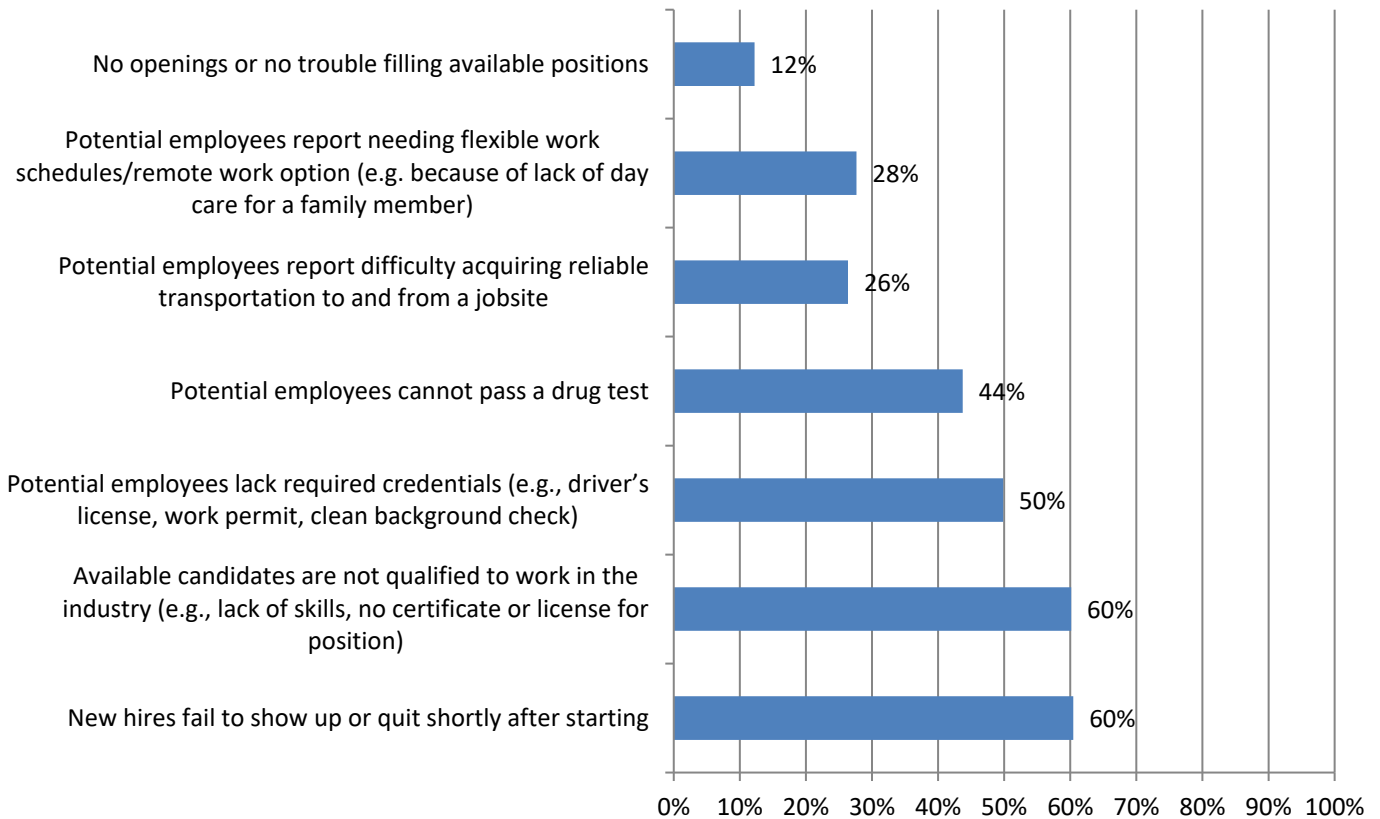

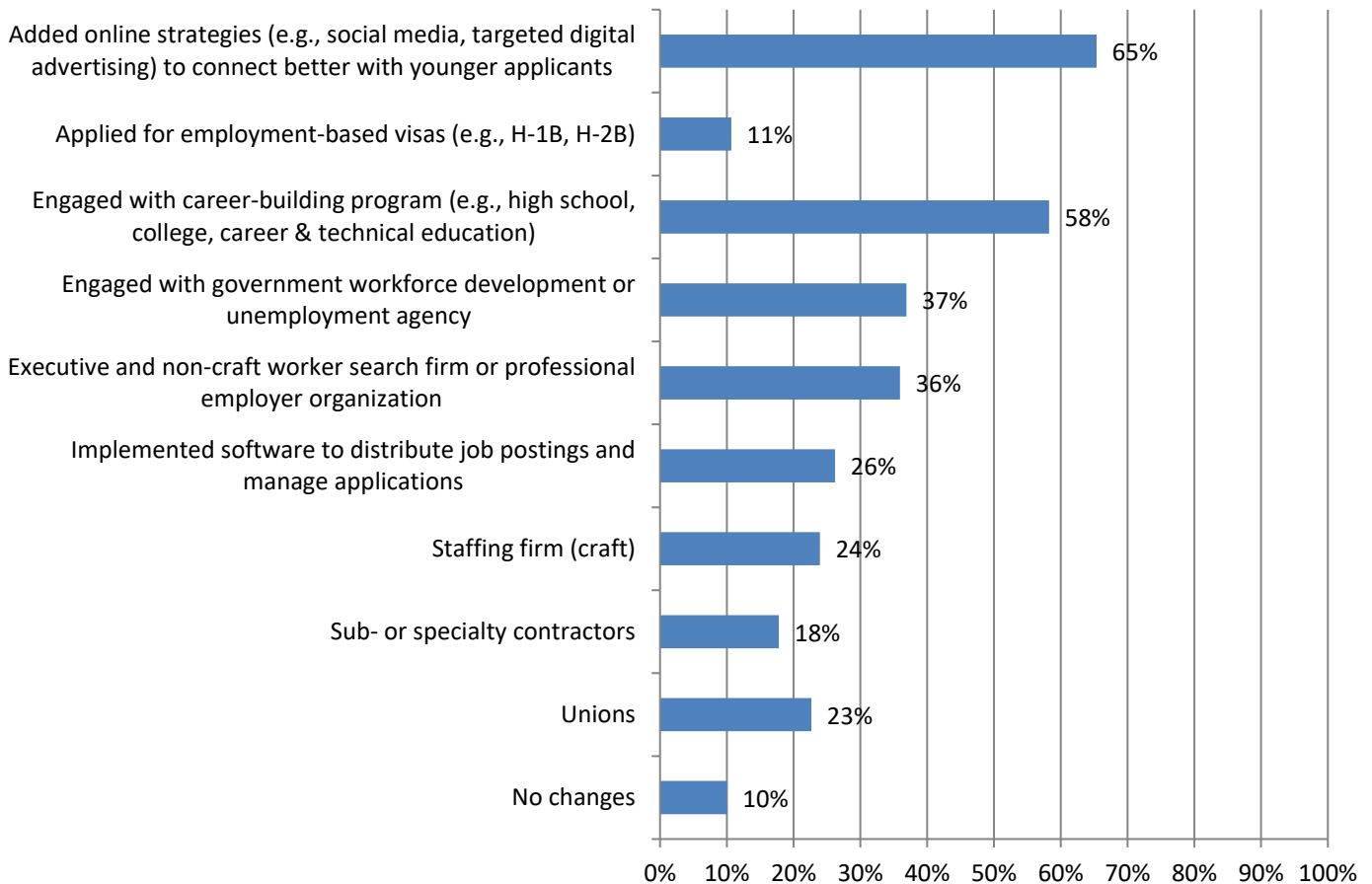

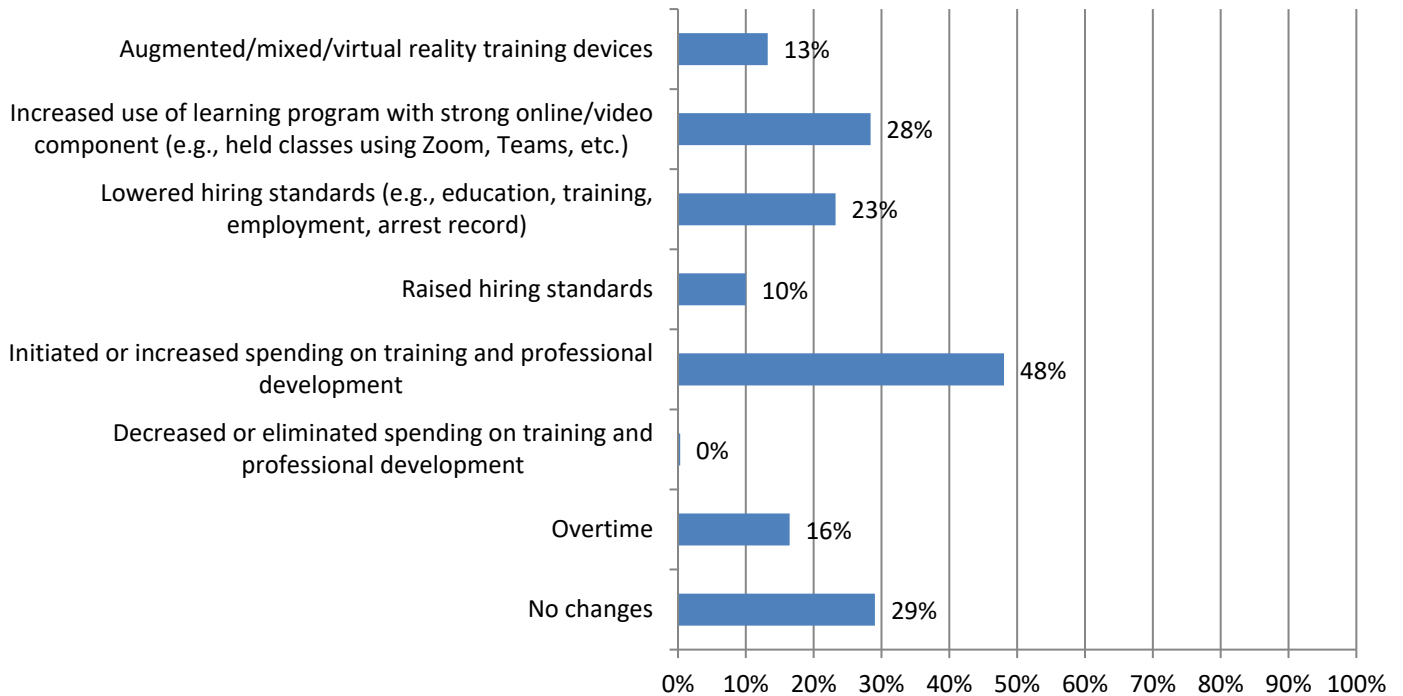

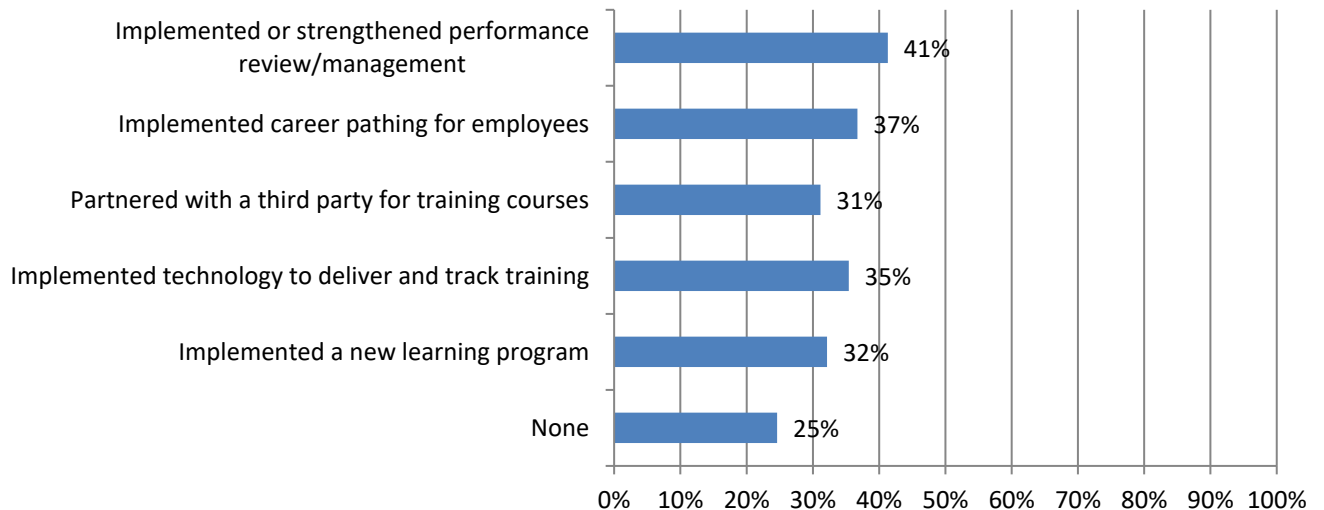

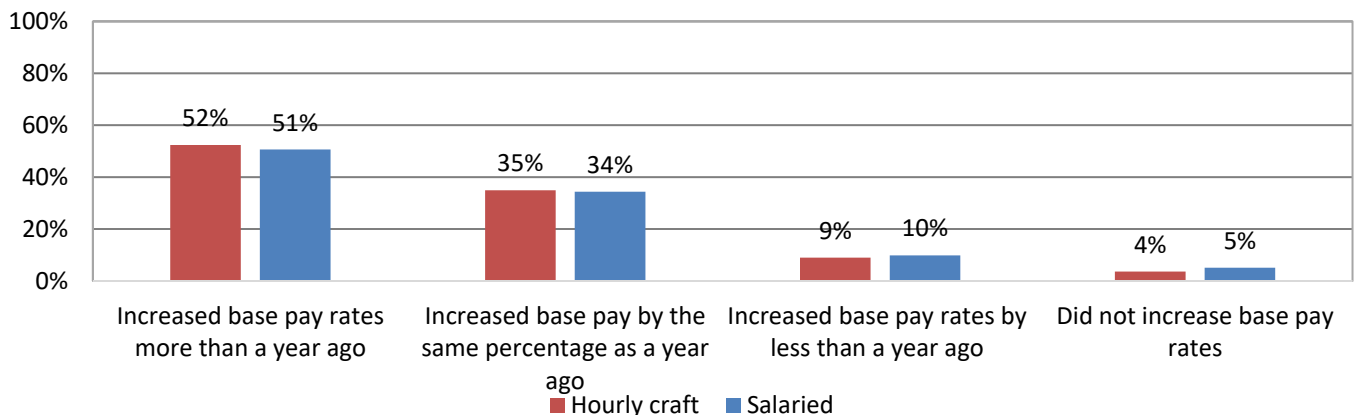

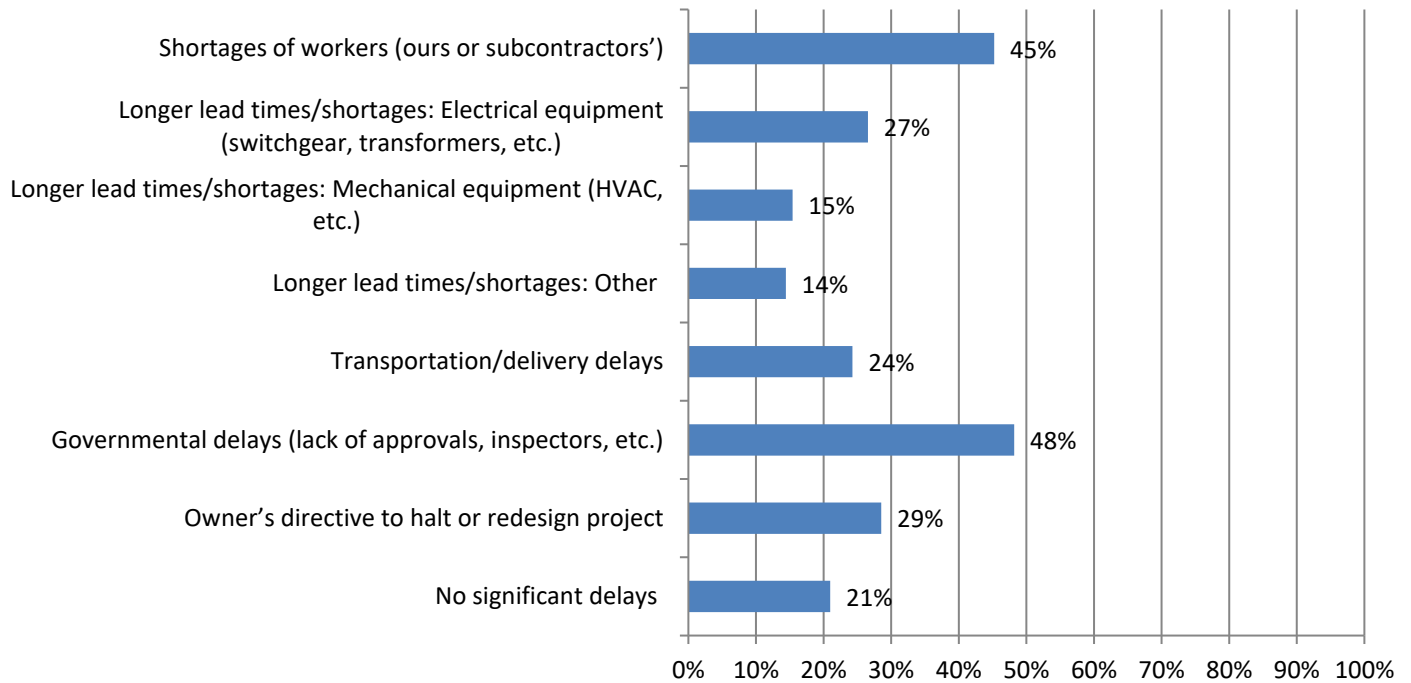

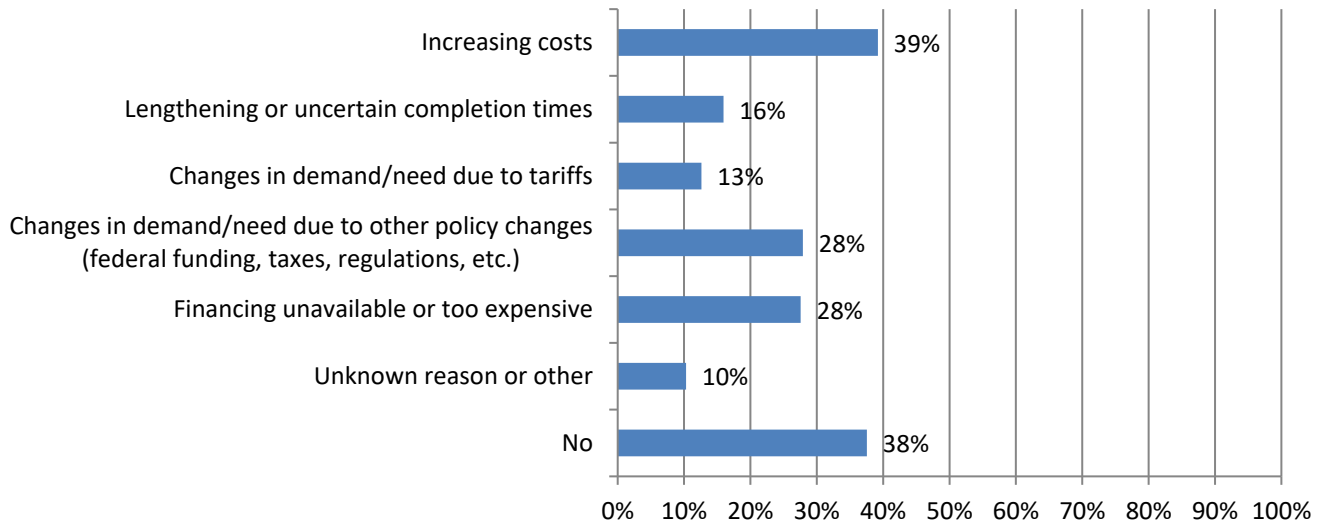

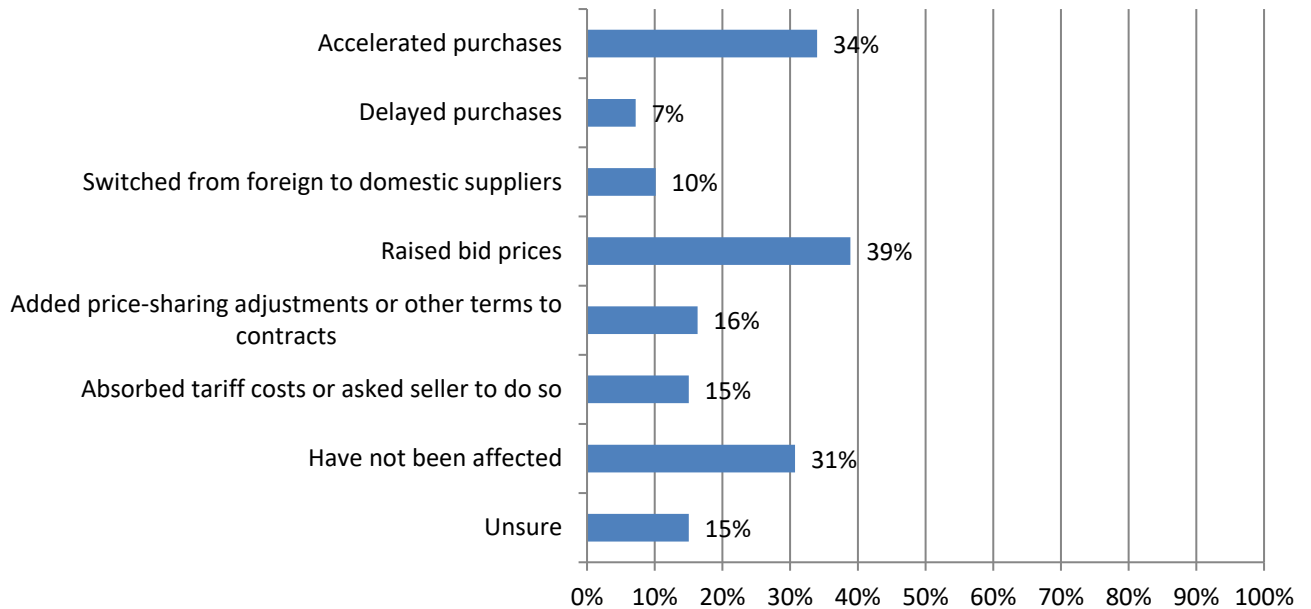

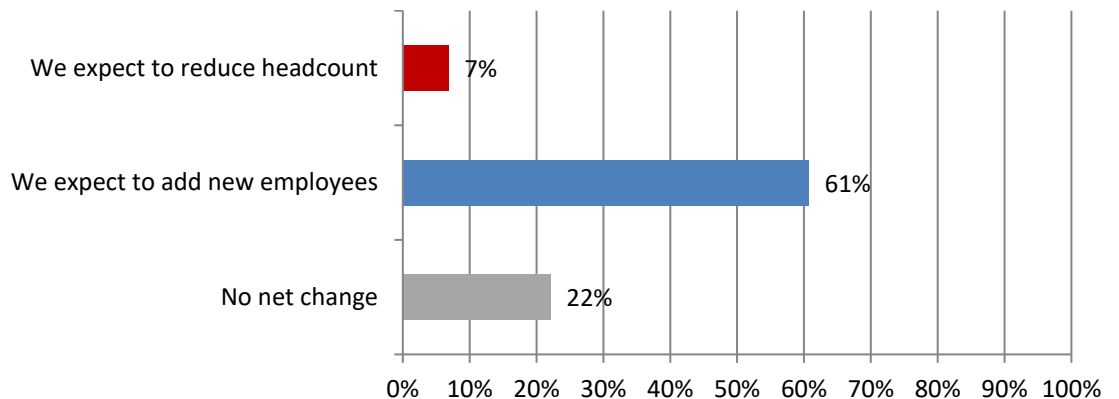

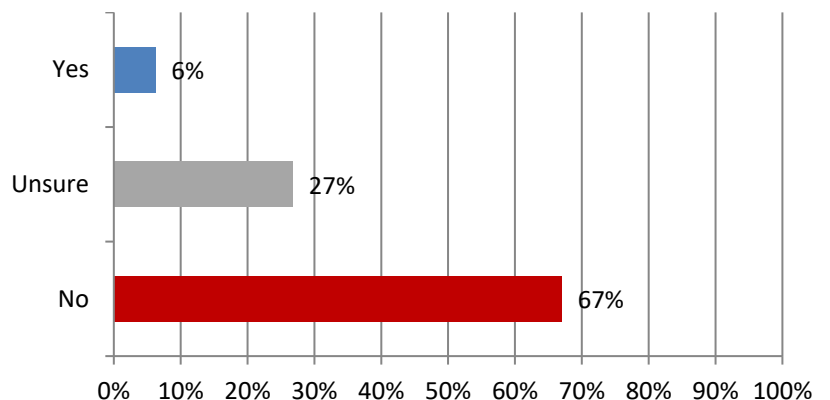

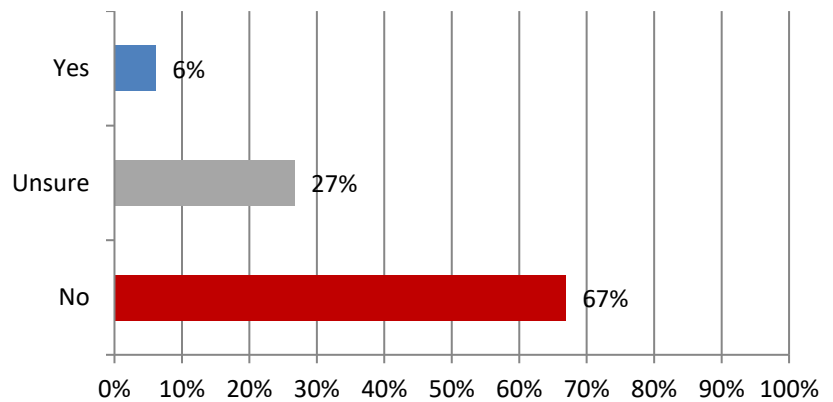

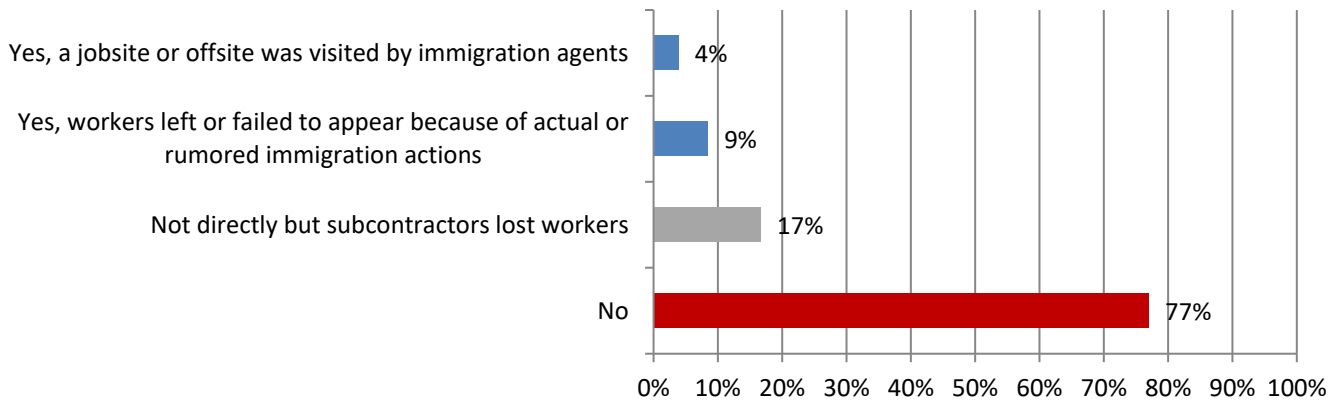

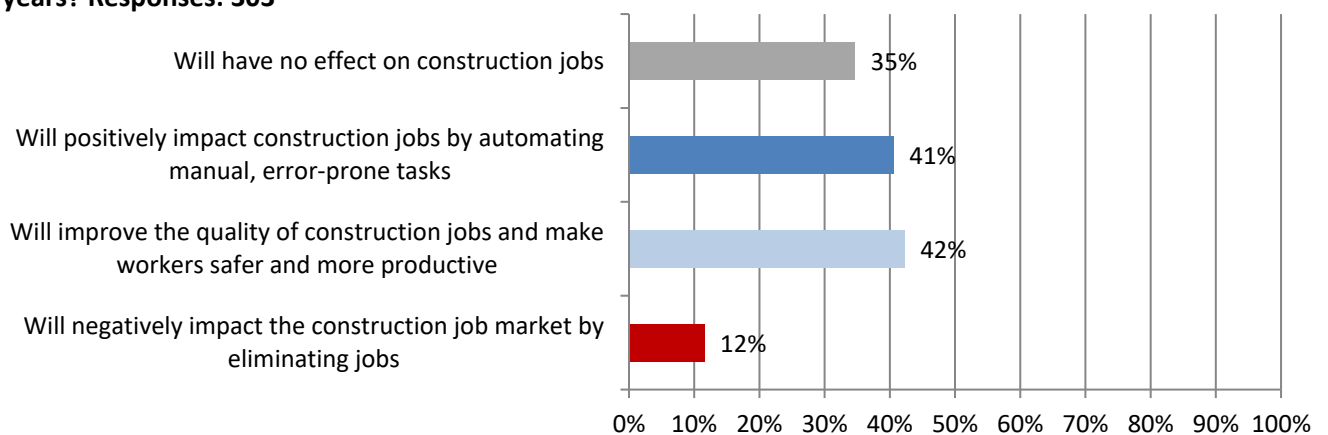

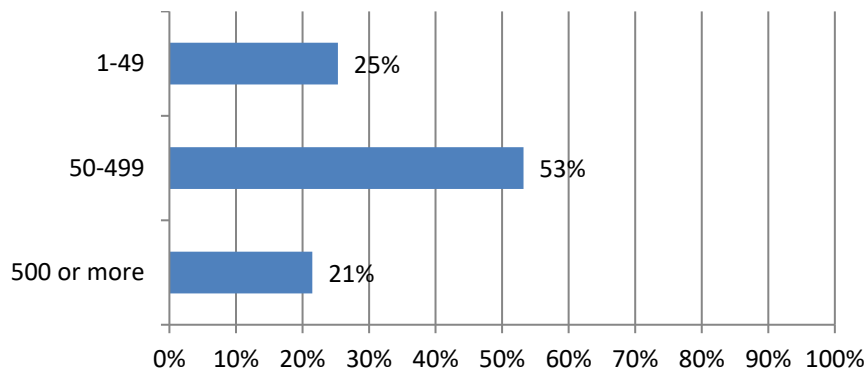

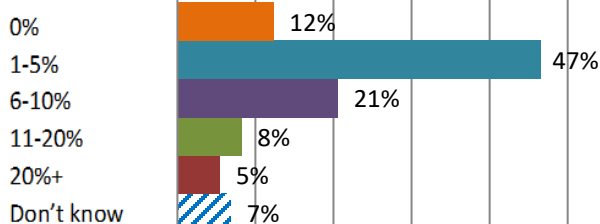

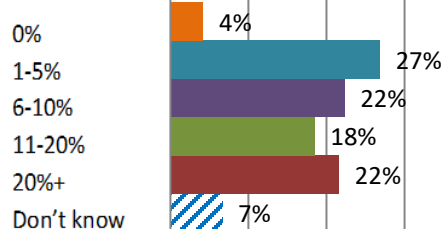
Female Share of Current Workforce (as of June 30)

Female Share of Employees Hired in the Past 12 Months

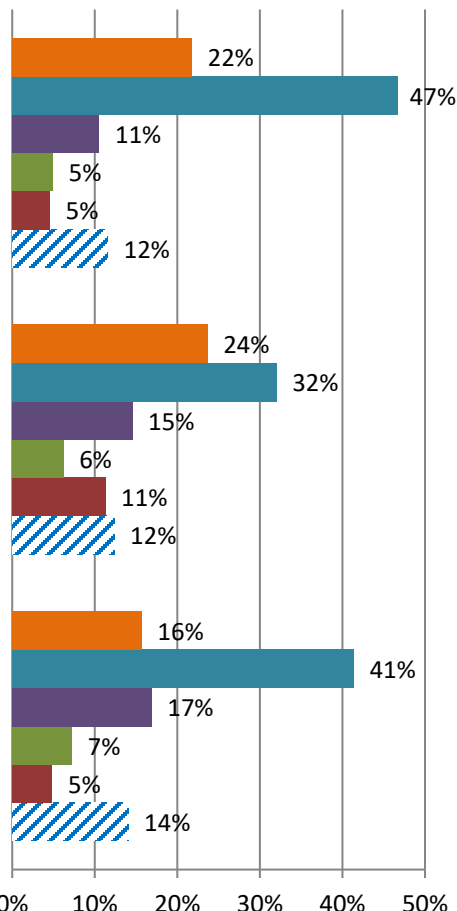
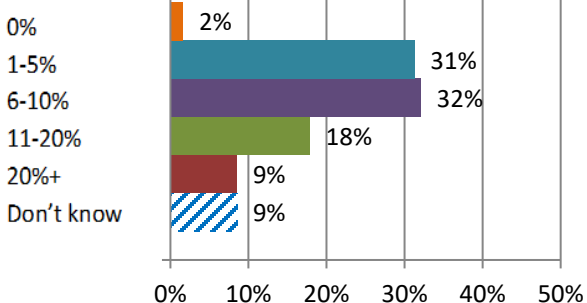

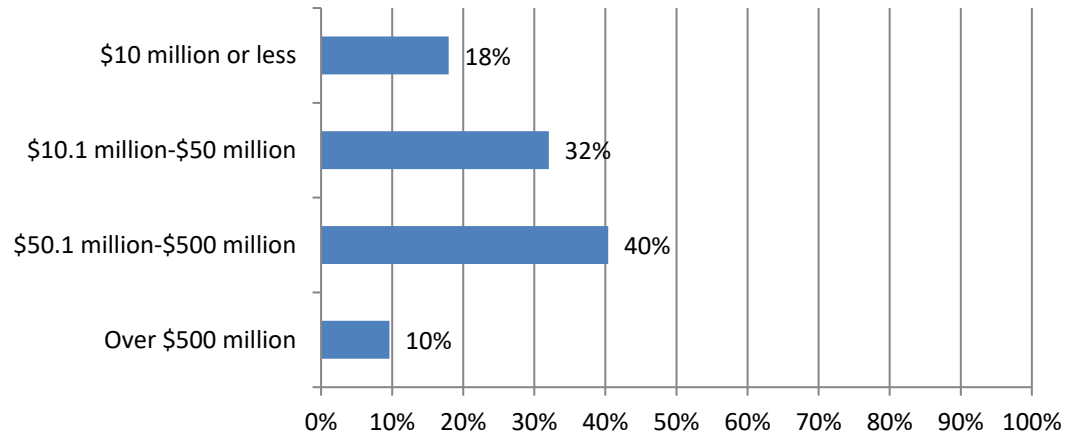

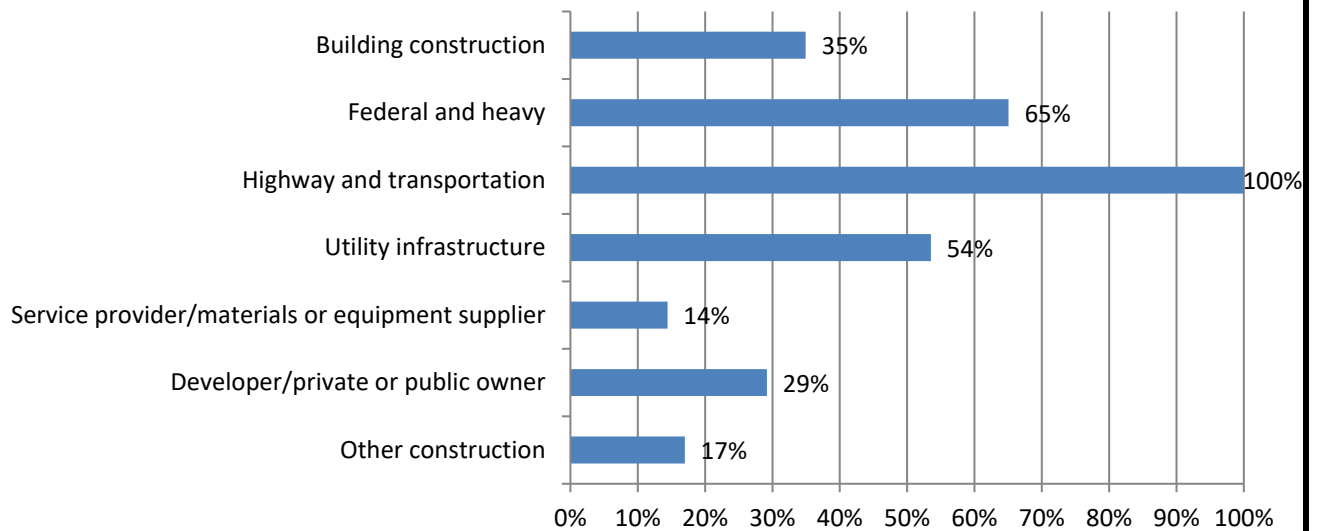
