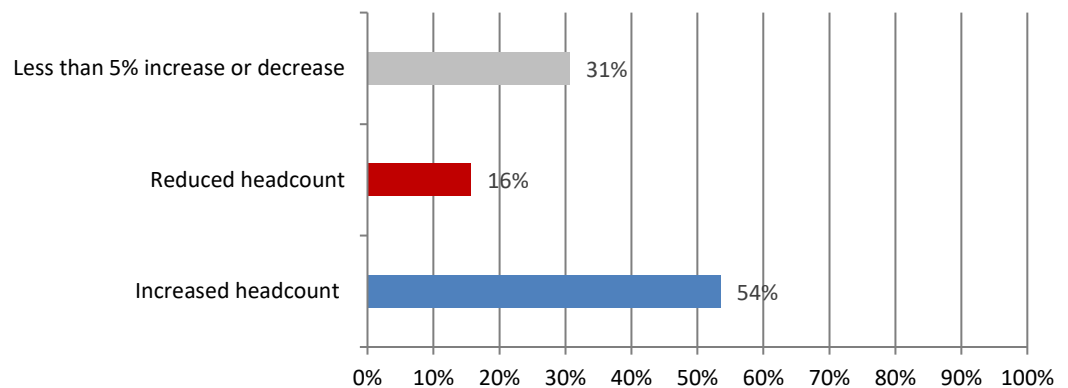

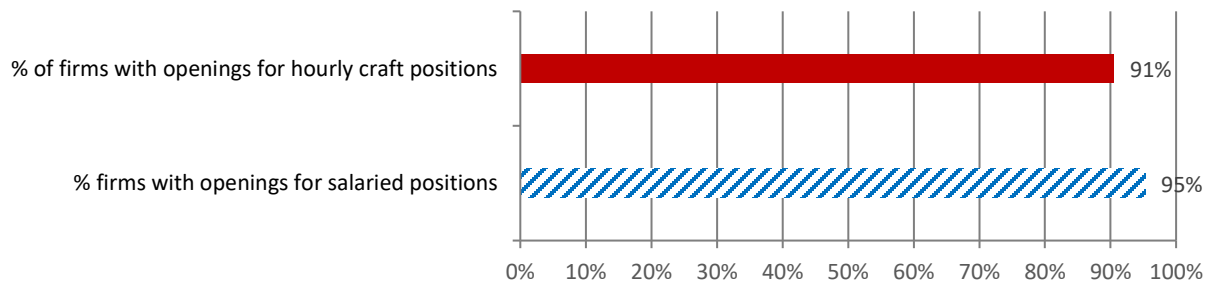

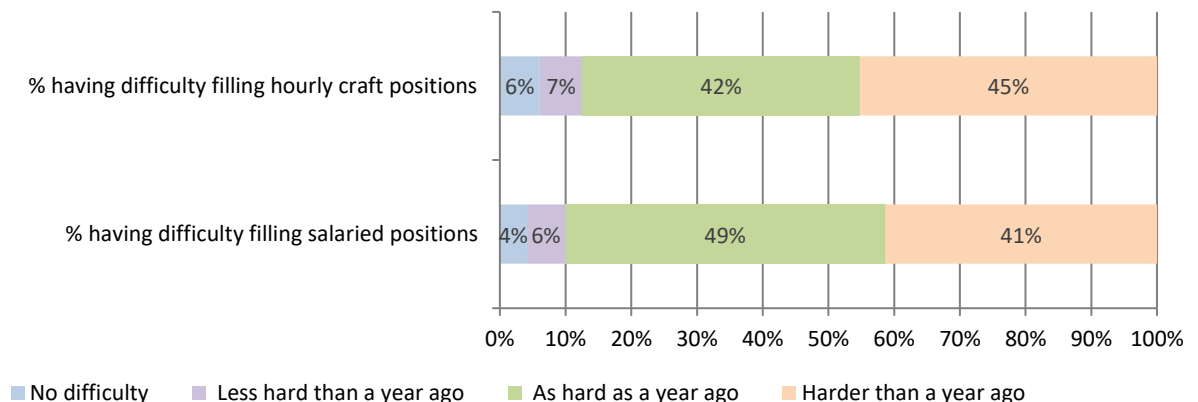
1. By what percentage has your firm's headcount changed in the past 12 months? Responses: 254



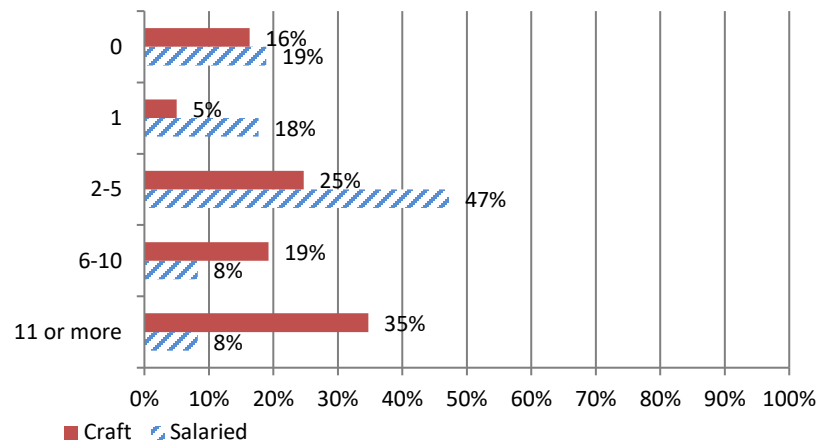
2. Do you currently have an open hourly craft or salaried position? Responses: 254 Salaried; 254 Craft



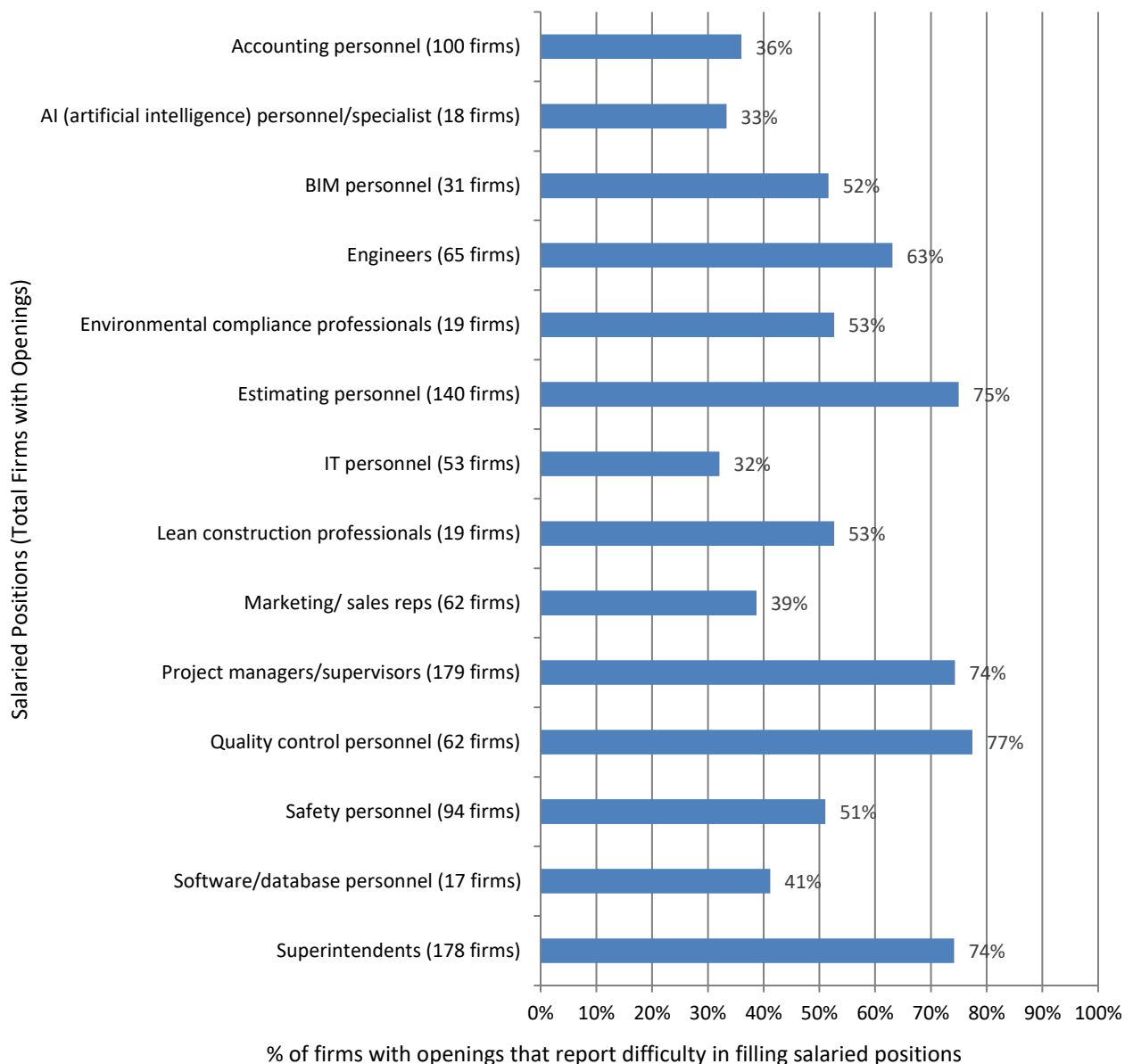
3. Describe your difficulty in filling open positions: Responses: 254 Salaried; 254 Craft



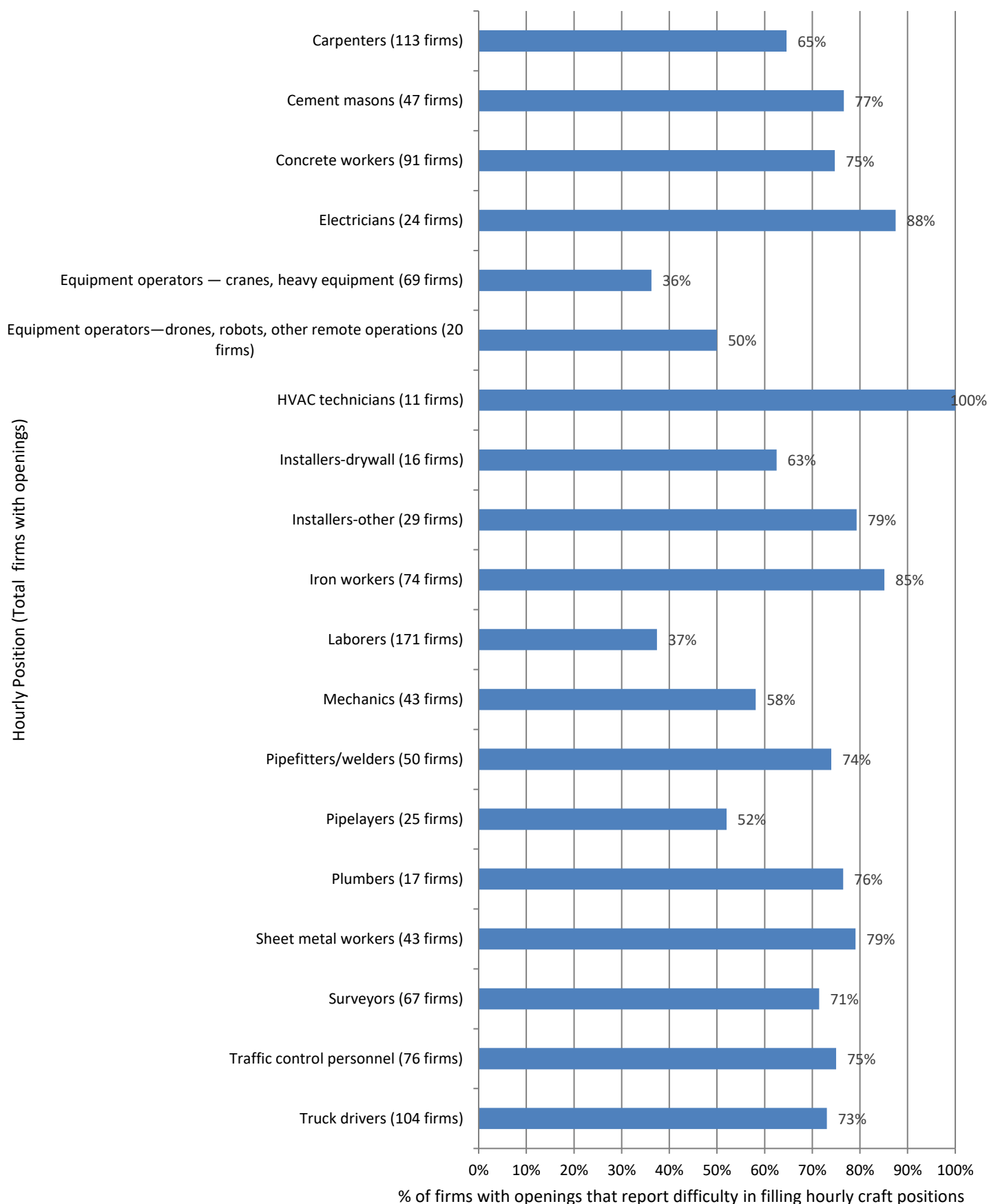
4. How many unfilled hourly craft or salaried positions did you have on June 30, 2026? Responses: 255 Salaried; 255 Craft



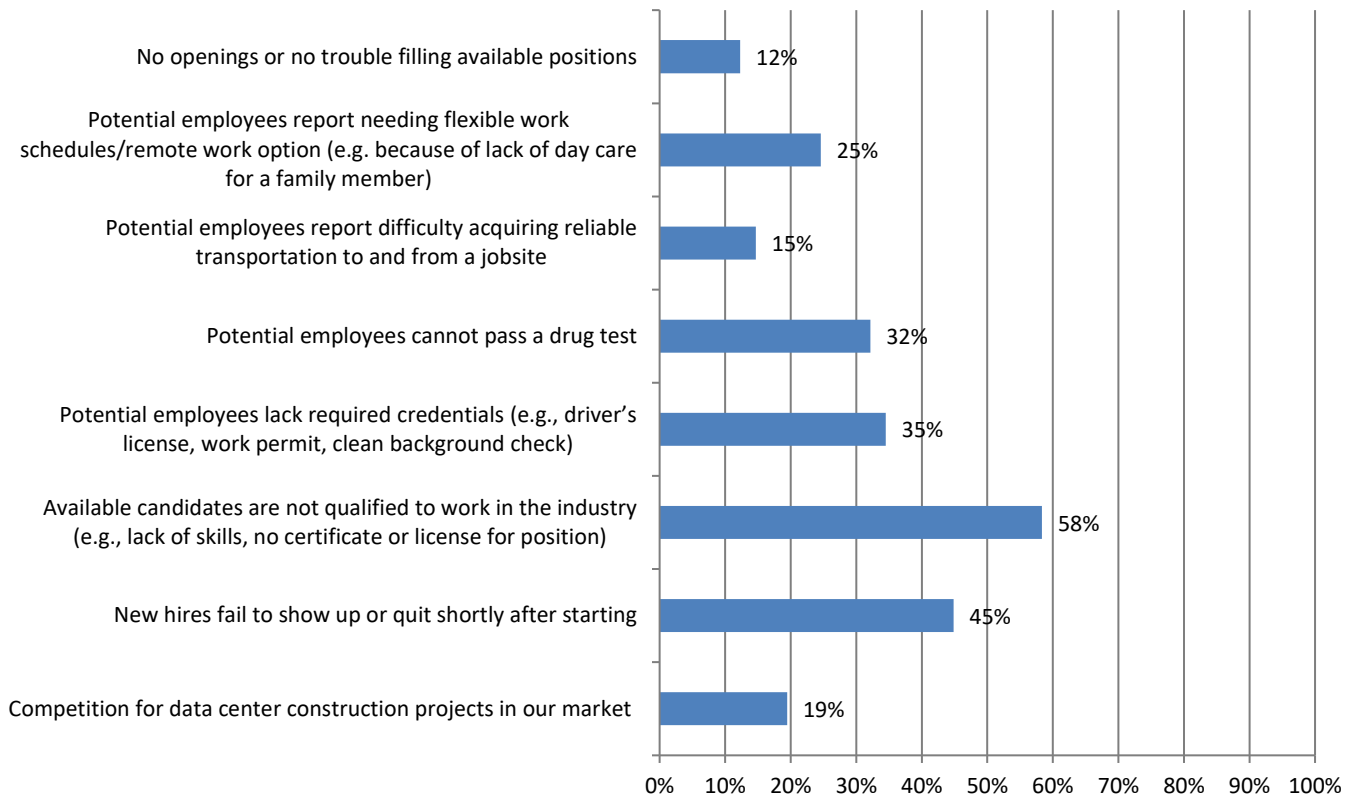

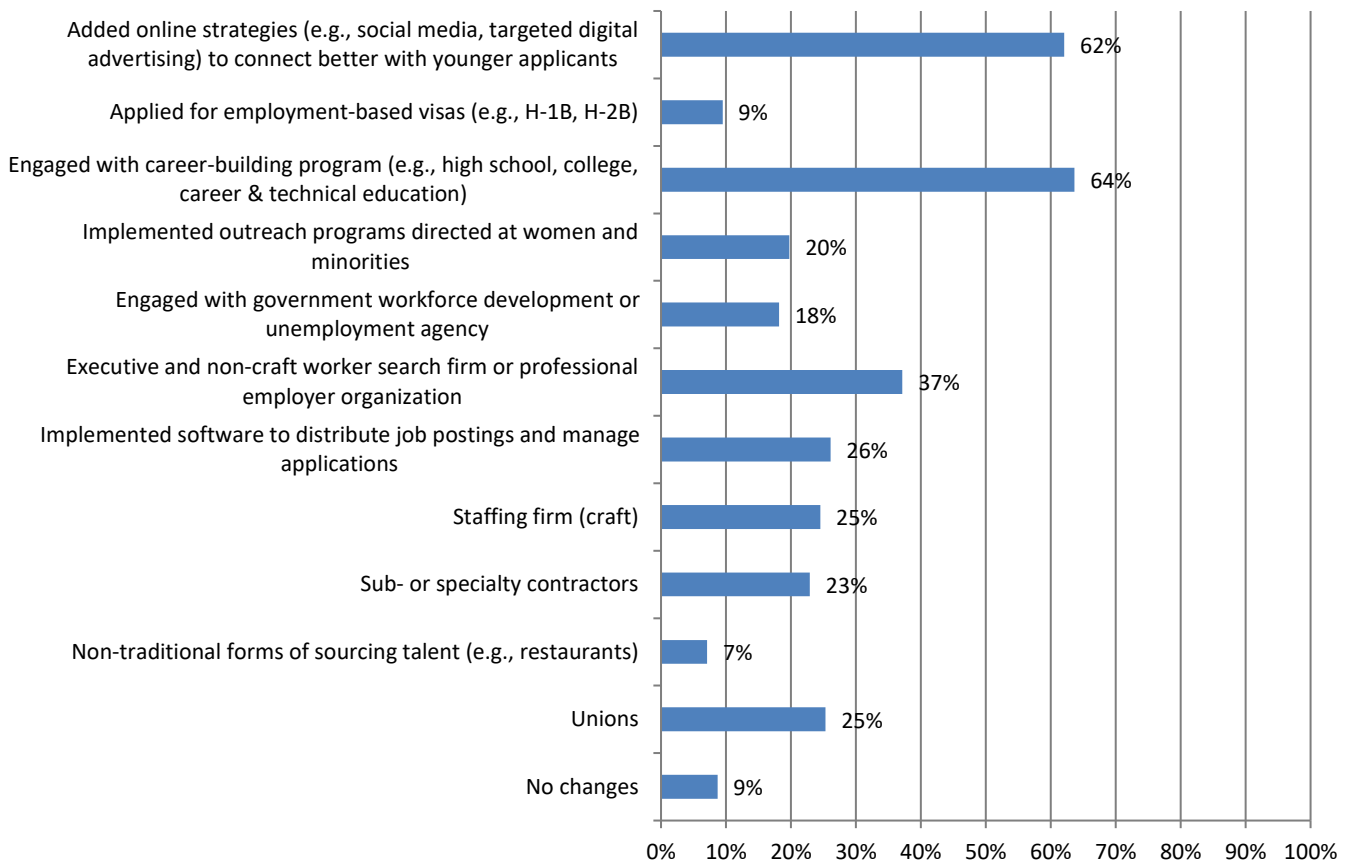

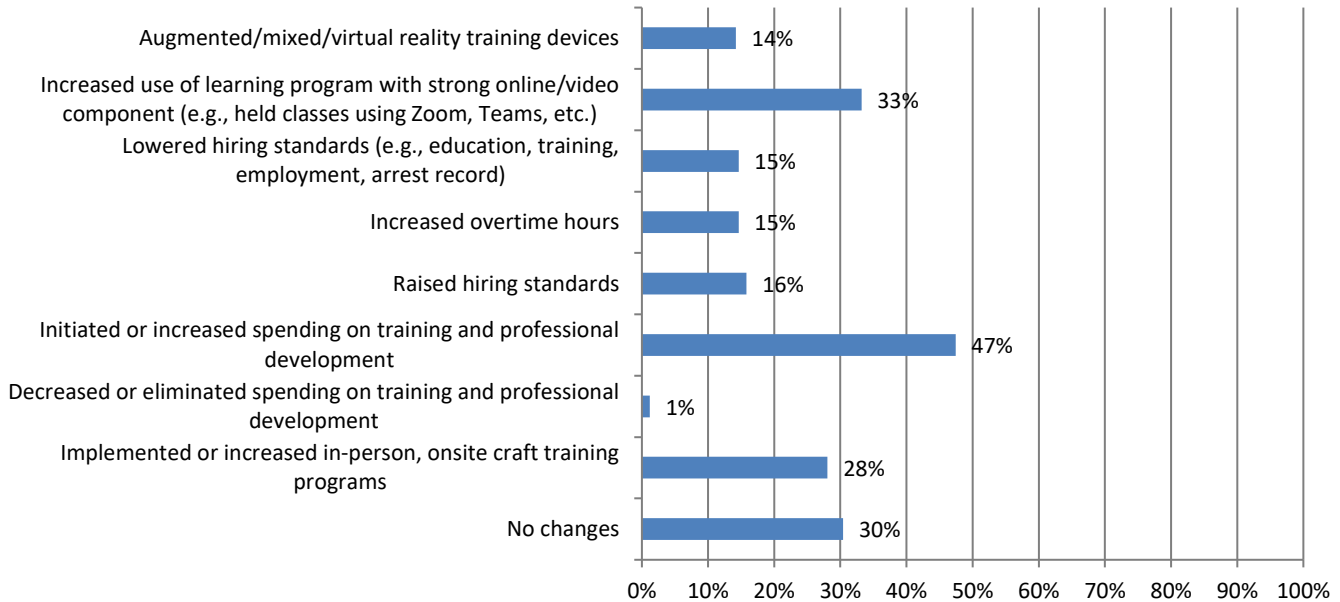

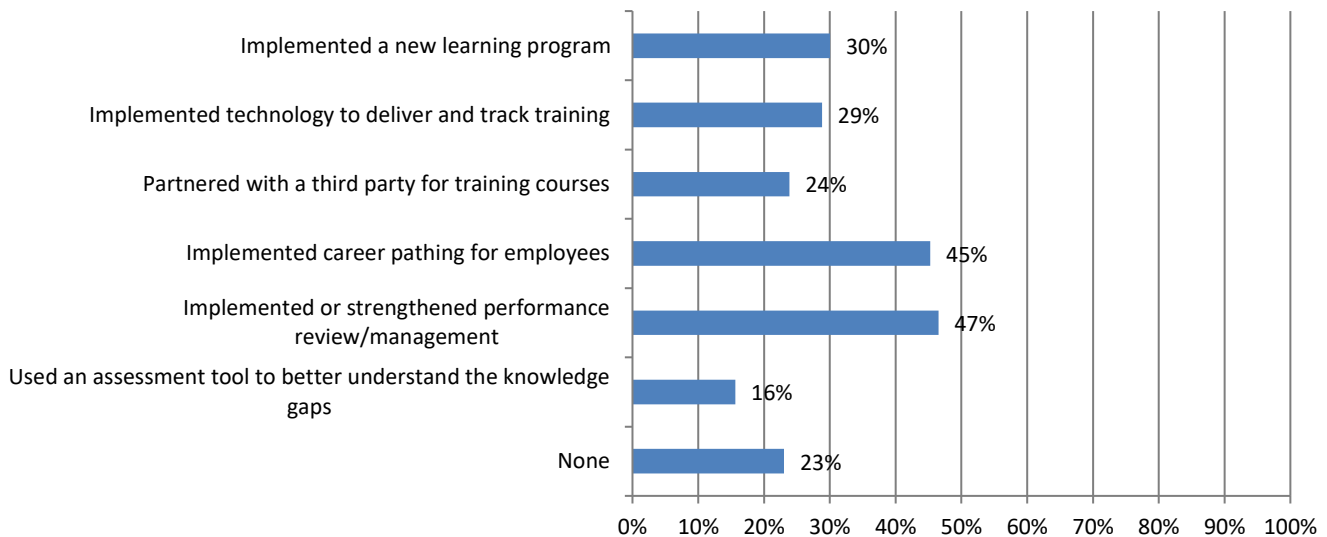

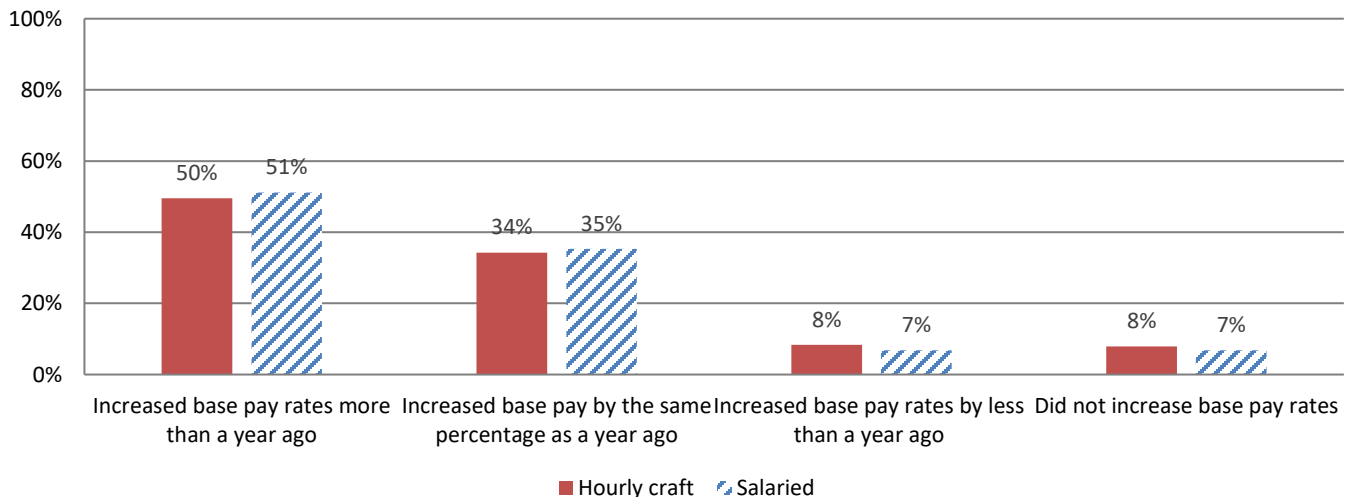

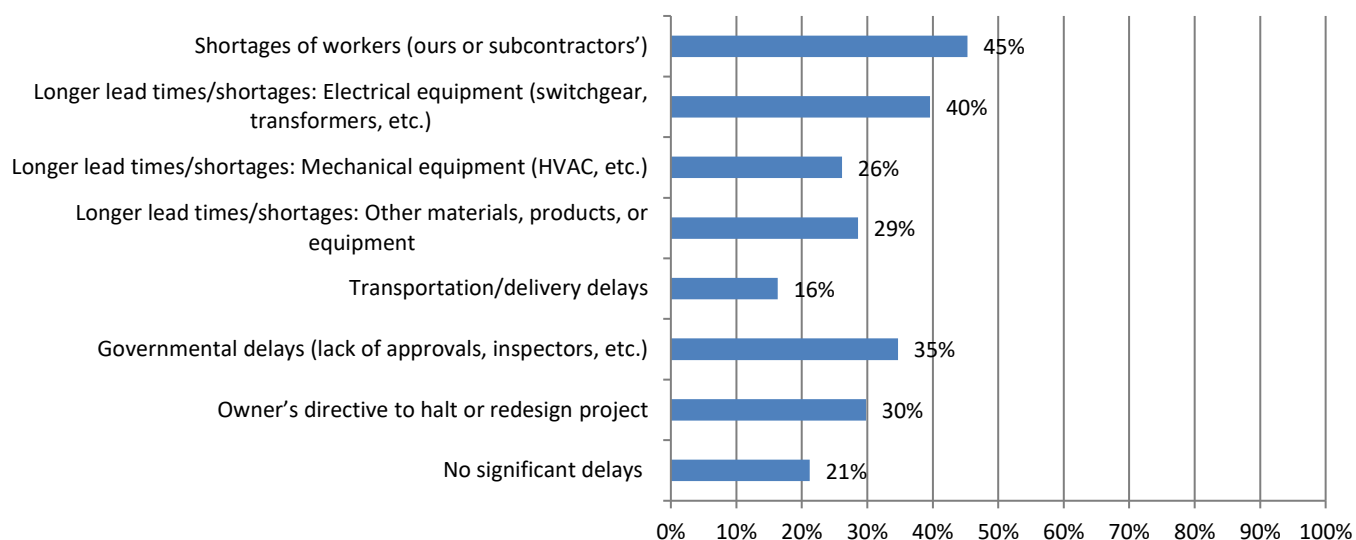

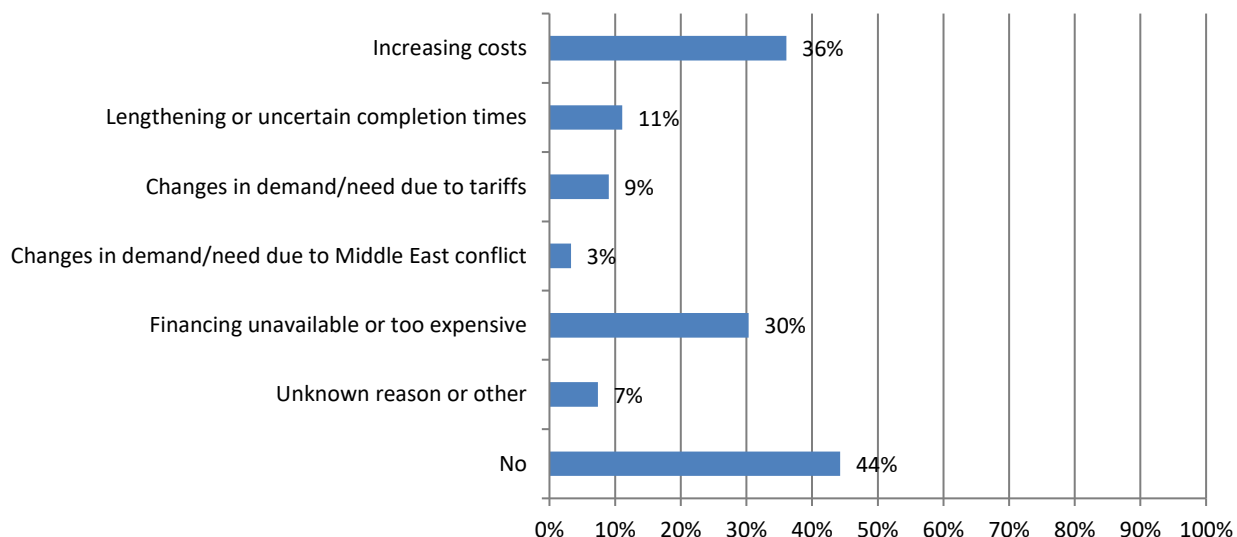

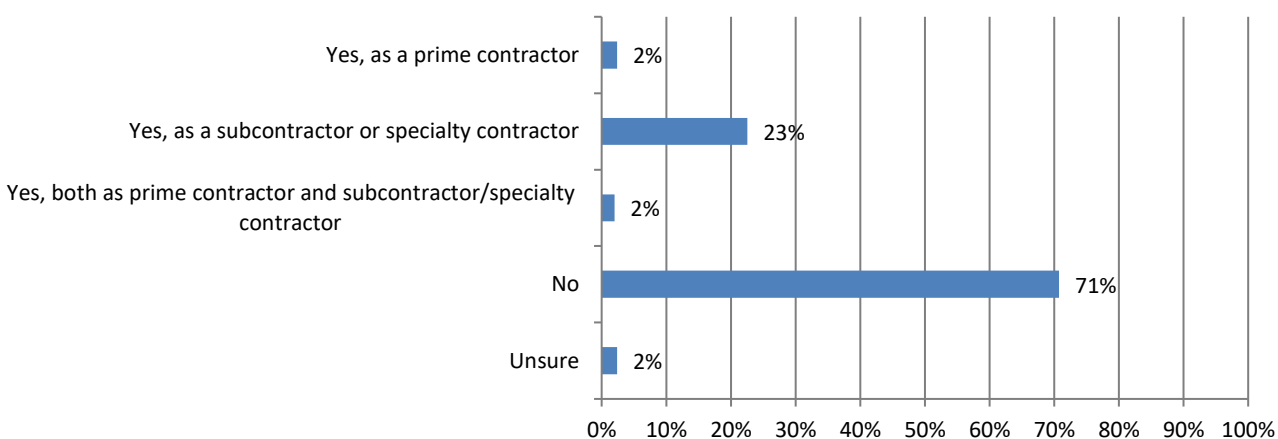

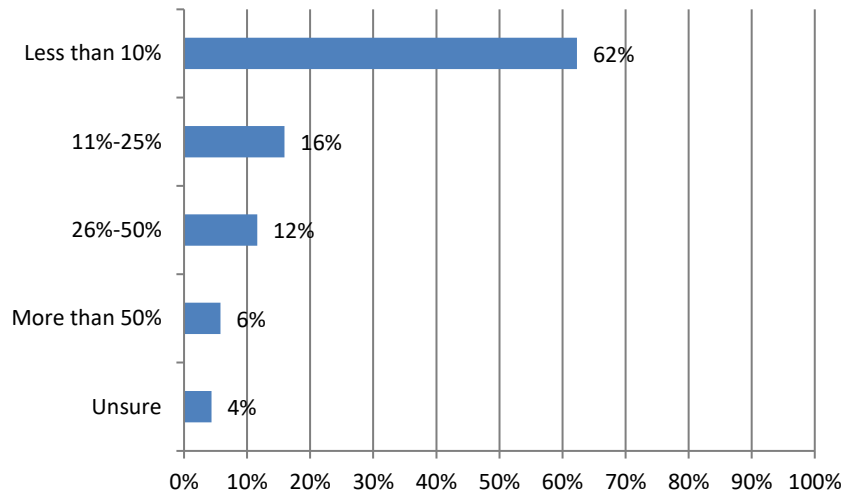

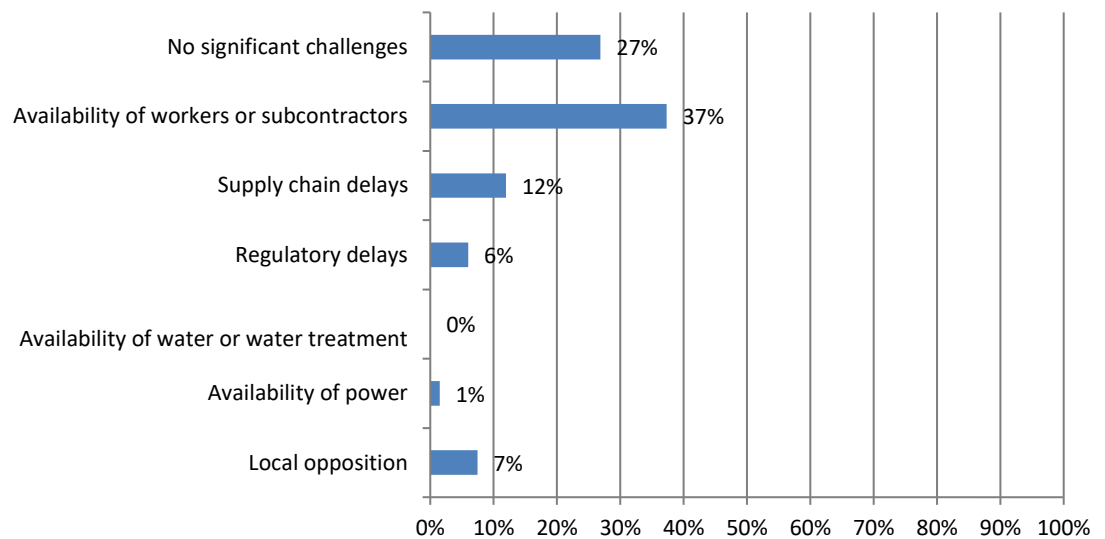

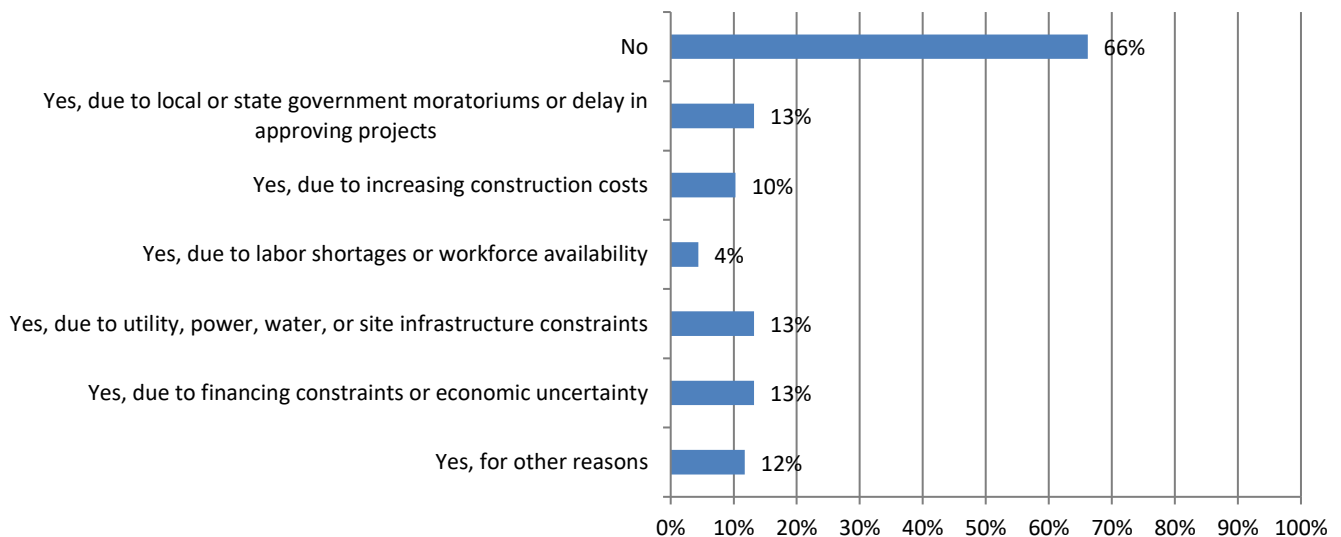

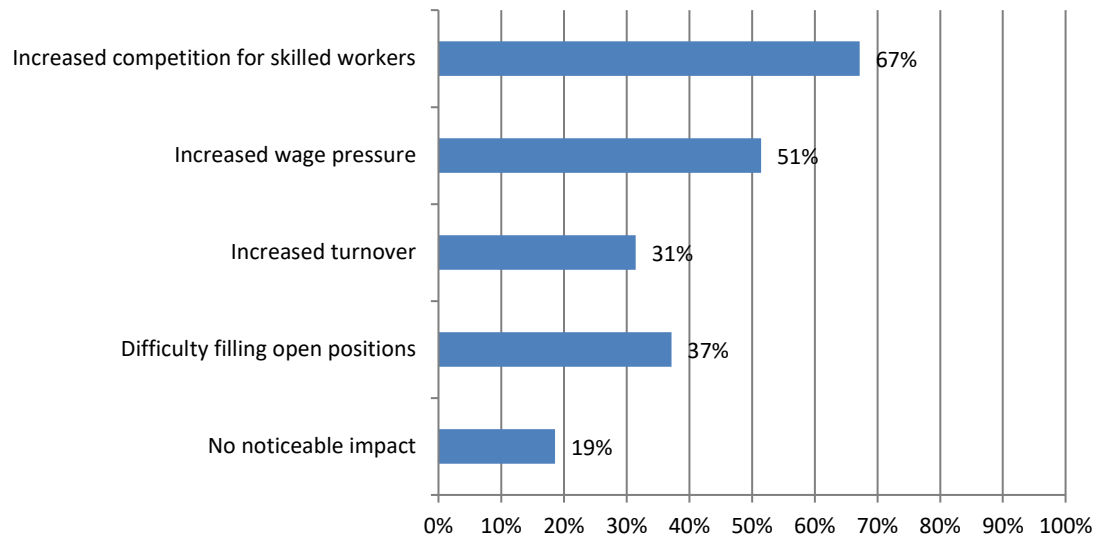

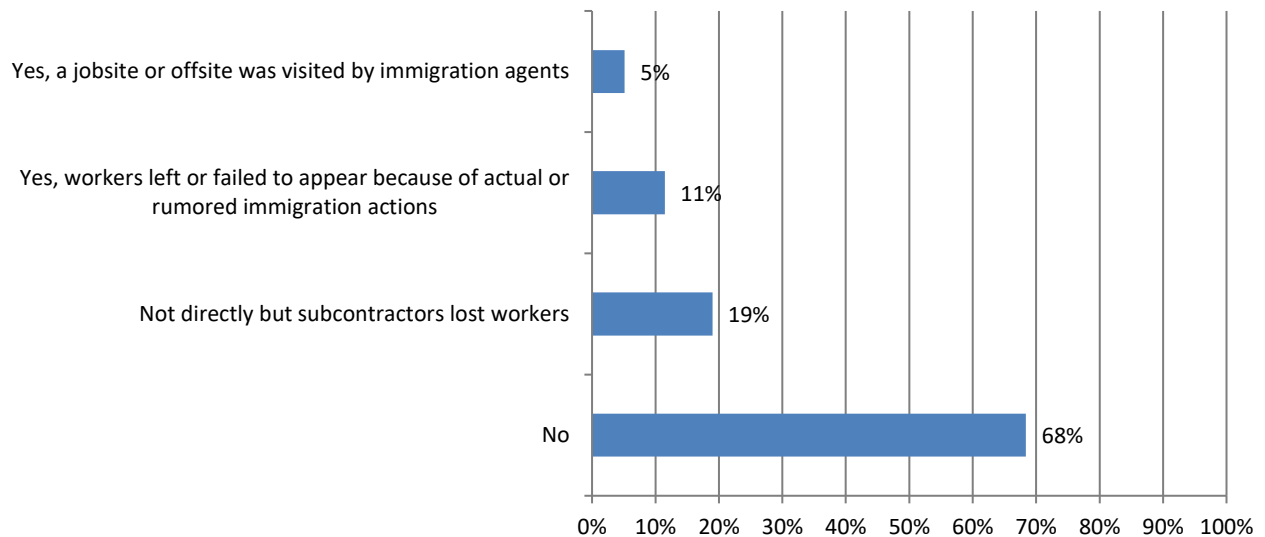

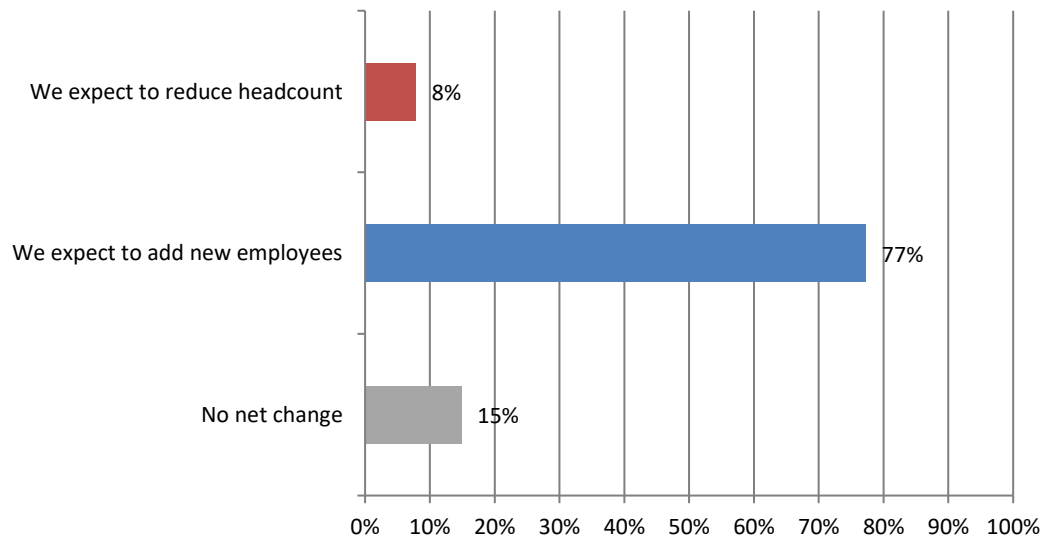

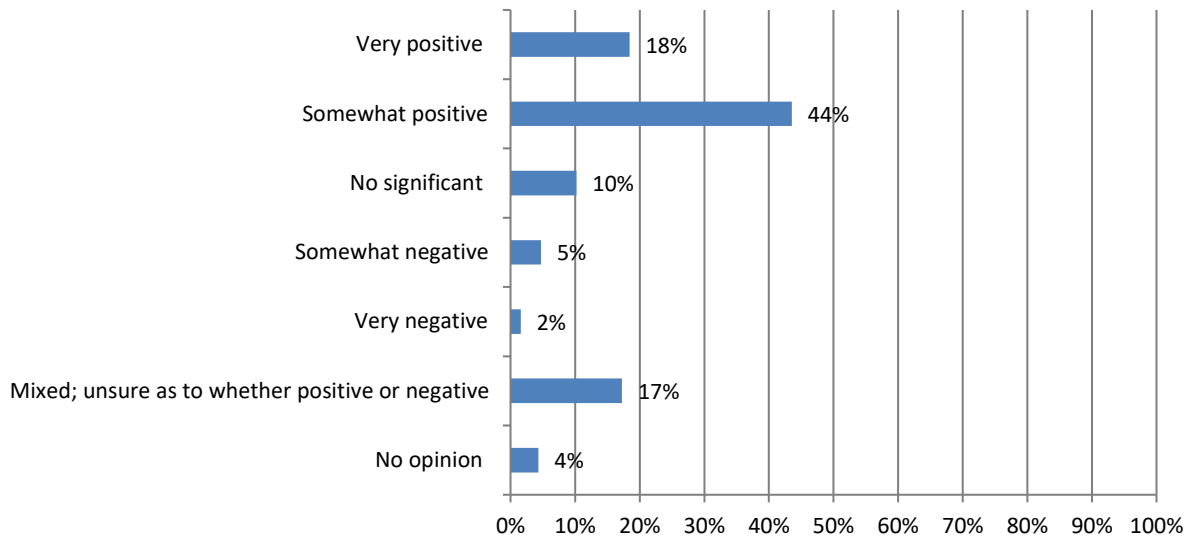

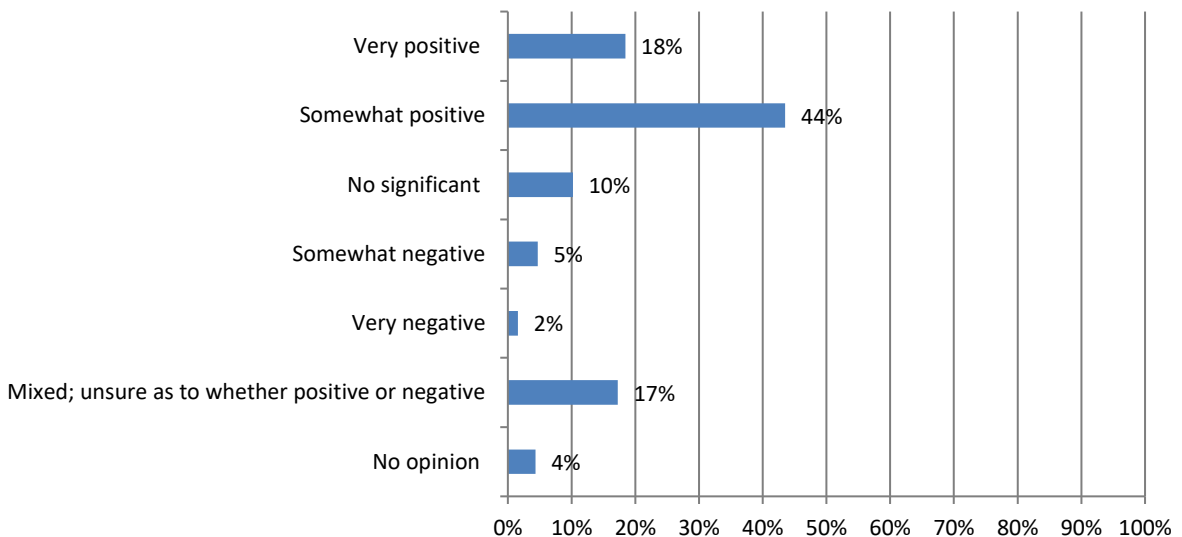


21. What impact do you expect AI and robotics to have on the construction industry over the next five years?

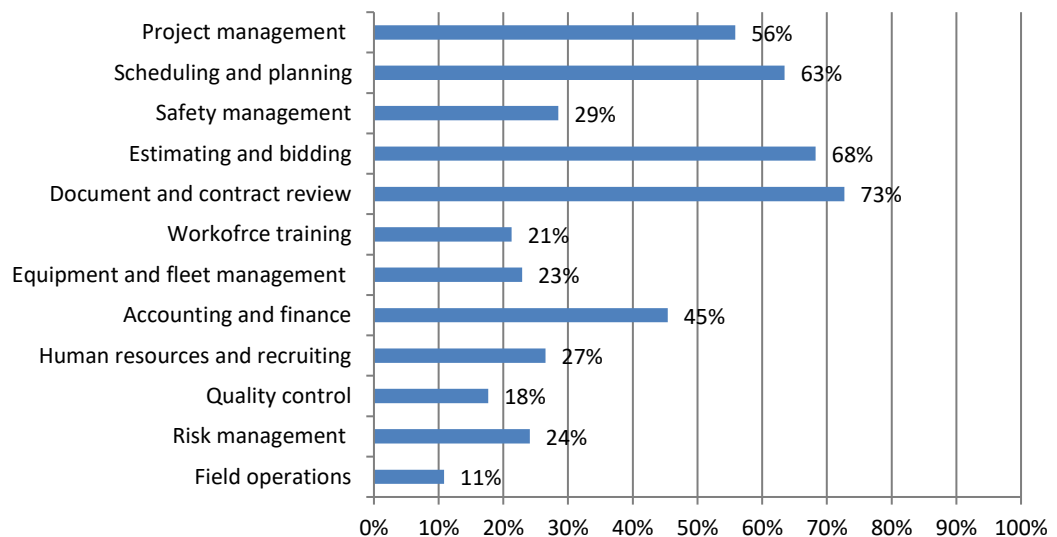

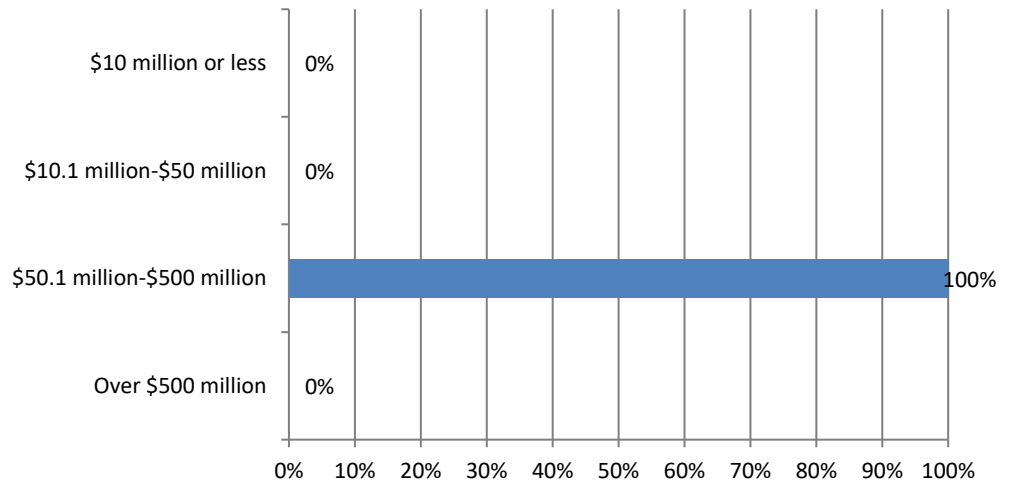

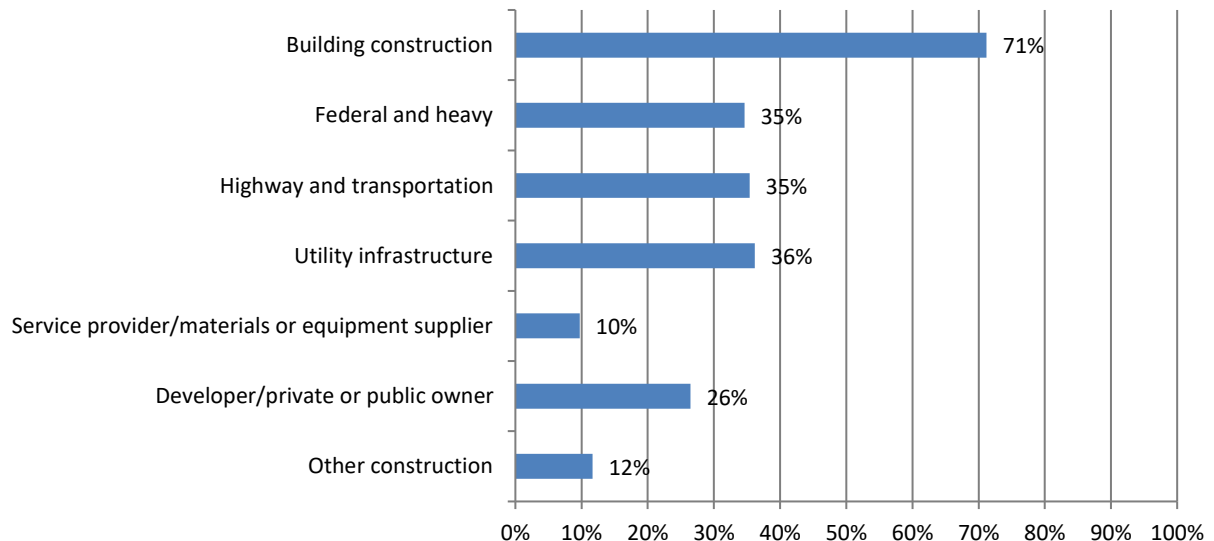
