

2024 Competition Rules and Disclaimers

- 1. The Construction Risk Partners Build America Competition is open to general contractors and specialty contractors working as prime contractors who are current members in good standing of at least one AGC chapter, though membership with the local AGC chapter in the area of the project is highly valued and may merit extra consideration during the judging process. All projects entered must have reached substantial completion between November 1, 2022 and November 1, 2023, AND/OR awarded a local award by the Chapter during that time frame. The final submission deadline for project entries is 11:59 p.m. ET, Wednesday, October 25, 2023.
- 2. Each entry requires an entry fee (minimum \$350.00 per entry). Each category is one entry. If any applications are submitted after October 25, 2023, there will be a late fee included and the new fee will be \$500 per entry.
- 3. ALL parties of a joint venture MUST be AGC member firms in good standing.
- 4. Any projects with a fatality will be disqualified.
- 5. Nominations must be submitted by principals or officers of firms, or with their written permission.
- 6. Different phases or elements of the same project may be entered independently, but not combined as another total project entry.
- 7. Entries must include color photos. Photos should highlight the construction process and the finished project, including special techniques or unique conditions. Photos that are uploaded should be in JPG/JPEG or PNG format, ideally in 300 dpi resolution (for production purposes). Each file, including photos, may not exceed 5 MB.
- 8. You may also submit PDFs, Microsoft Word documents, or Microsoft Excel documents with your entry. Only ten (10) uploaded files (including photos) are allowed per submission. Each file, regardless of type, may not exceed 5 MB. Do not submit multiple images within the same file.
- 9. All entries and accompanying materials will become the property of AGC of America upon submission. By submitting an entry, the entrant grants to AGC of America a broad, non-exclusive royalty-free license to copy, distribute, and otherwise use the entry and all accompanying materials (including materials in text, image, or other forms) in works both related and unrelated to the AGC Build America Awards. The entrant warrants that it has the right to grant such a license and that neither the entry nor the license infringes on the rights of any third party. Do not submit any materials to which you do not have the copyright and other proprietary rights.

- 10. Awards will only be considered for new construction and renovation work in the following categories:
 - 1) Building Construction (under \$20 million)
 - 2) Building Construction (\$20 million to \$75 million)
 - 3) Building Construction (\$76 million to \$125 million)
 - 4) Construction Management (Under \$99 million)
 - 5) Federal & Heavy Construction
 - 6) Highway & Transportation Construction (\$20 million or more)
 - 7) Highway & Transportation Construction (under \$20 million)
 - 8) Utility Infrastructure Construction

For the following categories, there is no distinction between new or renovated projects:

- 9) Building Construction (\$126 million or more)
- 10) Construction Management (\$100 million or more)
- 11) Construction Management Civil
- 12) Design-Build Building
- 13) Design-Build Civil
- 14) Environmental Enhancement
- 15) Specialty Contractors
- 16) International
- 17) Partnering Excellence (separate applications with different questions and criteria)
- 11. All applications must be completed using AGC's online application system. Entries will not be accepted by mail or fax.
