The AGC Foundation will achieve this by:



UNAUDITED **FINANCIALS**


The AGC Education and Research Foundation had another successful year in 2024. The Foundation raised roughly \$1,666,929 in total contributions in 2024. The Annual CCC Gala, held at the AGC of America Convention, was once again a success, raising a total of \$421,000 through sponsorships and donations. The Foundation's investments showed positive returns during the year and the Foundation ended the year with roughly \$1.8 million in net investment income. The Foundation awarded scholarships and awards of approximately \$705,000 and contributed \$40,000 to four Industry Residencies in 2024.


Total Revenue: \$3,464,329 **Total Expense:** \$1,230,253

THE AGC ERF IS:



BOWEN PRIZE FOR GREAT BUILDERS

In 2024, the AGC Education and Research Foundation announced the launch of the Bowen Prize for Great Builders. Established by Terry and Robert "Bob" Bowen, this new \$1 million endowed prize is dedicated to identifying, recognizing, and rewarding the construction industry's most influential builders. Candidates are those individuals who have demonstrated extraordinary leadership, fortitude, skill, and stewardship in an on-the-job capacity to ensure project goals were achieved in constructing America's most essential infrastructure — the leaders with boots on the ground, who, day in and day out, managed that critical construction project from planning through execution. Bob is an Emeritus AGC Education and Research Foundation board member and has created this prize to encourage and award those amazing project executives and AGC member companies for their finished projects.

OUTSTANDING EDUCATOR AWARD

The AGC Education & Research

experiences in consulting and public
service. He leads the Construction
Engineering Management emphasis
within Civil Engineering with a focus on
"connecting industry with students."

Dean is the faculty advisor for the UA student chapters of the Associated General Contractors (AGC) and the Design-Build Institute of America (DBIA) and helps lead UA Rise Together Mentorship for Women in Civil and Architectural Engineering at UA. Prior to becoming a professor, Dean was a civil engineering project manager for Pima County Department of Transportation in Tucson, Arizona. Dean's research interests include project delivery methods, including contributing to two AASHTO

guidebooks on Post-Award Contract Administration for Highway Projects Delivered Using Design-Build and Construction Manager/General Contractor. Dean is currently active in an NSF research grant exploring strategies to improve engineering education. As part of his award, Dean received a \$5,000 cash award and named two students as recipients of \$2,500 scholarships. In addition, Dean attended the annual AGC Convention as a guest of the Foundation.


INDUSTRY CASE STUDIES
