

# AGC Public/Private Industry Advisory Committee (PIAC)

# 2024-2026 COMMITTEE APPLICATION OVERVIEW AND CRITERIA FOR SERVICE

## **PIAC Committee Purpose**

The PIAC was established to provide a direct line of communication between private and public owners and the AGC of America. The primary mission of the PIAC is to promote dialogue with private and public owners involved in facility construction on issues including owner needs, market trends, industry best practices, and legislation. Through the PIAC, AGC's goal is to foster a construction industry that is more responsive to owners' needs.

# The PIAC's goals are to:

- Provide a forum to discuss the changing needs of owners.
- Review current trends such as Building Information Modeling (BIM), lean construction, craft worker and personnel availability.
- Review the latest in technology and methods for its implementation.
- Provide a forum to review current legislation, regulations, codes, and enforcement actions that may affect the industry and have long-term implications on owners.
- Provide a means to review current contracting practices and to encourage discussions on improving the construction process.
- Provide a means of sharing information on workforce development, safety, OSHA compliance and environmental issues.

#### **Committee Role**

- Lead the PIAC and ensure the PIAC mission is achieved:
- Provide oversight of all related objectives, initiatives, and activities;
- Via the Chair, provide updates, reports, and recommendations, on behalf of the PIAC, to AGC
   Building Division Leadership, AGC Board of Governors, and AGC Board of Directors;
- Engage Committee members and gather input and feedback.

#### **Committee Structure**

- Reside in and report through AGC's Building Division but serve all AGC divisions and members;
- Consist of members selected from AGC member firms across all AGC divisions':

- Meet 2 times per year, both meetings are currently virtual. The meetings are roundtable style and take place over two days. They are typically 2 hours per day;
- Led by a Chair and Vice-Chair, who are appointed by AGC Leadership;
- Supported by assigned AGC staff liaison(s).

# Committee Member Expectations and Responsibilities

- Share knowledge, ideas, best practices, and experiences;
- Attend two virtual meetings a year;
- Be a positive representative of AGC, the Committee, and the Forum;
- Maintain and exhibit high ethical standards, practices, and actions;
- Inform the Chair of any potential conflicts of interest;
- Maintain the confidentiality of the Committee's work and conversations until the Chair authorizes release.

### **Committee Membership**

- Members must possess proficient knowledge of the construction industry, deal directly with the client/owner in their day-to-day job and be willing to share their construction knowledge with fellow contractors and owners.
- Members participating in this committee must be willing to extend invitations to owners/clients to participate in virtual meetings.
- Members serve two-year terms coinciding with the AGC Annual Convention, from April 2024-April 2026
- Members must be employed by an active AGC member firm or chapter in good standing
- Members must be willing to devote time and effort to the well-being of the Committee, AGC, and the construction industry
- Members must possess a demonstrated capacity to exercise good judgment
- Committee makeup should be reflective of, as reasonable/feasible, AGC's diverse membership in terms of company size, geographical area, operating markets and competencies, etc.
- Committee makeup should be representative of, as reasonable/feasible, the different business
  development related positions and areas of expertise, including sales, marketing, proposal
  development, etc.

#### **Committee Process**

- Individuals who <u>complete the volunteer interest form</u> and indicate an interest in PIAC Committee will be asked to complete an online form to collect further information. Once the form is complete, a member of the PIAC Committee will contact you in late 2023 to further discuss your experience. Applicants will be notified of their status by the end of 2023.
- Complete the Volunteer Interest Form by October 1.
